- 2 MR. KAMINSKI: Chief Ashley, thanks for giving me a call
- 3 back.

- 4 MR. ASHLEY: Yes, sir. How you doing?
- 5 MR. KAMINSKI: Good. Do you have a couple minutes to talk?
- 6 MR. ASHLEY: Yeah, I do.
- 7 MR. KAMINSKI: Great. Okay. Do you mind if I record this so
- 8 I don't have to -- I don't write fast enough, so I don't have to
- 9 interrupt you when we're talking?
- 10 MR. ASHLEY: Yes, sir, that's fine.
- 11 MR. KAMINSKI: Great. Okay.
- 12 INTERVIEW OF MATTHEW ASHLEY
- BY MR. KAMINSKI:
- 14 Q. Chief, where do you -- spell your first and last name for me
- 15 real quick.
- 16 A. Matthew Ashley. M-a-t-t-h-e-w, Ashley, A-s-h-l-e-y.
- 17 Q. Okay. And you're the fire chief for the Friendship Fire
- 18 | Department?
- 19 A. Yes, sir.
- 20 Q. And that's a volunteer fire department?
- 21 A. That's correct.
- 22 Q. Okay. I quess, why don't you just give me a description of
- 23 when you got the call and when you got out there. I'm just trying
- 24 to get a feel of, you know, what all went on out there, any issues
- 25 you -- or anything you needed more help with, or -- and just kind

- 1 of give me a rundown of what all you had out there.
- 2 A. Okay. We received a call for a wreck on Honea Path Highway.
- 3 And when we arrived on scene, we found one SUV and one -- the van
- 4 | with the passengers in it. They had hit, you know, collided. I'm
- 5 | not real sure how the collision happened or anything like that.
- 6 But they -- one vehicle was on one side of the road, and the van
- 7 was on the opposite side. And we got our resources there and
- 8 began to treat patients and then get them treated or to the
- 9 hospital, and then stayed on scene for a while to, you know, get
- 10 everything cleaned up.
- 11 Q. How many units did Friendship send out there?
- 12 A. We had -- how many personnel or --
- 13 Q. Yes.
- 14 A. -- is that what you're talking about?
- 15 Q. Yes. Personnel and I guess you had -- if you had any
- 16 engines, or ambulances, or rescue units.
- 17 A. Yeah, we had a rescue truck and an engine. And then we
- 18 called for Belton to bring a couple of trucks to help with traffic
- 19 | control as well as help with manpower about assisting with the
- 20 patients. And then we also called for the emergency operations
- 21 | command post to -- because it was going to be a kind of a
- 22 drawn-out thing. So they brought some resources out as well.
- 23 Q. Okay. And who was that -- with the county?
- 24 A. Anderson County, yes.
- 25 Q. Anderson County EOC? Okay. And who else responded out

- 1 there? What other fire departments?
- 2 A. Well, we -- Friendship and Belton was the only two that was
- 3 called out.
- 4 Q. Okay. And how many units and personnel did Belton send out?
- $5 \mid A$. I'm not sure. I don't have the report right in front of me.
- 6 We can --
- 7 Q. Okay.
- 8 A. -- I -- well, you can get a copy of the report. I can get
- 9 | you in touch with -- let me -- you got something to write with?
- 10 Q. Yes, sir. Yeah.
- 11 A. Okay. It's (864) 260-4016, and that is our Anderson County
- 12 headquarters. And they can get you the info you need on the --
- 13 that's who -- we send all the reports in directly to them, and
- 14 then they kind of handle when people need things like that.
- 15 Q. Okay. Well, I've been working with Ms. Chitwood at the -- at
- 16 dispatch. Maybe she can help me out with that.
- 17 A. Okay, yeah. If you call like right now, I think the number's
- 18 transferred over to the dispatch line. But if you call like from
- 19 8:00 a.m. until 5:00 -- or 4:00 p.m. or something like that, it
- 20 | will be transferred to the headquarters station.
- 21 Q. Okay.
- 22 A. And they -- we got like a written report with the narrative
- 23 | in there. And it should have all that info on it. Because like I
- 24 say, I'm at work right now, so I ain't got the paperwork right in
- 25 front of me to know exactly the personnel numbers and all that.

- 1 Q. I understand. So why don't you just tell me then, so when
- 2 | you got there and you saw each vehicle's on each side of the road,
- 3 and you're requesting more help I guess, and -- just tell me, did
- 4 you have enough resources to get the people transported? Was
- 5 there a little bit of wait for that?
- 6 A. Well, see, we're not a transport agency. We rely on Anderson
- 7 County EMS to do the transportation as far as patients. The fire
- 8 side of it don't handle patient --
- 9 Q. Okay.
- 10 A. -- transportation. We just handle assisting with loading
- 11 patients, and helping them, and triage, and stuff like that, and
- 12 then the EMS handles transporting them to the hospital. But they
- 13 had, I think there was three different units from EMS that
- 14 transported the different patients or whatever.
- 15 Q. AnMed or something like that, something in Anderson?
- 16 A. Say what now?
- 17 Q. Something-Med. Yeah, there's -- in Anderson, right, that
- 18 came out.
- 19 A. Anderson, yeah, Anderson County EMS would probably be able to
- 20 | get you the questions on that, I guess.
- 21 Q. So by the time --
- 22 A. As far as -- I don't know like which patients went to which
- 23 | hospital. Some of them went to Anderson Hospital and some of them
- 24 | went to Greenville Hospital. So I don't -- we don't have no -- we
- 25 | don't know that, because that's not what we -- we don't do that.

- 1 Q. So that would be on some report?
- 2 A. We just get them to the ambulance and -- say what now?
- 3 Q. That would be on some -- like a brief field incident report
- 4 or --
- 5 A. Yeah, absolutely.
- 6 Q. Okay.
- 7 A. They -- that's -- there's a report out there with all that
- 8 | information on there. But I don't know what that would -- I
- 9 | can't --
- 10 Q. So your department didn't have to write anything up for that
- 11 | then?
- 12 A. Yeah, we wrote it up. I sent it in to headquarters.
- 13 Q. Oh, okay. So they have it then?
- 14 A. Right.
- 15 Q. I have to get it directly from them?
- 16 A. Yes.
- 17 Q. Okay. Okay.
- 18 A. Yeah, you can just contact them, and they'll get you the
- 19 necessary information or whatever.
- 20 Q. Now, in the time process, how -- approximately what time did
- 21 you get out there? Were you out there fairly soon, or was there
- 22 other people that maybe I should talk to that would give me a
- 23 better idea of initially what was going on out there?
- 24 A. Oh, I guess I arrived on scene probably about 45 minutes
- 25 after we got the call out, because I was still at work. And when

- 1 | I got off work, then I got there. But --
- 2 Q. So who would've been in -- who did you assume command from
- 3 when you got out there then?
- 4 A. Our captain that had the command first.
- 5 Q. And who is that?
- 6 A. His name is Rodney Madison, and that's in our report as well.
- 7 Q. Okay. Could I get -- do you have his number handy?
- 8 A. Yes. It's .
- 9 Q. Okay, let me write that -- a lot of fours in there.
- 10 .
- 11 A. That's correct.
- 12 Q. That's for Captain Rodney Madison. Okay.
- 13 A. Yes.
- 14 Q. Okay. So I imagine -- so -- okay. I guess I'll probably
- 15 talk to Captain Madison and follow up with other questions. And
- 16 I'll call up the -- call the county up. And maybe I'll send Ms.
- 17 Chitwood an email real quick here. But okay, chief.
- 18 A. Sounds good.
- 19 Q. Any follow-up, I may give you a call back, but I appreciate
- 20 your help and cooperation.
- 21 A. All right, thank you.
- 22 Q. Thank you, sir. Bye-bye.
- 23 A. Bye-bye.

INTERVIEW

- MR. KAMINSKI: Mr. Madison, thanks for calling me back. I

 got your name and contact information from Chief Ashley, saying

 that -- because I initially was told, he was the incident

 commander for that event back on the 17th. And he said, well, he

 got there about 45 minutes late, that you were probably more in

 tune to things than he was since he got there a little bit late.
- 8 MR. MADISON: Yeah.

- 9 MR. KAMINSKI: So if you don't mind, I just wanted to -- do
 10 you have a couple minutes to talk to me?
- 11 MR. MADISON: Yeah, sure.
- 12 INTERVIEW OF RODNEY MADISON
- 13 BY MR. KAMINSKI:
- 14 Q. Okay. I just want to get a description of when you initially
- 15 got the call, you got out there, what you saw, what you guys all
- 16 did, and you know, calling for support or any other issues you may
- 17 have had out there.
- 18 A. Yeah. But I was probably -- I was coming up the highway that
- 19 it actually happened on when the call come out. So I wasn't but
- 20 | just a couple of minutes away. And when I got there, one of my
- 21 other firemen was there too. He lives just right down the road.
- 22 O. Is that Cade? Which was the other fireman?
- 23 A. No, it wasn't Cade, no. No. Eric Kelley, he was there. He
- 24 lives right next to that road.
- 25 Q. Oh, he might be a --

- 1 A. He actually lives on that beach.
- 2 Q. -- good person to talk to then. I mean he was, he was pretty
- 3 quick on scene. So go ahead.
- 4 A. Yeah, he was there before I was. But anyway, yeah, when we
- 5 got there, I mean we had multiple patients. They had already got
- 6 them out of the bus when I got there -- had already gotten the
- 7 | patients out. So we had I think it was, let's see, seven on the
- 8 bus, I believe it was; is that right?
- 9 Q. Yeah. Seven passengers and a driver, yes.
- 10 A. Seven on the bus, and then the one in the car. And the lady
- 11 | in the car was the most critical patient we had. She was in
- 12 really bad shape. So the first ambulance that come, we sent her
- on her way. We were going to fly her, but the helicopter wouldn't
- 14 | fly that day. So --
- 15 Q. Yeah, I did notice it got cancelled. Was it a weather deal?
- 16 A. Yeah, it was a weather deal, yeah. They couldn't fly because
- 17 of the weather. And so -- but she was in bad shape anyway. I
- 18 don't --
- 19 Q. Yeah.
- 20 A. -- I believe if he flew her it wouldn't have mattered
- 21 either -- one way or the other. She had a lot of trauma --
- 22 Q. Did she even make it -- I don't think she even made it to the
- 23 hospital, did she?
- 24 A. No, I think she coded on the way to the hospital. Yeah. She
- 25 had lost a lot of blood on scene. She had --

- 1 Q. Almost lost a leg.
- 2 A. -- she -- one of her legs almost -- yeah, one of her legs was
- 3 almost amputated.
- 4 Q. Yeah. Yeah, I heard that.
- 5 A. Yeah, it was pretty bad. And then the other patients on the
- 6 | bus, we had -- the three in the wheelchairs was the worst patients
- 7 on the bus. They -- but they mainly had, you know, minor bumps
- 8 and scrapes. But the ones that were strapped in, they were fine.
- 9 They said they didn't -- they wasn't hurting or no injuries
- 10 whatsoever, except for the one guy that died.
- 11 Q. Right. Well, I think there was another woman --
- 12 A. And he was strapped in.
- 13 Q. -- that was seated behind him, and they had a fractured wrist
- 14 or something that ended up -- it was --
- 15 A. Yeah, yeah. The ones in the wheelchairs was the ones that --
- 16 I only want to add visible injuries to us --
- 17 Q. Okay.
- 18 A. -- with the ones that were in the wheelchairs. I don't
- 19 believe the wheelchairs were secured in there or whatever. It
- 20 must have threw them around or whatever. But they had some minor
- 21 head injuries and you know, scrapes, and bruises, and stuff like
- 22 that.
- 23 Q. Right. So by the time you got there, everybody was out. So
- 24 when you guys just started -- you and I guess Eric Kelley, got --
- 25 you started triaging or --

- 1 A. We started assessing the patients, yeah, and prioritizing
- 2 them as which ones needed to go next.
- 3 Q. Right.
- 4 A. And I had ambulances coming from all over. I mean I had six
- 5 ambulances coming, so we had --
- 6 Q. And where did you --
- 7 A. -- plenty of them coming.
- 8 Q. Where did you request all the ambulances from? Do you
- 9 recall?
- 10 A. We had two coming from Honea Path, we had two coming from
- 11 Belton, and we had Medshore sending two. So we had six coming.
- 12 Q. Okay.
- 13 A. And as they pulled up, the ones that we thought needed to go
- 14 first is the one that we loaded first and sent them on their way.
- 15 And in the last ambulance, they carried the body of that one guy,
- 16 the one that was deceased.
- 17 Q. Right. So but all six transport --
- 18 A. But we had enough transport units to carry everybody,
- 19 Q. Okay. Did all six units transport someone then?
- 20 A. Yeah.
- 21 Q. Do you know?
- 22 A. All six, yeah.
- 23 Q. Okay.
- 24 A. Yeah. One patient on the bus didn't go by ambulance because
- 25 he didn't want to go by ambulance. He had no visible injuries.

- 1 But his dad was there, and his dad took him to the hospital.
- 2 Q. Okay.
- 3 A. I said, I'll let you go, but you got to make sure you take
- 4 him to the emergency room and get checked, you know, because it
- 5 was such a horrific crash. I mean that's what I told him; I said,
- 6 dude, you don't know if you got any injuries or not.
- 7 Q. Sure, right.
- 8 A. I mean you could have internal injuries and not know it.
- 9 Q. By any chance, do you know that person's name, by chance?
- 10 A. Who's that?
- 11 Q. Do you know that person's name by chance, which one that was?
- 12 A. Where at?
- 13 | O. Burdette -- no --
- 14 A. No. Well, Burdette -- are you talking about Eric Kelley? Is
- 15 | that who you're talking about?
- 16 Q. No, no, the patient that was --
- 17 A. The fireman that was there before I was?
- 18 Q. No, no, the patient that refused -- that was going to go with
- 19 | his father to the hospital. Did you get it by any chance?
- 20 A. I don't remember what his name was, no. I could look on the
- 21 report and see. But I don't remember what his name was.
- 22 Q. Okay.
- 23 A. There were two of them that said they were fine, but we made
- 24 them go anyway.
- 25 Q. Okay. Yeah, I know a couple --

- 1 A. They were the two that were strapped in.
- 2 Q. Right. I think everybody was strapped in --
- 3 A. Yeah, I don't --
- 4 Q. -- except for those two (indiscernible).
- $5 \mid A$. -- know about the wheelchairs, because see, they had the
- 6 patients in the wheelchairs sitting outside of the bus in the
- 7 | wheelchairs when I got there.
- 8 Q. Right. Yeah, that's what I heard.
- 9 A. So bystanders had done and got everybody out of the bus by
- 10 the time we got there.
- 11 Q. Okay. Any issues with having to wait around for the
- 12 ambulances, or pretty timely getting out there?
- 13 A. No, they was pretty quick about -- especially Belton and
- 14 Honea Path. I mean we were right there at Belton and Honea Path,
- 15 so we -- so they were there pretty quick, yeah.
- 16 Q. Okay.
- 17 A. Medshore took a little while, but they're coming from
- 18 Anderson, so that's a 20 mile ride from there.
- 19 Q. Yes, yes. Yeah, I drove that ride a couple times when I was
- 20 there those couple days right before Christmas.
- 21 A. Yeah, it's like a 20 mile ride. And that's basically it,
- 22 yeah.
- 23 Q. Okay. Did you -- was the -- when you got there, was the
- 24 driver of the SUV, the female, was she already in the ambulance
- 25 | then or --

- 1 A. No, she was laying under the -- her head was up under the
- 2 front of the vehicle.
- 3 Q. Okay.
- 4 A. She was laying in front of the vehicle, but her head was up
- 5 under the vehicle, and her body was sticking out of the front of
- 6 the vehicle.
- 7 Q. But she wasn't stuck under there but her head was just under
- 8 there, correct? Is that what I heard?
- 9 A. No, she wasn't stuck, she was just under -- that's where she
- 10 ended up at.
- 11 Q. Right, right. Okay, got it.
- 12 A. Yeah.
- 13 Q. Okay.
- 14 A. And she was still conscious and talking at that time.
- 15 Q. Okay. And would you mind, either you can give me Mr.
- 16 Kelley's contact number or you give him my information and have
- 17 him give me a call?
- 18 A. Yeah, yeah. I'll tell you what, I'll send it to you. I'll
- 19 | send you his number.
- 20 Q. Okay. Yeah, this is my cell number.
- 21 A. All right.
- 22 Q. And what did you say, he beat you by what, 5, 10 minutes at
- 23 most?
- 24 A. Yeah -- no, not that much, no. It didn't take me but a
- 25 | couple minutes to get there. And he lived right there at where

- 1 | the wreck happened, so he was on scene pretty quick. Now, I don't
- 2 know -- I think bystanders is the one that got him out of the bus,
- 3 the guy that was behind the car.
- 4 Q. Yeah, I'm trying to track down -- I guess there was a couple
- 5 of guys from the Belton Metal Company that were there I'm trying
- 6 to track down.
- 7 A. Yeah. Yeah, that was them, yeah.
- 8 Q. Okay.
- 9 A. Yeah, I think they helped get everybody out and back in the
- 10 wheelchairs and everything, yeah.
- 11 Q. Okay. Well, maybe I'll wait and talk with them, and then if
- 12 I need more information, I'll -- after you send me that
- 13 information for Mr. Kelley, I'll tell him I may not give him a
- 14 call if I get enough information from these other guys.
- 15 A. Okay. All right, sounds good.
- 16 Q. Okay, sir. I appreciate your help, captain.
- 17 A. All right, buddy. Have a good one.
- 18 Q. Thank you, sir. You too.

- 2 MR. FRITH: -- and he's beside me.
- 3 MR. KAMINSKI: Okay.
- 4 INTERVIEW OF CADE FRITH
- 5 BY MR. KAMINSKI:
- 6 Q. Okay. So Mr. Frith, your first name is Cade, C-a-d-e?
- 7 A. That's correct.
- 8 Q. Last name Frith, F-r-i-t-h?
- 9 A. Yes, sir.
- 10 Q. Okay. And you are -- who do you work -- what department do
- 11 | you work with?
- 12 A. I work with South Greenville Fire Department and I work with
- 13 Honea Path Fire Department.
- 14 Q. Honea Path, and what was the first one?
- 15 A. South Greenville.
- 16 Q. South Greenville. Oh, okay.
- 17 A. Yes, sir.
- 18 Q. And so I quess, who -- I quess start with -- first of all, if
- 19 you don't mind, I'm going to tape this, so I can -- because I
- 20 | can't write fast enough and I let you talk --
- 21 A. Yes, sir.
- 22 Q. Okay. Great. And then who was the, I guess the incident
- 23 commander or what department was kind of in charge out there at
- 24 the crash scene?
- 25 A. It was actually Friendship Fire Department's call. They was

- 1 | the responding fire department, first due.
- 2 Q. Okay. And who is -- do you have a contact or name of
- 3 somebody I should try to contact there for who was the incident
- 4 commander?
- 5 A. I don't know who the incident commander for them would've
- 6 | been, not 100 percent sure.
- 7 Q. Or was there somebody else you know that was in charge from a
- 8 different department?
- 9 A. Greg Elgin, he was there. He just done like myself; he just
- 10 kind of rode up on it kind of like me. We just kind of got out to
- 11 help assist because it was such a large scene and --
- 12 Q. Right.
- 13 A. -- a lot of patients. So we wasn't really, quote/unquote,
- 14 "dispatched," but we all kind of work well together. So, you
- 15 know, we passing by, you know, we just decided to get out and get
- 16 help because nobody was on scene I think when we first arrived.
- 17 Q. Okay. Greg Elgin, who does he work with?
- 18 A. He works for the South Carolina Highway Patrol and a --
- 19 O. Oh.
- 20 A. -- volunteer -- volunteers with Rock Springs Fire Department.
- 21 He's actually -- I think he's actually the chief over there.
- 22 Q. Rock Springs?
- 23 A. Yes, sir.
- 24 Q. And most of these fire departments, they're volunteer?
- 25 A. In Anderson County, yes, sir. You have a few municipalities

- 1 | like Honea Path, Belton, Williamston -- and Anderson City it's all
- 2 paid -- inside of Anderson County, but most of your outlying
- 3 county stations are all volunteer.
- 4 Q. Right, right. So what -- do you know what all departments
- 5 | responded; do you have an idea, other than Friendship?
- 6 A. Friendship, Belton City Fire Department came. But as far as
- 7 | fire departments --
- 8 Q. Yeah.
- 9 A. -- that was the only two that were dispatched on the fire
- 10 side.
- 11 Q. Okay. Okay. And so why don't you give me a description
- 12 of -- if you could, of you came -- you said you came up to the
- 13 scene --
- 14 A. Yes, sir.
- 15 Q. -- and what you saw and what you all did?
- 16 A. When I first drove up on the call, they was -- I was coming
- 17 from Belton going towards Honea Path, and the bus was on the left
- 18 | side of the road off the roadway and kind of looked like it was
- 19 kind of -- it was leaning to the left side. The car was probably,
- 20 | I'd probably say 50, 60 yards down on the right-hand side of the
- 21 road off the roadway just before the railroad tracks there. And
- 22 | there was debris everywhere. Yeah, it was pure chaos, I mean,
- 23 when I first got there.
- 24 Q. Okay. And then I guess when you got there, what did you all
- 25 do?

A. When I first got there, I met with the bus driver. She was standing in the middle of the roadway. And we're trying to account for how many number of patients we had. And I stopped at her because she was kind of hyperventilating a little bit. And I said, talk to me, tell me what's going on, what happened.

And she said -- all she could tell me at that point in time is she never saw the car, that she never saw the car. And I said, okay. I said, calm down, real deep in through your nose out through your mouth. And I started checking off -- I was like, you need to try to figure out how many people you had on this bus, and I need to know. I said because we're going to have a lot of things going on here, and it's going to take a little while, it's not going to happen quick, but I need to know how many patients I got.

And then I heard somebody hollering out from the car. And they said this woman's up under the car. So I went down there to try to look at her. She was still alive at that point in time. She was still sort of kind of talking. She wasn't really making a whole lot of sense. I think she was just kind of concerned that -- you know, she wanted somebody to help her.

And after that happened, I kind of got in a mode. There was a few more guys that showed up. And we started kind of assessing what we had. We tried to see if we had -- we was going to have to lift the car up off of that woman or not. Luckily, we did not; we was able to move her. She wasn't hung up under the car. I just

- 1 | think she got ejected basically, and where the car and her rested
- 2 it was just kind of how she was.
- 3 Q. Right. Because that whole side of the car was torn away --
- 4 A. Right.
- 5 Q. -- or the SUV; right.
- 6 A. Yes. It was all torn away. So we got her loaded up first
- 7 | when the first arriving ambulance come in, and --
- 8 Q. Now who was the first ambulance that arrived?
- 9 A. The first arriving ambulance was Honea Path EMS.
- 10 Q. Okay.
- 11 A. So we got her loaded up and started getting her care that she
- 12 | needed. Then we started kind of, I guess you'd say more or less
- 13 trying to triage the rest of them and see what was most critical
- 14 or life-threatening. And, you know, I realized that should've
- 15 | been -- you know, after the fact, I realized that should've been
- 16 numero uno, number one, we should've started doing that from the
- 17 point. But things were so crazy when we first got there, it was
- 18 | just, you know -- it was kind of rough.
- 19 Q. Right. I understand. And -- okay, so then Honea Path. Who
- 20 does all the dispatching for that area there? Because I usually
- 21 | get their dispatch logs. Is there a county --
- 22 A. Yes. So there's like county dispatch that's run through the
- 23 | Sheriff's Office. So it would be Anderson County Dispatch or
- 24 Anderson County Communications. I think they're out there beside
- 25 | the -- right there at the airport out there, right off of Highway

- 1 24 in Anderson.
- 2 Q. Okay. I'll get a hold of them. And so is there anyone else
- 3 you feel that would be beneficial I talk to that would give
- 4 detailed information like yourself? I mean, I think your father-
- 5 | in-law gave me Landon Epps and Eric Kelly. But is there anyone
- 6 else that you feel that would be a good person for me to talk to?
- 7 A. Greg Elgin, the guy that I gave you, he would probably be one
- 8 of -- like I say, I believe he was -- he was right there behind
- 9 me. So he was -- me and him were there right about the same time.
- 10 Eric was there about the same time that I was.
- I can't -- like I say, we had so many personnel. There was
- 12 | so much going on. That's the only two names that are sticking out
- 13 | in my head right now that I know that were there around the same
- 14 time that I arrived.
- 15 Q. Okay. Do you happen to have a number for Greg Elgin?
- 16 A. I do not; I do not have a number for him. Golly, I don't
- 17 know anybody that would, honestly.
- 18 Q. Maybe call Rock Springs Fire Department, they may --
- 19 A. Well, yeah, if -- maybe if you could catch somebody over
- 20 there, or if you know anybody with the Highway Patrol that maybe
- 21 get it to you.
- 22 Q. Yeah, we're dealing with one of the first sergeants. So
- 23 yeah, I'll reach out to him then.
- 24 A. Yeah, because I think -- if I'm not mistaken, I think Greg's
- 25 pretty high up in the ranks with the Highway Patrol, too, so --

- 1 Q. Oh, okay.
- 2 A. I know he's still on the road, but I mean I think he's up
- 3 there as far as ranks too, so -- but yeah, he could probably
- 4 account for some of those detailed incidents you're looking for as
- 5 well.
- 6 Q. Okay. And then were there any issues out there you feel was
- 7 | there -- you had enough EMS and the transports to get the people
- 8 | out in a timely manner?
- 9 A. Well, I think it's a yes and a no. I think we had done a
- 10 great job of getting people out of there when we had the units
- 11 | that got on scene. But nobody really knew when that thing was
- 12 initially dispatched of how many people were injured and how many
- 13 people needed to be carried out of there.
- 14 So when you deal with something like that, you have to
- 15 realize that hey, some of your neighboring departments or rescue
- 16 squads or EMS, or whatever you want to call them, may be out on
- 17 different calls at the time, which is what we run into I think
- 18 | with Belton EMS at the time. I think both of their trucks were
- 19 out on call. So that kind of put us behind the 8-ball in the
- 20 | initial. But Medshore provided an ambulance within probably the
- 21 first, probably within the first 10 minutes of me being on scene
- 22 | as well. So --
- 23 Q. And it's Medshore?
- 24 A. Yes, sir, out of Anderson County.
- 25 Q. Okay.

- 1 A. So we never was, I guess you'd say, in a lack. You know,
- 2 | because we sent one, we had one on scene, we'd send another one,
- 3 there was another one on scene before that one -- you know, all of
- 4 them was getting out there, but as they were getting out there,
- 5 there was still one on scene before one left.
- 6 Q. Okay.
- 7 A. So nobody was left without medical care.
- 8 Q. Right. And you guys were there doing the triage?
- 9 A. Yeah, we were trying to do the triage and doing basic first
- 10 responder skills. And lucky enough that they -- I think Belton
- 11 Fire Department, I think, have a few EMTs on their roster as well.
- 12 So they were able to jump in there and kind of help out in the
- 13 back of the ambulance, too, when it was needed. So that was a
- 14 great thing.
- 15 Q. Sure. Okay. Well, if you -- I appreciate your help. If you
- 16 talk to Mr. Epps or Kelly, if you can give then a heads-up that
- 17 | I'll probably give them a call and just kind of get the same
- 18 information as I'm asking you.
- 19 A. Yes, sir.
- 20 Q. And I appreciate the information you gave me, as well as who
- 21 to contact to get the CADs and all that kind of stuff. So --
- 22 A. Yes, sir.
- 23 Q. And I thank you for what you did out there. I know -- it
- 24 sounded like -- we talked to the driver of the bus yesterday, and
- 25 | it sounded just a horrible scene out there. So --

- 1 A. It's --
- 2 Q. -- I hope you guys are doing well and getting the -- if you
- 3 | need any kind of emotional support or anything like that, I'm sure
- 4 there's -- you know, I can put you in contact with somebody if you
- 5 need to talk to someone.
- 6 A. Yes, sir. I appreciate it. Is she doing okay? Because I
- 7 know she was pretty shook up while we were out there. And I'm --
- 8 Q. Yeah, she's -- I mean, she was doing well enough to talk to
- 9 us yesterday.

- 11 Q. Yeah. It's going to be a long -- it's going to be a process
- 12 for her to get through this, no doubt.

- 18 buses are not required to have lap and shoulder belts. And in
- 19 | this case, I really think the lap and shoulder belt would've
- 20 helped some of these people.
- 21 A. Oh, yeah, absolutely.
- 22 \mathbb{Q} . And like you said, there's no structure to that bus body.
- 23 A. Yeah. I mean, we got to looking at that thing after
- 24 everything had kind of calmed down, and it's just plywood and
- 25 | fiberglass. And I'm like --

- 1 Q. Exactly.
- 2 A. -- you know, what the crap? And I mean, you know, you're
- 3 sending loved ones off in this thing. I mean, and they can't --
- 4 | if they can't take -- I mean, it was a pretty hard lick anyway,
- 5 but I mean you --
- 6 Q. Yeah.
- 7 A. -- if you look at that impact, and I mean the side of that
- 8 | bus that was ripped out like that, and then you're like, well,
- 9 that kind of -- and if I would've never done an extrication class
- 10 on a regular school bus, I probably would never know the
- 11 structural integrity of those things, but I mean --
- 12 Q. Yeah. Now school buses are a whole other story.
- 13 A. Right.
- 14 Q. Yeah.
- 15 A. Right. Yeah, absolutely.
- 16 Q. As you know, yes.
- 17 A. Yeah. Because I mean, I've done some classes on them things,
- 18 and it's -- you take everything you know about cutting a car up
- 19 and you throw that out the window when it comes to a bus because
- 20 | it is totally different.
- 21 Q. A school bus, yes. Right.
- 22 A. Yeah, a school bus. But I'm --
- 23 Q. Where these things you can probably use ten strips to get
- 24 through it.
- 25 A. I was about to say, yeah, we used a regular dad-gum household

- 1 can opener to get these things. I mean, you know, it's just --
- 2 but yeah, that was one thing that really concerned me after
- 3 everything kind of calmed down and we looked at that thing. I was
- 4 | just like, man, there is -- no wonder. I mean, I hate the guy
- 5 | lost his life, but I mean, you know, I was just like no wonder
- 6 now, you know?
- 7 Q. Right. Oh, that's why we're looking in these, because we
- 8 | realize there's a problem, and we're trying to get the NHTSA to
- 9 makes some more regulations, as they've done for the motor
- 10 coaches, the full-size motor coaches.
- 11 A. Yes, sir.
- 12 Q. They have, as of 2016, November 2016, all their new motor
- 13 coaches have to have lap and shoulder belts. And we're also
- 14 working on trying to get their roof structure a little bit
- 15 strengthened.
- 16 A. Right.
- 17 Q. But anyway, I can go on for hours here. But --
- 18 A. Yeah.
- 19 Q. -- I appreciate your help in taking time to talk with me,
- 20 Mr. Frith. And I just want to thank you for doing what you could
- 21 out there on scene.
- 22 A. Yes, sir. I sure appreciate it.
- 23 Q. Okay, sir. Take care.
- 24 A. Yes, sir. Have a good --
- 25 Q. Have a Merry Christmas.

- A. And we come in that way. And when we got there, the
 firefighters were motioning for us to come over to where the SUV
 is at. And I had talked to the Belton fire chief when I got out
 of the vehicle, and he said that there was a fatality in the van,
 that I doubt that this lady was alive.
 - She was kind of -- she wasn't pinned in or anything like that. She was kind of in front of the car, under the car, maybe from her breast up. And she was moving; she was alive. There was

firefighters there.

I remember there was a lady, she was probably about 5'4", somewhere along in there. She had on a green sweater, and she kind of had sandy blond hair. She's probably maybe in her mid 50s, late 50s. And she had told me that -- she said her name was Sherry. I said, okay.

So we pulled the lady out from under the car, put her on a backboard. And the gentleman, the firefighter that was helping me -- I mean I was telling everybody, just calm down, take it slow, don't be in a hurry, and stuff like that because of the lady's injury.

Well, her leg, left leg, was very mangled from her hip probably all the way down to her ankle. And we're talking about it looked like it was in a meat grinder. I mean it was awful. And her arm, left arm was split wide open maybe from her shoulder probably midway almost to her wrist. I mean a lot of injuries. Her face was fine. I mean she had a little bit of fluids coming out of her mouth. It looked like, best way I can describe it, kind of like a Coke color.

20 O. Yes. Um-hmm.

A. Well, she had her eyes open and she was talking. She told me that she couldn't breathe. I mean it was in a low voice; it wasn't like me and you are talking. So I told her, I said, I'm trying to get you in my car -- I mean not in my car, but in my ambulance -- and everything. And I said, and we'll take care of

- you, we'll get everything situated.
- 2 We put her on some oxygen and on a breather, and I was trying
- 3 to get an IV on her. We were putting her on the monitor and stuff
- 4 like that.

- 5 And y'all hush -- excuse me, my dogs --
- 6 Q. That's okay. I work out of the house too, so if my dog
- 7 starts barking, you'll know.
- 8 A. So anyway, when we got her in the back of the truck and

- 11 Q. Okay.
- 12 A. 1 milligram. And that's what we give when the patient goes
- 13 into a systole or PEA, which is post electrical activity.
- 14 Q. Yes. Yeah.
- 15 A. So -- and we never did get a rhythm back on her.
- 16 Q. Okay. So let me just go over this real quick with everything
- 17 | you've told me here. You're posted at 252 and 413. Is that --
- 18 A. Yes, sir.
- 19 Q. Okay. About 10 minutes away. You got there. You arrived.
- 20 You came in off of Beeks Road. The firefighters were motioning
- 21 you to come over. There was a fatality in the bus, but they went
- 22 to the SUV driver, who was partially under the front of the car.
- 23 She's still breathing.
- 24 A. Yes.
- 25 Q. You guys pulled her out from underneath. Her left leg was

- 1 severely severed. Her right -- her left arm was split open. Her
- 2 eyes were open, and she complained she couldn't breathe. You got
- 3 her in the back of the ambulance, put her on oxygen. There's
- 4 still no other ambulances on scene yet. You called to ask for
- 5 | another medic. You needed to intubate her, which you did. You
- 6 drilled an IO into her leg. She went -- and you were driving to
- 7 | the hospital -- and you went to what hospital? Were you going
- 8 to --
- 9 A. AnMed. It was Anderson ER, an AnMed on 800 North Fant
- 10 Street. It was closest facility at that time.
- 11 Q. And it's Anderson Medical Center?
- 12 A. Yes, sir.
- 13 Q. Okay. We've got a -- yeah, okay. And then she went into
- 14 arrest, a systole --
- 15 A. A systole.
- 16 Q. A systole, okay.
- 17 A. Yes.
- 18 Q. You gave her an epi 1 to 10,000, started with CPR. You got
- 19 to the ER, and the doctor said she was gone. So --
- 20 A. Yeah, we did the CPR before we gave any kind of drugs and
- 21 stuff like that. And we gave four or five rounds of epi 1 to
- 22 10,000, I think.
- 23 Q. Okay.
- 24 A. And I mean that's per our protocol and the -- it's kind of
- 25 | hard, because I mean you know, holding somebody's hand and

- 1 everything like that and then making eye contact, and then --
- 2 Q. Sure.
- 3 A. -- her -- so it's kind of hard to talk about.
- 4 Q. Oh, I understand. People think I have a hard job. No. It's
- 5 you guys that are dealing with the real thing at the time, they
- 6 have the hard job, you and firemen, and the -- I mean me going out
- 7 | the next day and talking, and it's a totally different situation.
- 8 I understand that. It's --
- 9 A. So what did they say ever happened or --
- 10 Q. No, we're still --
- 11 A. -- I asked.
- 12 Q. Yeah, we're still trying to put it together. It was the --
- 13 the woman in the SUV was driving. And we have a witness that she
- 14 was kind of being a little erratic, so we're not sure what was
- 15 | going on there. We'll be getting all of her drug tests, autopsy,
- 16 and their tox tests, all that kind of stuff, so --
- 17 A. Yeah.
- 18 Q. Yeah, because the bus driver, the poor girl, was just driving
- 19 she said, then all of the sudden, this car just came right in her.
- 20 | She had no time to react or anything.
- 21 A. No, and the thing is the vehicle -- I don't know how she got
- 22 | in front of the vehicle and stuff like that, I don't. But I did
- 23 hear somebody state that when they hit, that she had went up in
- 24 the air probably about 20 feet, and when she came down, the car
- 25 somehow had drug her down the road. So I don't know. I do know

- 1 on the driver's side and everything, it looked like from the
- 2 | windshield post, looked like it was just peeled back --
- 3 Q. Yeah, exactly, yes.
- 4 A. -- that the seatbelt was broke and stuff --
- 5 Q. The airbags the side airbags, everything was completely --
- 6 | it's very unusual to see that kind of damage like that where the,
- 7 | all that whole side structure is totally pulled away like that.
- 8 A. Yeah, I mean and it's -- like I said, they said she was going
- 9 to pick her kids up and stuff. And that's -- the direction of the
- 10 vehicle looked like it was going back to Belton. I mean it was
- 11 just, it was a bad accident.
- 12 Q. Yeah, sure.
- 13 A. I mean I've seen a lot, don't get me wrong. But like I said,
- 14 when you make eye contact -- and the lady, she was alive I mean,
- 15 but due to her injuries and stuff like that -- and that's why I
- 16 was calling for another medic, because I knew that due to her
- 17 | injuries -- I mean she had internal injuries. And just her leg, I
- 18 mean it was from like her hip down. I mean it was just tore all
- 19 to pieces.
- 20 Q. Yeah, yeah.
- 21 A. And I -- it was just -- she bled out basically, I feel like.
- 22 | I mean I can't say, but how she got in front of the vehicle, I
- 23 don't know. But that's probably where the vehicle drug her down,
- 24 because she had a lot of road rash on that leq.
- 25 Q. Oh, okay. Well, yeah, once that whole side got torn out or

- 1 | torn away, and even if -- the belt would've come right off of her,
- 2 | because that was -- if she was wearing it, that would've been torn
- 3 away. So anything happens when it's -- you're flying around like
- 4 that, that she may have been thrown that far and then -- or the
- 5 car dragged --
- 6 A. Yeah.
- 7 Q. Yeah, I don't know if we'll ever figure that out, but --
- 8 A. Yeah. I mean this is just from people I guess seeing it or
- 9 was on scene. I mean you hear from different people what
- 10 happened, da-da-da --
- 11 Q. A lot of speculation too, you know.
- 12 A. Yeah.
- 13 Q. But -- okay. Well, I really thank you for your help. Is
- 14 | there anybody else out on scene you think I should -- that would
- 15 | be worth -- you think would be helpful for me to talk to out
- 16 there, that was -- seemed to be doing a lot?
- 17 A. Well, I mean my partner and everything, he was right there
- 18 with me and stuff. He's an EMT basic. And --
- 19 Q. How about any --
- 20 A. -- he might --
- 21 Q. Did you get to treat -- or did he get to see any of the other
- 22 patients, any other passengers?
- 23 A. Not that I -- not to my knowledge. I'm not 100 percent sure.
- 24 | I mean it was like everybody -- when we came in off of Beeks Road,
- 25 we was right there at the SUV. And that's when everybody was

- 1 motioning for us to come around, to come over here, da-da-da.
- 2 And of course, when I got out of the vehicle, I was going to
- 3 go and assist, see what's going on with the other folks and stuff
- 4 | like that. And that's when the Belton fire chief told me that,
- 5 hey, we got a fatality there and stuff, I mean walking wounded,
- 6 and this lady here, she's alive. And so --
- 7 Q. So did it look like that was -- I was under the impression
- 8 that Friendship was kind of in charge. It sounds like more the
- 9 Belton fire chief might have been a little bit more in charge than
- 10 the Friendship.
- 11 A. Well, that's who I made first contact with. They came up to
- me and stuff and was pulling me away. I mean it was kind of like,
- 13 okay. But he said he was from Belton, a Belton fire chief.
- 14 Q. Okay. Yeah, I'll give -- I might give them a call. But
- 15 | what's your call number? So when I'm looking in the logs, what's
- 16 your rig number that I would recognize that it's you when I'm
- 17 looking at the dispatch.
- 18 A. Oh, I'm 308.
- 19 0. 308?
- 20 A. Um-hmm.
- 21 Q. Okay. And what other ones -- do you know of any other call
- 22 | numbers that came in, or any other rig --
- 23 A. Not that I know of.
- 24 Q. Okay. But you're 308 --
- 25 A. I mean -- yes, that is my Med-IT number. Yes, 308.

- 1 Q. Okay.
- 2 A. And we were on Ambulance LS Truck 32.
- 3 Q. LS 32?
- 4 A. Yes, sir.
- 5 Q. Okay. Okay. I'm just trying to get an idea of what kind of
- 6 | numbers I'm looking at when I'm looking at the catalogs and all
- 7 | that, that they're sending me. Sometimes it's like a puzzle
- 8 trying to figure all that stuff out.
- 9 A. Oh, I know. Bless your heart. I mean I understand. Thank
- 10 you for doing -- because like I said, I mean I don't know what
- 11 happened. I mean you hear so many things. They said, she
- 12 could've had -- she probably had a seizure, or this, or that. So
- 13 I mean you never know.
- 14 Q. Right.
- 15 A. And of course, to me, I mean I don't really care about that.
- 16 I just care about taking care of my patient and see what I could
- 17 do for them. And I mean --
- 18 Q. Sure. Well, it sounds like you did everything possibly you
- 19 | could've done. And so you ought to be proud of yourself for at
- 20 | least doing what you could.
- 21 A. Yeah. I mean and -- yes, sir. I mean like I tell people, we
- 22 | work through God's hand, and it's her time to go, but it's kind
- 23 of -- I do know that the husband's best friend had called me after
- 24 the call was over with and was talking to me and stuff. Because
- 25 when we brought her in, they didn't know what her name was. I

- 1 told them at the ER that her name was Sherry; that's all I had.
- 2 So they put her in as Jane Doe.
- 3 So then after the call was over with, after we left the ER,
- 4 that's when the husband's best friend had called me and was
- 5 talking to me. And I said, well, she's at the hospital. Because
- 6 he said, did you treat the lady that was in the SUV? And I said,
- 7 yes.
- 8 And then that's when he said, well, I'm his best friend --
- 9 the husband's best friend. And I said, well -- he asked, he said,
- 10 | well what kind of -- because he's a paramedic too -- he said,
- 11 | well, what kind of injuries? And I told him, I said, well, I
- 12 said, she didn't make it.
- 13 Q. Yeah, she had some pretty traumatic injuries, there's no
- 14 doubt.
- 15 A. Yes, she did. She did. She really did. I think -- like I
- 16 said, I mean that leg was tore all to pieces. And the bone
- 17 | fragments, I mean yeah. So --
- 18 Q. Yeah, I understand. Okay.
- 19 A. But anyway, if there's anything else I can help you with,
- 20 | please, by all means, give me a call. If I don't answer, leave me
- 21 a message. And I do apologize about not getting back with you
- 22 | last night.
- 23 Q. No problem.
- 24 A. And thank you.
- 25 Q. Well, I thank you very much for your taking the time and
