I just want everybody to know, 10 you know, that he has an injury, and so he has been treated for 11 that. So I just try to keep this --12 MR. WILLETT: Gotcha. 13 MS. AMIOTTE McDONALD: -- cohesive as we can here. 14 MS. BELL: Understood. 15 MS. AMIOTTE McDONALD: Okay. 16 MR. FLAHERTY: All right. 17 MS. BELL: I don't think -- I do have a question about the 18 cargo ops. 19 BY MS. BELL: 20 So you have people that inspect that report to you, correct? Ο. 21 INTERPRETER: Who are the people? 22 BY MS. He's Α. 7 holding onto the railing, and it was slippery, the railing, so 8 then he slipped from there. And then he -- after he let go of the 9 railing, he just went straight down and then hit the wall. 10 MS. BELL: I think that's all the questions that I have for 11 you. Thank you. 12 MR. FLAHERTY: Okay. I don't have any questions. 13 MR. McRAE: I have one question. 14 BY MR. McRAE: 15 Q. I represent the slot charters. Were there any problems found 16 with any of the lashings? 17 Α. (In English) No, were not. 18 MR. McRAE: Okay. Thank you. 19 UNIDENTIFIED SPEAKER: No questions, sir. 20 UNIDENTIFIED SPEAKER: No, no questions. 21 MR. WILLETT I just have one more. 22 BY MR. WILLETT: 23 After you fell, how did you get back up? Ο. (Through interpreter) He forced himself to get up and reach a 24 Α. 25 port hold that's nearest to where he landed. So it was -- when he
