7	MR. SEO: My name is Seo and Sunghyun, Sunghyun Seo.					
8	MR. FLAHERTY: And could you please spell your last name?					
9	MR. SEO: Last name is S-e-o. S-e-o.					
10	MR. FLAHERTY: All right. Sir, do I have your permission to					
11	record this interview for the investigation?					
12	MR. SEO: Yeah.

- 14 INTERVIEW OF SEO SUNGHYUN
- 15 BY MR. WILLETT:
- 16 Q. Okay. Sir, before we talk about the incident, we'd just like
- 17 | to get some background. How long have you been sailing?
- 18 A. For almost 9 months.
- 19 O. Nine months?
- 20 A. Yeah.
- 21 O. On this vessel?
- 22 A. No. This vessel is 3 months.
- 23 Q. Okay.
- 24 A. Yeah.
- 25 Q. Did you recently graduate from maritime academy?

- 1 A. Yeah, it's the first time since graduated.
- 2 Q. Okay. Describe your normal duties during the day?
- 3 A. Eight a.m. start to work and noon, noon to eat the lunch and
- 4 5:00 p.m. is stop -- finish the work and go to the common. I have
- 5 less (indiscernible). Just checking the machine.
- 6 Q. Okay. Do you take soundings?
- 7 A. Huh?
- 8 Q. Soundings? Do you take levels? No.
- 9 A. No. The administrative work.
- 10 Q. Okay. And that's normally in the engine control room?
- 11 A. Yes, it's in the engine room that he does administrative
- 12 work.
- 13 Q. So the administrative work you check, like, hours and
- 14 | maintenance?
- 15 A. Yes.
- 16 INTERPRETER: Yes, he does.
- 17 BY MR. WILLETT:
- 18 Q. Okay. Do you ever oversee maintenance of equipment?
- 19 A. No, he doesn't oversee anything. He just receive the
- 20 instruction.
- 21 Q. Okay. Okay. Where were you when you departed Brunswick?
- 22 Where physically on the vessel on the way out?
- 23 A. Engine room, the bottom of engine room.
- 24 Q. The engine control room or --
- 25 A. No, engine room.

- 1 Q. The very bottom?
- 2 A. Yes.
- 3 Q. Okay. And were you there when you prepared to sail, fired up
- 4 | the main engines, the generators, bow thruster?
- 5 A. (No audible response.)
- 6 Q. Yes? On that Saturday on the 8th, the day of the
- 7 departure --
- 8 A. Yeah.
- 9 Q. -- were you in the engine room?
- 10 A. Yeah, I --
- 11 Q. Did you notice during the loading or unloading at Brunswick
- 12 the vessel shift at all? No?
- 13 A. No.
- 14 Q. So that Saturday you got up at 8:00 and worked in the engine
- 15 | room until 5:00?
- 16 A. No.
- 17 Q. No?
- 18 A. Yeah. There was a -- because the departure so there was time
- 19 was not exactly same normal hours.
- 20 Q. Okay. So what time did you go on watch prior to departure?
- 21 A. It's midnight.
- 22 Q. Midnight?
- 23 A. Yeah.
- 24 Q. Okay. So you were in the engine room at midnight and what
- 25 were you doing when the vessel left the dock?

- 1 A. Just patrol the engine room.
- 2 Q. Walking around?
- 3 A. Patrol, yeah.
- 4 Q. What were you looking at or just looking for oil or --
- 5 A. Just looking, yes.
- 6 Q. Making sure there's no leaking or fires?
- 7 A. Yeah, no leaking and fire.
- 8 Q. Okay. When did you realize there was a problem?
- 9 A. When he -- when they realized that there -- the ship was just
- 10 leaning.
- 11 Q. Was the machinery all running prior to the --
- 12 A. Yeah. They -- all the thing was operating, all that.
- 13 Q. When did the machinery stop?
- 14 A. Almost the --
- 15 Q. It ran until it got to here?
- 16 A. Yeah.
- 17 UNIDENTIFIED SPEAKER: Could you -- how many degrees is here?
- 18 INTERPRETER: He say he doesn't know exactly.
- 19 BY MR. WILLETT:
- 20 Q. Okay. Where were you physically? Were you near the main
- 21 engine? Were you near the generators? Were you on the very
- 22 | bottom flat?
- 23 A. Yeah, very bottom. Yeah, very bottom.
- 24 Q. Okay. So were you on the port or starboard side?
- 25 A. Port side.

- 1 Q. Port side.
- 2 A. Yeah.
- 3 Q. So describe what happened as the vessel --
- 4 A. Yeah.
- 5 Q. -- came over. What -- where did you go?
- 6 A. He ran to the upper deck.
- 7 Q. Okay. You went up to the next deck?
- 8 A. Yeah, next deck.
- 9 0. And then where?
- 10 A. And after that he could not move no longer because of the
- 11 | ship has tilted so much.
- 12 Q. Did you get the EE, the Emergency Escape Breathing Device?
- 13 Did you get the orange -- no? Was it dark, completely dark?
- 14 A. Dark. Dark, yeah.
- 15 Q. Did you have a flashlight?
- 16 A. I have a flashlight but I can't find this EEBD.
- 17 Q. Okay.
- 18 A. Yeah.
- 19 Q. So was there any smoke or fire in the engine room?
- 20 A. No.
- 21 O. No?
- 22 A. No.
- 23 Q. So it was you could breathe?
- 24 A. Yeah, breathe. It can breathe, well -- he can breathe but
- 25 the odor of the fuel --

- 1 Q. Yes. The -- oh, you smelled diesel exhaust, steam?
- 2 A. Yes.
- 3 Q. How long were you on the second deck, the second flat?
- 4 A. He doesn't remember.
- 5 Q. Don't remember? Did -- after you went to the side, did you
- 6 stay there for many hours or 2 or 3 hours?
- 7 A. For 6 hours.
- 8 Q. Six hours? And then where did you go?
- 9 A. Okay. He could not see because it's so dark and he was
- 10 trying to escape from the water.
- 11 Q. Uh-huh.
- 12 A. And he -- and there were -- he can grab, you know, away from
- 13 | the water and so he doesn't really know where, but he trying to
- 14 escape from the water.
- 15 Q. Okay. Did you hear tapping?
- 16 A. Yeah. There is tapping.
- 17 Q. Did you tap back?
- 18 A. Yeah, just tap back for this not loud It's even though he
- 19 tap he feel like no one could hear him.
- 20 Q. What were you tapping with?
- 21 A. Just driver. Driver and --
- 22 INTERPRETER: With a screwdriver?
- MR. LEE: Yeah, screwdriver.
- 24 BY MR. WILLETT:
- 25 Q. Screwdriver. Did you ever go back to where shaft alley,

- 1 where the shaft of the screw, did you make your way back that way?
- 2 A. No.
- 3 Q. You stayed there the whole time?
- 4 A. Yeah.
- 5 MR. WILLETT: Okay. All right. I'm --
- 6 MR. LEDET: I have no questions right now.
- 7 BY MS. BELL:
- 8 Q. I just -- I know he asked those questions, but can you just
- 9 | tell us -- excuse me -- in your own words what happened from the
- 10 | time you left port until the incident?
- 11 A. At the time of departure there was a normal and nothing
- 12 unordinary. And we did not recognize anything above the normal.
- 13 And he was making his routes and in the engine room and
- 14 patrolling. He can't really -- he doesn't have any recollection
- 15 to really explain, but he knows that his normal activities at time
- of departure were they say he can (indiscernible).
- 17 MS. BELL: Okay. That's all I have. Thank you.
- 18 BY MR. FLAHERTY:
- 19 Q. So you, at the time you didn't have your flashlight or you
- 20 | lost your flashlight when the incident happened?
- 21 A. Okay. He was with a cadet and the cadet had the flashlight
- 22 | so he was able to use cadet's, the flashlight. He did not have
- 23 his so he used the cadet's.
- Q. Okay. And when the incident happened did the -- did any
- 25 emergency lights come on at all or it just went dark?

- 1 A. He say he cannot recollect.
- 2 Q. Okay. Did the water that entered the engine room was it
- 3 | immediately after the vessel heeled over or was there some time
- 4 | between the vessel heeling over and water coming in?
- 5 A. It was immediately after the incident was -- he could see the
- 6 water was coming up.
- 7 Q. Okay. And as you were in there the -- as you were climbing
- 8 up to get away from the water --
- 9 A. Yeah.
- 10 Q. -- did the -- over time did the water level keep coming up?
- 11 A. Yeah.
- 12 Q. Okay.
- 13 A. Yes.
- 14 Q. All right. So the -- you were on the lowest level. How many
- 15 | levels is that to the -- where the engine control room is?
- 16 A. Third deck, three floors.
- 17 Q. Three decks above where he was? Okay. What piece of
- 18 equipment, just as a reference, were you standing next to prior to
- 19 | the incident occurring?
- 20 A. He says on the bottom.
- 21 Q. What was there -- what piece of -- what machinery or
- 22 | equipment was next to him?
- 23 A. Just sewage treatment.
- 24 Q. Sewage treatment? Okay.
- 25 A. Yeah.

- 1 Q. All right. When the incident happened did you hear any other
- 2 of the people who were also -- verbally did you hear anyone
- 3 speaking who were also in the engine room? Did you hear anyone
- 4 talking or were you completely by yourself the whole time?
- 5 A. There was an announcement by the captain and then he was with
- 6 a cadet.
- 7 Q. Okay, so he was with a cadet. Okay. And you and the cadet
- 8 stayed together during the whole time?
- 9 A. Yeah. Yeah.
- 10 Q. Okay. And the cadet, did he still have his flashlight?
- 11 A. Yeah, flashlight.
- MR. FLAHERTY: Okay. All right. I have no further
- 13 questions.
- 14 UNIDENTIFIED SPEAKER: I have no questions.
- 15 UNIDENTIFIED SPEAKER: No questions, sir.
- 16 UNIDENTIFIED SPEAKER: No questions for me.
- 17 BY MR. WILLETT:
- 18 Q. I have one final. When you were making your rounds on the
- 19 way out would you know if a ballast pump was running?
- 20 A. I don't know.
- 21 Q. Do you know where the ballast pumps are?
- 22 A. He knows.
- 23 Q. Where are they?
- 24 A. Float (indiscernible) is almost middle, middle, yeah.
- 25 Q. It's in the engine room?

- 1 A. Yeah.
- 2 Q. Okay. If they are on would you know?
- 3 A. Yes.
- 4 Q. Yes? But do you recall if they were on or off? You don't
- 5 remember or you just -- you think they were off?
- 6 A. He doesn't --
- 7 Q. He doesn't remember?
- 8 A. No.
- 9 INTERPRETER: He doesn't remember.
- 10 MR. WILLETT: Okay.
- 11 BY MS. BELL:
- 12 Q. Did you say that you heard an announcement by the captain?
- 13 A. Yes.
- 14 Q. What was that announcement?
- 15 A. That he announce they come to a certain point but he doesn't
- 16 remember where, but he was -- the captain was announcing to come
- 17 to certain point but he does not remember where to.
- 18 Q. Okay, thank you.
- 19 BY UNIDENTIFIED SPEAKER:
- 20 Q. Excuse me. Did you -- Les Ledet, U.S. Coast Guard. Do you
- 21 | recall was that announcement -- did you hear it on a P.A. system
- 22 or a handheld radio?
- 23 A. P.A. system.
- 24 O. A P.A.?
- 25 A. Yeah.
