

NS Counsel advises he will handle and doesn't expect it should be an issue NS Counsel texted IIC stating no further data was available. Locomotives were returned to service and data only available going back to 2/10

IIC call to NS Party Spokesperson to inquire if NS performed a full data download of the image recorders.

A few

hours later, NS Spokesperson confirmed that no additional image recorder data was available.
