We propose to supply all supervision, labor, materials and equipment necessary to perform the following scope of work: 3 Bars & 2 Wait Stations – approx. 960 square feet of floor (integral cove base excluded from scope of work). Measurements provided by Andy C. from Cooley Marine Management

INSTALLATION OF BASF MASTERTOP 1843 SRS CQ (QUARTZ) <u>FLEXIBLE</u> MMA/ACRYLIC FLOORING SYSTEM (CURES 1 HOUR AFTER INSTALLATION – 2-3 DAY PROJECT)

- Step 1: Surface preparation to be performed by Cooley Marine Management mechanically beadblast, sand or grind all steel surfaces down to white, ferrous metal to provide an anchor profile into the surface.
- Step 2: IFS to use wire brushes to skim pre-prepared surfaces should metal have oxidized before IFS arrival.
- Step 3: Apply a full coat of PPG Amerlock 2 Epoxy Primer.
- Step 4: Apply a full prime coat of MasterTop SRS 51P Primer/Sealer.
- Step 5: Apply a base coat of MasterTop SRS 40TCSL (Flexible).
- Step 6: While 40TCSL base coat is still wet, a full broadcast of 'S' Grade colorquartz will be introduced.
- Step 7: Apply two (2) full finish coats of MasterTop SRS 71TC Clear Satin Topcoat.

Qualifications:

- 1) Pricing based on:
 - a. Floor substrate Existing metal/steel decking (to be prepped prior to IFS arrival)
 - b. Wall substrate n/a (no integral cove base to be installed)
 - c. Shifts Normal, Day (Monday Friday)
 - d. Phases/mobilizations One
 - e. Sloping Not factored into proposal
 - f. Misc. Project Details
 - i. Existing metal decking to be prepped prior to IFS start up
 - ii. Integral cove base not included in scope of work/pricing above
- 2) This is a hand applied & broadcasted resinous flooring system, therefore imperfections may be seen. This does not affect the functionality of the system.
- 3) ADDENDUMS/RFIs None
- 4) Moisture tests not necessary for this project
- 5) Any new concrete (Portland based) must cure for 28 days before resinous flooring installation.
- 6) Any major concrete patching/repairs will be performed on a time & material basis & included in final invoice.
- 7) Any downtime caused to our laborers while working around other trades will be back charged directly to GC/owner
