MGL, c. 90, § 22(a) mandates an IMMEDIATE suspension of your license/right to operate a motor vehicle whenever the RMV has reason to believe that continuing operation by the operator will be so seriously improper as to constitute an immediate threat to public safety. An operator suspended under MGL, c. 90, § 22(a) is entitled to a suspension hearing within 30 DAYS of the suspension.

This offense may be combined, by law, with prior and future offenses to determine appropriate reinstatement requirements. No hardship licenses are authorized by law during this period of suspension.

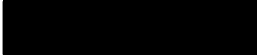
