Good morning David. Answers to your questions below. Let me know if you need any clarification.

- 1. There were no smoke or heat detectors in the dry stores room.
 - a. I believe there was one smoke detector in the dry stores room, though I cannot guarantee this.
- There were no smoke or heat detectors in the deck locker located above the dry stores room.
 a. As far as I know this is correct.
- 3. The control panel for the fire detection system was only located on the bridge.
 - a. The fire and smoke sensors were all tied in to the ships main alarm system. There were control panels in the following locations: Bridge, Engine Control Room, Watermaker room, and Refrigeration room.
- 4. The control panel for the fire detection system had a wireless notification system, but it did not notify the designated personnel the night of the fire.
 - a. Correct. I can confirm that the wireless notifications system was working as late as

March 31st. I have an email generated from that system when it was triggered due to smoke from hotwork activities in the bow thruster space. It did not send out any notifications the night of the fire. I can't be certain why.

- 5. The control panel for the fire detection system had an audible alarm, but it was not connected to the vessel's general alarm or other internal communication systems on the vessel.
 - a. Correct. The ships alarm system, of which the fire detection equipment was part of, was not tied in to the general alarm. There were strobes and audible alarms dedicated to that system, but it did not cross over to the general alarm.
