• Freon - The crew was able to access the refrigeration machinery space and confirm that the system is no longer a closed loop and that the tanks no longer contain amounts of freon beyond residual.

#### 7.1 SAFETY OBSERVATIONS

- An updated Dive Operations Plan was submitted to the Unified Command.
- Today's safety topic is slips, trips and falls. The current rainy weather is increasing slippery conditions onboard the vessel and on the pier. This weather is expected to continue for the foreseeable future.
