Narrative:

Mr. Tessier was assigned the accident at the Skaneateles Aerordrome (6B9), Skaneateles, NY who worked the scene, interviewed the pilot, the witnesses, and the mechanic who examined the airplane after the accident. He was interviewed by telephone and provided written documentation of his findings.

Below, are excerpts from the documents forwarded by Mr. Tessier:

DAMAGE: SUBSTANTIAL, PROP BENT FROM PROP STRIKE, FIREWALL BENT TAIL BENT AND CRUSHED, RIGHT AILERON BENT, RIGHT STRUT BENT LEFT FUEL CAP CAME OFF AND FUEL (100LL) SPILLED ON TAXIWAY. SKANEATELES, NY (6B9): N1331K, L8 A,

WHILE ATTEMPTING TO DEPART RUNWAY 28, AIRCRAFT VEERED OFF OF RUNWAY, PITCHED FORWARD AND CAME TO REST INVERTED ON TAXIWAY FOXTROT, NEXT TO THE RUNWAY.

MR. CARLSON STATED THAT HE FLEW FROM SENECA FALLS (OG7) AIRPORT TO SKANEATELES AIRPORT, (6B9) TO MEET WITH DON MCANN TO HAVE SOME MAGNETOS FROM ANOTHER AIRCRAFT HE OWNS, INSPECTED. HIS AIRCRAFT WAS PARKED ON THE RAMP IN FRONT OF THE HANGER. HE BACK TAXIED ON RUNWAY 28.

HE DID A RUN UP AND CHECKED THE AIRCRAFT OUT. AS HE TOOK OFF, HE GOT THE NOSE OFF THE GROUND, THE PLANE PULLED TO THE LEFT. HE SAID HE DID NOT HAVE MUCH RUDDER CONTROL. THE AIRCRAFT WENT INTO THE GRASS NEXT TO THE RUNWAY. THE GRASS WAS ROUGH AND THERE WAS NO WAY OF GETTING BACK OUT TO THE RUNWAY. THE AIRCRAFT FLIPPED UPSIDE DOWN ON THE PAVEMENT. SOMEONE HELPED HIM GET OUT OF THE AIRCRAFT.

THE WIND WAS APPROXIMATELY 030 AT 10 KNOTS. ALTIMETER 30.19, 73F DEGREES AND CLEAR SKIES.

MECHANIC, DON MCANN CONDUCTED A CONTINUITY CHECK OF THE RUDDER SYSTEM. HE SAID THE RUDDER CABLES WERE CONNECTED FROM PEDALS TO RUDDER. AND EVEN WITH THE DAMAGE TO THE TAIL, WHEN HE PUT PRESSURE ON THE PEDALS, THE RUDDER TRIED TO MOVE.
