3	MR. FOX: Today is June the 11th, 2014. This is Michael
4	Fox from the National Transportation Safety Board, the NTSB, out
5	of Washington, D.C. Today it is currently 4:55 p.m., and we are
6	at the Atlantic Transportation Services, the vehicle that was
7	struck in the recent accident, and we are going to be interviewing
8	
9	And, sir, could you please give me your name and title?
10	MR. President.
11	MR. FOX: President. Also present in the room, we have
12	another investigator with the NTSB, Ensar Becic. Could you please
13	identify yourself and title?
14	DR. BECIC: Ensar Becic, project manager with NTSB.
15	MR. FOX: And also present with have Could
16	you please identify yourself and your title, ma'am?
17	: manager.
18	INTERVIEW OF
19	BY MR. FOX:
20	O. So, sir, we are here to investigate the crash that

- Q. So, sir, we are here to investigate the crash that
- 21 happened this past weekend, and we wanted to know more about it.
- 22 How long have you been employed here at the company?
- 23 A. This company would be March 18th, 2013.
- Q. And what are your duties and responsibilities here?
- 25 A. President of the company. I check over vehicles,

- 1 vehicle maintenance, drivers, interview the drivers, train the
- 2 drivers. Basically, do as much as I can to get the operators of
- 3 our vehicles on the -- what do I want to say -- just a
- 4 understanding of what we're doing, what we're trying to do. And
- 5 keep them on the same page. Basically, a lot of our drivers are
- 6 bus drivers and a few have come in the limo business, so I want to
- 7 teach them and talk to them about what's the difference.
- 8 Q. Okay. What made you get into the business?
- 9 A. 2004, was it? I thought -- I got asked to do a run on
- 10 New Years' Eve night and got -- the gentleman knew I didn't drink,
- 11 and I did the run. And it was my first limousine run and I was
- 12 pretty hooked. Because I was a tractor-trailer driver -- I went
- 13 out for 6 hours, took some people home, drove a nice car, wore an
- 14 nice suit, and made more money than I used to make going to
- 15 Chicago, so it was a easy love affair at that point. So I wanted
- 16 to do more of it, learn more of it.
- 17 Q. Okay. And when did you get your CDL?
- 18 A. I got my CDL October 1993 in Cedar Rapids, Iowa.
- 19 Q. And did you attend a truck driving school or --
- 20 A. Yes.
- 21 Q. -- some other professional school?
- 22 A. Yes, sir. It was the Kirkwood Community College out in
- 23 -- out there. And I was attending through a company called CRST,
- 24 Cedar Rapids Steel Transport, and I was in their trucking program.
- Q. And upon completion of the school, what did you do?

1 A. I drove OTR, which is over the road, 48 states for them

- 2 approximately 4 to 6 months. And I just, you know, came home,
- 3 looked for a local employment, and -- just being away 4 to 6 weeks
- 4 was just too much.
- 5 Q. So what happened next?
- 6 A. What happened next, I was employed through a company
- 7 that was called -- they're like a driver, temp driver service. So
- 8 I would use my own personal car and go to certain companies that
- 9 maybe their driver was sick and I'd fill in on their route. And I
- 10 got paid -- Labor Logistics is what it was called. So and I
- 11 worked for Labor, I want to say, at least 2, 3 years.
- 12 Q. And what year time frame are we talking about?
- 13 A. From '94 to about '97, '98.
- 14 Q. Um-hum.
- 15 A. And after that I became a union car hauler, which is
- 16 tractor-trailer, open-carrier car hauler. So I -- in Chester,
- 17 Pennsylvania. And I joined them right from Labor Logistics. I
- 18 was there all the way up to about from '98 to 2000 -- 2000,
- 19 somewhere in there. Like 3 years, I think, '98 --
- 20 : Three or 4 years.
- 21 : -- 2000, 2001.
- 22 And I left the union to go over the road again with a
- 23 company, which this time it was east of the Mississippi so home
- 24 time was supposed to be more. But I was delivering luxury BMWs
- 25 and Mercedes and all type of -- it was called Bavarian Motor

- 1 Transport, BMT.
- 2 BY MR. FOX:
- 3 Q. I'm familiar with it. And then what happened next?
- 4 A. Bavarian Motor Transport, came home, got a job --
- 5 another car hauling job with a company called Auto Elite. Went to
- 6 Auto Elite and -- right? From BMT, Auto Elite? And I stayed with
- 7 Auto Elite until I, until I --
- 8 Application on the bottom.
- 9 What's that?
- : Giving you the years on the bottom, the
- 11 dates.
- : Oh, okay. Yeah, so Auto Elite, February '04
- 13 August '04. And then I came home, went to work for Dave's
- 14 Limousine. And after Dave's Limousine, is when I got the
- 15 opportunity to start Bayside Limousine.
- 16 BY MR. FOX:
- 17 Q. Bayside Limousine. And where was Bayside Limousine
- 18 located?
- 19 A. Bayside originally was located in Dover, South Bradford
- 20 Street.
- Q. And what was your position there?
- 22 A. Secretary.
- Q. And how many vehicles were operating at Bayside, and
- 24 what time frame are we talking about?
- A. We're talking -- Bayside was April of --

- 1 MS. 2005.
- 2 MR. -- 2005, we started that?
- 3 MS. Um-hum.
- 4 MR. And we had two vehicles. Two stretch 10-
- 5 passenger limousines.
- BY MR. FOX:
- 7 Q. And --
- 8 A. And Bayside basically continued from that date until
- 9 about 2 or 3 years later, I changed partners, but I still
- 10 continued with the company and I went from being the secretary of
- 11 the company till July -- 2009?
- 12 MS. I think so.
- 13 MR. III : I think it was July 2009, Bayside -- and I
- 14 became the president of Bayside Limousine. Each time, I was a 40
- 15 percent owner, so my percentage of ownership never changed even
- 16 though I went from secretary to president. Then on March 18th,
- 17 2013 is when we formed Atlantic Transportation Services and we
- 18 basically bought all of the equity assets of Bayside.
- 19 BY MR. FOX:
- 20 Q. In both Bayside and at your current company here at
- 21 Atlantic, in addition to being the president, are you responsible
- 22 to do any driving duties?
- 23 A. Yes. I did the same amount of driving that I do now. I
- 24 mean, I did driving, I did maintenance, did -- you know, I took
- 25 care of the vehicles.

- 1 Q. What type of vehicles do you drive?
- 2 A. Everything from the buses to the sedans and all of our
- 3 stretches.
- 4 Q. What vehicle were you driving at the time of the
- 5 accident?
- 6 A. I was driving a 2012 Mercedes Sprinter.
- 7 Q. Do you know what its seating capacity is?
- 8 A. Eight in the back and two up front.
- 9 Q. Two up front. And you were the driver --
- 10 A. Yes, sir.
- 11 Q. -- at the time of the accident?
- 12 A. Yes, sir.
- Q. Who was the other passenger that was up front besides
- 14 you?
- 15 A.
- 16 Q. Is he an employee of the company?
- 17 A. Yes.
- 18 Q. And what is his responsibility or duties?
- 19 A. Limousine driver.
- Q. Was he a backup for you?
- 21 A. Yes.
- Q. Were you wearing your seat belt at the time of the
- 23 accident?
- 24 A. Yes, sir.
- 25 Q. Was --

- 1 A. Yes, sir.
- 2 Q. --
- 3 A. was, also.
- Q. Okay. Did you provide any kind of safety briefing or
- 5 show any kind of pre-trip information to your passengers before
- 6 you left?
- 7 A. No, sir.
- 8 Q. How were you sitting prior to the crash? Can you
- 9 describe how you were sitting?
- 10 A. I was sitting, sitting straight up, because I was
- 11 looking up above, you know, the distance of the vehicles in front
- 12 of me. So I was sitting up straight.
- MR. FOX: I'm going to pass my questions to Ensar
- 14 because I think he has some of these questions relating to the
- 15 vehicle.
- 16 BY DR. BECIC:
- 17 Q. Do you know the locations of your passengers in the
- 18 back? Where were they seated?
- 19 A. The last time we stopped, which was about 15 to 20
- 20 minutes prior to the accident, was sitting at the door. And
- 21 he would be behind , back to back. And then, I believe
- 22 was behind me, back to back. Then facing was
- 23
- MR. FOX: Maybe you could help draw a little diagram to
- 25 help me --

- 2 MR. FOX: -- a little bit better, or do it on Ensar's --
- 3 MR. Okay.
- 4 MR. FOX: -- pad.
- 5 MR. So if I want to split the driver seat, this
- 6 is the passenger seat. This is the two seats. So see 's here.
- 7 And this is my door, a slide door. And then there's pretty much a
- 8 little bar here. Then there's a seat across from . So
- 9 Ardie's here. I got a, like a little divider right here so --
- 11 What I'm not sure of is -- and I'm assuming, based on
- 12 the results of the crash, that this was , . And across --
- 13 so there's a bar here. And then across from is . And
- 14 then there's a sofa right here that seats three, but there was a
- 15 lot of clothing on the sofa. And then there's a small luggage --
- : Compartment in the back.
- 17 : -- compartment right there. So -- and
- 18 that's, that was pretty much the last visual I remember --
- DR. BECIC: Okay.
- 20 MR. -- looking in. When we stopped, I took
- 21 pictures, so -- and as everybody climbed in. Now, if anybody
- 22 moved after I started rolling -- I'm pretty sure I can vouch that
- and never moved based on the conversation we were
- 24 having.
- 25 BY DR. BECIC:

- 1 Q. Okay, so you are certain.
- 2 A. And I would -- yeah.
- 3 Q. Okay. And was also seated and -- or --
- 4 A. Yeah, so --
- 5 Q. -- which direction was he facing?
- A. So and are facing the rear of the vehicle.
- 7 Everyone else is facing the front of the vehicle.
- 8 Q. Okay.
- 9 MS. **MS.**
- 10 MR. is facing the front.
- 11 BY DR. BECIC:
- 12 Q. Okay. I think I will need contact information for
- 13
- 14 A. Yeah. I have that.
- MR. FOX: We can get it later.
- DR. BECIC: We can get it later.
- 17 MR. Okay.
- DR. BECIC: I think that's all.
- MR. FOX: Okay.
- DR. BECIC: Going back to the (indiscernible).
- 21 BY MR. FOX:
- Q. Let's discuss the trip.
- 23 A. Okay.
- Q. Do you need the itinerary to refresh your memory?
- 25 A. No, sir.

- Q. Can you, to the best of your ability, remember how your
- 2 day began, when you first went to pick up your passengers, when
- 3 that was?
- 4 A. Yeah. So I arrived at shome.
- 5 Q. What date was that?
- 6 A. That is Friday, the 6th of June. And I was in, what,
- 7 the -- yeah, I was in the Chevy Suburban, a 2011 Chevy Suburban.
- 8 I sat in the street for about 15 minutes because I usually like to
- 9 go to the door 15 minutes before, prior to the pickup. So then I
- 10 backed into the driveway at about 3:15 for a 3:30 pickup.
- I was greeted at the door by swife, who said --
- 12 and I let them know that I wasn't rushing them, I just letting
- 13 them know I was here. son came to the door, and another
- 14 Town Car pulled in -- or another vehicle pulled in, but it was a
- 15 Town Car, and it took son. And he told me his dad would
- 16 be out in a few minutes.
- 17 O. And this was at what location?
- 18 A. That was at the Cresskill home on . I
- 19 forget the --
- Q. What state are we in?
- 21 A. New Jersey.
- Q. So I guess I need to back up. You left your terminal
- 23 here in Delaware?
- 24 A. Yes, sir.
- 25 Q. And what time was that?

- 1 A. I left the terminal here between 11:15 and 11:30.
- 2 Q. Here in Delaware?
- 3 A. Yes, sir.
- Q. At 11:15. And then from there you went to New Jersey?
- 5 A. Yes, went to New Jersey. And I stopped at the
- 6 Eisenhower rest area for fuel.
- 7 Q. Fuel? Do you know what time that was approximately?
- 8 A. I would say after 2. After about -- yeah, about 2,
- 9 2:15, somewhere in there.
- 10 Q. Okay. And --
- 11 A. Left there, and I wasn't too far from strong 's house. I
- 12 arrived at his house somewhere about quarter to 3, 10 to 3, I
- 13 believe. I sat out -- I sat on the street.
- 14 Q. If I can back up.
- 15 A. Um-hum.
- Q. You said you got fuel in New Jersey. Do you know what
- 17 exit that was or what city that was?
- 18 A. If I could look at a map, I could tell you. But I
- 19 believe it was the Eisenhower rest area, which is the last plaza
- 20 that you can hit before you -- going north, before you go over a
- 21 bridge or the Lincoln Tunnel.
- Q. Into New Jersey?
- 23 A. Yes. Into New York.
- Q. I'm sorry. Into New York. Okay.
- 25 And then you picked up your (indiscernible static).

- 1 A. No, we never -- I don't know where New York came from,
- 2 but it's -- the town's called Cresskill, New Jersey.
- 3 Q. Okay. I'm sorry. Cresskill --
- : Cresskill.
- : Or (indiscernible static) K-I-L-L.
- BY MR. FOX:
- 7 Q. Okay, I see it here. Okay, on
- 8 A. Yes,
- 9 Q. And approximately what time was that?
- 10 A. I think I -- I want to believe I pulled up about quarter
- 11 to 3 or a couple minutes before 3, because I remember that it was
- 12 a 3:30 pickup, and I didn't want to knock on the door until about
- 13 15 minutes prior. So I sat outside (indiscernible static) and
- 14 about 3:15, I pulled into the driveway.
- 15 Q. All right. And what happened next?
- A. From there, as I stated, I was greeted by his wife when
- 17 I knocked on the door. I was told (indiscernible static).
- Briefly after that, the vehicle left and
- 19 pulled up. And when he was coming in the driveway, I asked him if
- 20 he needed to go (indiscernible static) -shaped driveway. And I
- 21 asked him where he needed to go and he said he needed to go around
- 22 the back.
- So I backed into the U-shape driveway in front of, I
- 24 assume, small sat there. He parked his car. I
- 25 pulled back out and waited for him. He came up with like a small

- 1 bag and some clothing. I hung it in the clips on the -- in the
- 2 Suburban. We had some conversation, and while he was putting
- 3 laces in the shoes in the back of my -- back of the Suburban,
- 4 Tracy came out the house holding his baby.
- 5 Q. Um-hum.
- A. I started to approach to see if I have anything to
- 7 grab, didn't know, and he kind of gave me the stop sign. And I
- 8 took a step back, and I said, no problem. And his baby kind of
- 9 made eye contact, and I smiled, she smiled back. And let me
- 10 know that this is my princess right here.
- 11 Q. Um-hum.
- 12 A. So, and I said, all right, as a father of two girls, I
- 13 totally understand.
- And so him and Mr. had a couple conversations
- about what they were going to do tonight and if Mr. was
- 16 going to touch the stage, as put it. And he said, you know,
- 17 you never know. And they just shared a laugh and a hug, an
- 18 embrace. And we hung out probably another 15 -- 15, 20 minutes
- 19 before, I want to say, Jeff pulled up.
- 20 pulled up, put his stuff in the car. And we stayed
- 21 in the driveway still kind of talking and different subjects were
- 22 coming up about, you know, what they had -- what they were doing.
- 23 And then the last two to show up were and and After
- 24 and showed up, we loaded everything in the car. They
- 25 did a couple final little checks back and forth. "s wife --

- 1 her trainer came and they went for a run with the baby in a
- 2 carriage.
- And everybody said they were ready. And I usually kind
- 4 of ease out of their driveway very slow because it's usually the
- 5 trigger of what I forgot, whether it's keys, whether it's, you
- 6 know, I need something. So I kind of did that slow because of
- 7 just experience --
- 8 Q. Sure.
- 9 A. -- of having to turn around and come back. And then I,
- 10 at the driveway, I said everybody got everything? We're sure?
- 11 Everybody's like, yeah, we're good. And then check for chargers,
- 12 phones, and we hit the road. And I let them know that, you know,
- 13 we were tight on time. The show started at 9, and my GPS said I
- 14 was going to get there 8 -- I believe it said 8:30.
- 15 O. Um-hum.
- DR. BECIC: Oh, can I interject quickly? You mentioned
- 17 Suburban a couple of times earlier. Whose vehicles were you
- 18 referring to?
- 19 MR. : The Suburban is the vehicle that I showed up
- 20 in.
- DR. BECIC: So that's the vehicle you --
- 22 MR. I picked up.
- DR. BECIC: Okay.
- 24 MR. So I picked up -- original booking was for
- 25 four.

- 1 DR. BECIC: Okay.
- 2 MR. : And then it was changed to five, because
- 3 Mr. was a late minute addition.
- 4 DR. BECIC: Okay.
- 5 MR. Last minute addition. So during the trip, a
- 6 lot of conversation, a lot of laughs. And so I had let, you know,
- 7 Mr. and a couple other gentlemen were long, long legs.
- 8 And, you know, in the back, and I told them, I said, yeah, the
- 9 seats don't, you know, move forward to give anybody behind you
- 10 extra room.
- And I said, you know, I did want to bring, you know, our
- 12 Sprinter up but I was told that, you know, you didn't want any
- 13 limo-type vehicle. So he said, well, who told you that, you know
- 14 And I just basically said, I just thought your people told us
- 15 that. And he said, no, you know, that's not the case. So I --
- 16 BY MR. FOX:
- Q. What, if I can ask and interject, what time did you
- 18 leave New Jersey?
- 19 A. I want to say I left New Jersey like quarter after 4,
- 20 was it?
- 21 MS. 4:30.
- 22 MR. 4:30? Yeah, so 4:30. So we were in the
- 23 driveway --
- MR. FOX: You left New Jersey --
- 25 MR. an hour.

- 1 BY MR. FOX:
- 2 Q. -- at 4:30. Okay. And you were heading to --
- 3 A. Dover Downs.
- 4 O. -- Dover Downs?
- 5 A. Yup.
- 6 Q. Okay. All right, sir. So continue.
- 7 A. So we're heading down the Turnpike. I'm letting them
- 8 know that, you know, I saw a lot of traffic on the way up and I
- 9 was going to check it on the way back. I have a GPS in there, and
- 10 I'm kind of -- I check the GPS. It's giving me a time of arrival
- 11 I think about -- a little bit later than my phone, Google Map.
- 12 Q. Um-hum.
- 13 A. So I looked at my phone on Google Map, and I could see
- 14 the traffic and how long it was getting. And I said that I think
- 15 we're going to have to do a little detour on this to save some
- 16 time. And I said, I just wanted to let you know. I didn't want
- 17 you to see me get off the highway and wonder where I was taking
- 18 you. And they were like, no, whatever you got to do.
- So I jumped off at Exit 9, took Route 1 to 130, and I
- 20 got back on, and I know I was -- I wanted to get back on at 33,
- 21 and I actually missed that one, which was a good thing, because it
- 22 was still traffic backed up on the Turnpike. So I got on at the
- 23 one south of that, so off of 130. My GPS time actually gave me 15
- 24 minutes back, so that let me know that it was calculating the
- 25 traffic time. So I was kind of glad that I got 15 minutes,

- 1 knowing that they had a show to do.
- 2 So we continued down the road. Everything's fine. A
- 3 lot more rapport building, a lot more jokes. I felt like I was a
- 4 sample of new material because they were just throwing different,
- 5 you know, things at me and it was going from _____, and it was
- 6 going -- and was sitting behind me. And I -- a couple
- 7 times, I broke out in tears just on the way down with a lot of the
- 8 things they were telling me. And I just couldn't wait to share
- 9 all of this with her, you know --
- 10 Q. Sure.
- 11 A. -- because that's -- if there's anything that she knows
- 12 me, you know, you can be an R&B singer, you can be this, but she
- 13 knows I love my comedians. So soon as we get a call that there's
- 14 comedians coming in, slike, ah, you know, you know, I know
- 15 who's doing this one. And I'm like, yeah. Because so far every
- 16 -- from Dover Downs, I
- 17 did them all. So, and I -- you know, based on where they come
- 18 from with their comedy, I kind of, you know, relate and all that
- 19 stuff, so -- love the, I love the craft.
- 20 Q. Sure.
- 21 A. So we're coming down and everybody's already talking
- 22 about like what's going on, what's Dover Downs like. I let them
- 23 know that, you know, we're across from Delaware State University,
- 24 you know, it's a predominantly black college, you should have a
- 25 great turnout. He asked if it was sold out. I said, yeah, it's

- 1 sold out. So he was like, wow. He's like, that's good; my last
- 2 few have been sold out, so this is nice.
- 3 Q. Um-hum.
- A. You know, and he let me know that it's hard, you know,
- 5 that, you know, everybody thinks because they see you on TV that,
- 6 you know, it's automatically you get it, you got it, just because
- 7 they see you one time on TV. And the circumstances now, it's, you
- 8 know, it's amazing how ignorant some people can be to what's going
- 9 on really.
- 10 And he just let me know that -- you know, I let him know
- 11 how Dover Downs people are, completely professional, you're going
- 12 to love it. Because I see them go over and beyond for all their
- 13 entertainers. Well, I'm already surmising in my head like I know
- 14 some 's going to love them, because I've been with her with some
- 15 very difficult entertainers.
- 16 O. Um-hum.
- 17 A. These guys, if a bottle of water would make them --
- 18 that's all he really wanted or really needed. So I said, she's
- 19 going to love these guys.
- 20 So we got close to Delaware, coming up on Exit 3 --
- 21 well, coming up, passing Exit 3, saw the Nathan's sign for
- 22 the rest area and he said, man, can we get some Nathan's? And I
- 23 said, well, we're a little close on time, but if we get our
- 24 Nathan's and we leave, we can probably do some Nathan's. And he
- 25 said, yeah, we got to do some Nathan's. And I said, yeah, you

- 1 can't go down there hungry. I said, all right. You know, and I'm
- 2 tracking time and I'm like, all right. So I think at that time, I
- 3 was due into Delaware -- I think I was due there like, like 8,
- 4 8:15, somewhere, you know, according to my ETA on my GPS.
- 5 So they go in. I stand by the door. I help -- I throw
- 6 the trash and some of the water bottles that I had in the car, and
- 7 I throw that all out. I get the car ready to go. I fold seats
- 8 up. This way it's easier to get in and out when they come back
- 9 in.
- 10 And went in and came out with his food, ate a
- 11 little bit outside, you know, and I kind of said, you know, the
- 12 old, you know, regulators kind of mount up. And we got in the car
- 13 and we were back, you know, at it. You know, we continued south
- 14 into -- we didn't even hit the bridge, and I thought it was funny
- 15 because asked me if we were in Delaware yet. And I was just
- 16 thinking, you know, we're still on the Jersey Turnpike.
- 17 Q. Sure.
- 18 A. If anybody should know what the Jersey Turnpike looks
- 19 like, it should be him, you know.
- 20 Q. Sure.
- 21 A. So we went across the bridge and I came down through
- 22 Newcastle, Route 13. And he's like, you know -- and I guess
- 23 because he saw the business district and business area -- we
- 24 close? And I'm like, no, we're -- we still got a good 30-
- 25 something miles to go. He's like, man, this is what, this like 4

- 1 hours, 5 hours? I said, it says GPS -- the GPS says 3:45, you
- 2 know. And I said, we had some good spots, we had some bad spots,
- 3 I said, but Nathan's made it 4 hours, you know.
- 4 Q. So what time did you arrive at Dover Downs?
- 5 A. We arrived at Dover Downs at I believe like 8:25, 8:26,
- 6 somewhere in there.
- 7 Q. All right.
- 8 A. I just remember looking at it and letting know
- 9 that I was coming in, because I -- as I told her, when I got
- 10 there, I could feel your anxiety from Smyrna. You got a 9:00 show
- 11 and there's no entertainers. It's a half hour --
- 12 Q. Absolutely.
- 13 A. -- away. So when I got there, everybody that worked in
- 14 the entertainment industry for Dover Downs was standing in that
- 15 parking lot.
- 16 O. Sure.
- 17 A. And so they asked what they needed.
- 18 said, nothing. And I said, look -- and I let them know that I
- 19 know where the dressing rooms are, so don't worry about your bags,
- 20 I'll take care of your bags. I'll be outside the dressing room,
- 21 and I'll -- you know, when you go in, do whatever they need you to
- 22 do. They said, beautiful, .
- 23 So I got out. I shook hands with some people there.
- 24 And they said, well, come on, we'll grab your stuff. And they
- 25 looked at me and said, well, told us he could take care of

- 1 it. He knows where everything is. So they said, yeah, yeah, no,
- 2 that's fine, so --
- 3 Q. They did their show.
- 4 A. They took inside. I went around the back. I
- 5 brought some of their clothing inside, handed over some bags to
- 6 Ardie, and I parked the car, shut the keys down.
- 7 O. Um-hum.
- 8 A. I wasn't missing the show. And gave me a
- 9 wristband.
- 10 Q. Nice.
- 11 A. And meanwhile, I notified the gentleman that brought the
- 12 slip over here, which his name is _____. ___l -- I had asked
- 13 him to grab the Sprinter because they needed more room on the way
- 14 back.
- 15 Q. Sure.
- A. And I wanted to give them comfort and I just, you know,
- 17 wanted to show them who Atlantic is.
- 18 Q. So when the show was going on was when the vehicles were
- 19 swapped out?
- 20 A. Yeah. Well, pretty much at the end of the show.
- 21 Q. All right.
- 22 A. He was texting me during the show, letting me know that
- 23 he was going to go get fuel and things like that. So I'm sitting
- 24 inside the show reading my texts.
- 25 Q. Okay.

- 1 A. I think there's about 5 minutes left, and the
- 2 entertainment director says, hey, your other vehicle is outside
- 3 and he's looking for you. I said, thank you.
- 4 Q. Okay.
- 5 A. We go outside.
- 6 Q. Right.
- 7 A. I get everything that I have inside the Suburban out.
- 8 We throw the trash away. Do a quick walk around the vehicle.
- 9 Tires, stuff like that, which is the normal stuff that I don't
- 10 want to be embarrassed about, you know, because that's the last
- 11 thing I want to hear is I brought a broken car to somebody. And I
- 12 set the satellite TV up so that it could be on something like --
- 13 you know, I think I set it up on Sports Center.
- 14 Q. Okay.
- 15 A. Go ahead.
- 16 Q. I was going to say, so after everyone was loaded and you
- 17 got under way --
- 18 A. Right.
- 19 Q. -- what time did you start your trip, your next leg of
- 20 your journey?
- 21 A. I want to say it was like quarter to 11, like 10:45.
- 22 Q. 10:45, you started back up?
- 23 A. Yep.
- Q. And then you were heading where?
- 25 A. Back to Cresskill, New York --

- 1 Q. Back to New Jersey?
- 2 A. -- New Jersey. I'm sorry.
- 3 Q. Back to New Jersey. Did anything else transportation
- 4 wise, vehicle wise happen during that period of time?
- 5 A. Well, we is another driver of ours.
- 6 O. Um-hum.
- 7 A. He lives literally 3 minutes from the Dover Downs. We
- 8 pretty much always keep a car with . So at that time, I was
- 9 going to turn it over to
 and introduce him and let take them
- 10 back up, but I was having a great time. A few of them said, are
- 11 you going back with us, and I said, yeah, I said, but I also have
- 12 another driver. And they said, oh, that's great, you know.
- So, and we were joking outside.

 came. I asked a
- 14 security guard where we could park our vehicle so that we wouldn't
- 15 get towed or anything because he had just a sedan.
- 16 Q. I see.
- 17 A. So parked the sedan that he just brought over from
- 18 home, and he asked if I -- if he wanted, you know, wanted me to
- 19 drive. And I said, no, I'll take over until we stop.
- 20 And we started up the road, and it started right from
- 21 where we left off. They peeked through the window and looked at
- 22 \blacksquare and accused \blacksquare of being the mafia hit man that they send out.
- 23 And they said, he looks like the dude that the mafia would hire to
- 24 send to kill you, you know. And I said, well, he is nicknamed the
- 25 undertaker, you know, and everybody laughed. And was just

- 1 beating him up big, big time.
- 2 Q. Um-hum.
- 3 A. So I said -- and I told \blacksquare that basically this is called
- 4 affection in the black community, I said, because if they didn't
- 5 like you, they wouldn't talk to you, you know.
- Q. Sure.
- 7 A. And so he was having a great time. We're riding up
- 8 there. They're talking about the show. Dover Downs loaded them
- 9 up with so much food because they didn't want nothing. They
- 10 didn't -- I mean, so and that -- and she did, she hugged me when
- 11 we were left and she said, I could not believe, that was the
- 12 easiest group of people I've ever dealt with.
- 13 Q. Good.
- A. And I said, they're amazing.
- 15 Q. So we're on our way back. Did you make any other
- 16 unscheduled stops or any scheduled stops --
- 17 A. Yep.
- 18 Q. -- before the accident?
- 19 A. Yep. I got over the Jersey Turnpike, I got between Exit
- 20 2 and 3, and I was told that Mr. needed to use the
- 21 bathroom.
- Q. Okay. And after you made that stop, you got back on the
- 23 Turnpike?
- 24 A. Yeah. I -- yeah, we got -- we made that stop.
- 25 Q. Do you know at approximately what time that was?

- 1 A. I think we're getting off the exit at like 12 -- between
- 2 like 11:50 and 12:10, we are between the exit and the Wawa that we
- 3 stopped at. We used the restroom. There were some drinks
- 4 purchased and I think some small, small amount of food like just,
- 5 you know -- and I kind of laughed at because he bought this
- 6 frickin' huge like Slurpee, Slushie.
- 7 Q. All right.
- A. And he looked like a little kid, just coming out happy
- 9 with his Slushie. And he -- they got in the car. We started
- 10 going up the road.
- Between Exit 4 and 5, I come up on the Walmart truck.
- 12 And I'm in the right lane, the Walmart truck's in the right lane,
- 13 and I see the Walmart truck wiggle. So I just keep an eye on it,
- 14 okay, and let it watch -- let it go.
- So and I'm like -- I look over to ■. I said, this dude
- 16 -- what's going on? And he wiggled again and this time with
- 17 nobody in front, and just us in back and a couple people that were
- 18 coming up on us to pass us. He went completely to the left, and
- 19 he -- when he did that, he recovered, and it was like that. And I
- 20 said, oh.
- 21 Q. A little zigzag.
- 22 A. And I said, oh, he scared the shit out of himself that
- 23 time. And usually what we always say in the truckers, you pull
- 24 cotton out of the seat when you do dumb shit like that, which is,
- 25 you know, you puckering your butt-hole.

- 1 Q. Right.
- 2 A. So I said, oh, he's up now.
- 3 Q. Right.
- A. And so we're -- I'm watching him -- go ahead, I'm sorry.
- DR. BECIC: Do you remember approximately what time that
- 6 was?
- 7 MR. GALE: That's got to be within 10 minutes.
- 8 MR. FOX: Yeah.
- 9 MR. : Ten minutes. I see him. I'm waiting for him
- 10 to signal. I'm staying behind him because I'm waiting for him to
- 11 signal that he's going to get back in the right lane because
- 12 there's nobody over there. And -- but he's straight, so I
- 13 continue to pass him on the right. Got up past him. You know, I
- 14 looked back. He was still maintaining his lane -- his control,
- 15 lane control. He stayed in the middle lane.
- I went up, and then I came up on some people that were
- 17 slow in the right lane and I moved in the middle lane. And the
- 18 last thing I remember doing is looking back, seeing, you know, his
- 19 lights fading away and -- but still straight, and I don't think I
- 20 never paid it another mind.
- Next thing you know, we're going up the road, maybe it's
- 22 another 5 minutes, and all is fine. I'm looking at my GPS. My
- 23 GPS says that I'll be at Tracy's house at 1:40, you know, 1:30,
- 24 something like that, 1:30, 1:40. And I was like, okay. And the
- 25 next thing you know I looked and I saw red lights.

- 1 And where I saw him was between 4 and 5, and maybe we
- 2 were passing 5. Now, I'm coming -- I'm between 8 and 8A.
- 3 BY MR. FOX:
- 4 Q. Okay.
- 5 A. And I see the lights, tail lights kind of at a pattern,
- 6 flickering back.
- 7 Q. So traffic is slowing?
- 8 A. Traffic is slowing. I'm doing from 60, I got plenty of
- 9 time. I pick up my phone and I see the map. And I can -- now I'm
- 10 looking at the size of the red in the -- in my map section, which
- 11 is telling me my traffic. And I'm like, ah, we got traffic. And
- 12 so Tracy's like, what, what, what's going on? I said, there's
- 13 traffic up front.
- Q. Could you tell why the traffic had slowed? Was there
- 15 anything --
- A. At that point, at that point, no. But when I looked at
- 17 my map, I saw that it was small. So I was like, well, shit, it's
- 18 not that big, you know.
- 19 Q. Temporary congestion?
- 20 A. Right. And I said, I said, so we're good. And I said,
- 21 I said, maybe 15 minutes. Then I looked to the right and I see a
- 22 sign that says two right lanes closing.
- 23 Q. Okay.
- A. So I see that sign. I'm like, oh, okay. And -- which
- 25 is the reason why I'm looking at more brake lights coming back in

- 1 the right lane.
- Q. Um-hum.
- 3 A. Now, right away, I know -- and my terminology is, I'm
- 4 going to funnel it. I'm going to funnel. I'm going to go to the
- 5 right lane --
- Q. Yes.
- 7 A. -- and I'm going to come over at the last minute with
- 8 all the construction --
- 9 O. Sure.
- 10 A. -- traffic to the left, rather than sit in the back and
- 11 keep going back, back, back, back. So I look right and
- 12 there's a car -- shew -- comes by. I look -- and I'm still
- 13 looking, there's a truck. And I'm leaned up like this, truck
- 14 comes by. So I'm like, cool, I'm good.
- 15 Q. Did you notice what truck that was? Just some kind of
- 16 -- a tractor-trailer?
- 17 A. Yeah, it was a tractor-trailer.
- 18 Q. Okay.
- 19 A. So the tractor-trailer comes by and I'm like, ah, I'm
- 20 good after the truck. Because I'm looking at headlights behind
- 21 him, there's no more headlights behind him. And it was like
- 22 trucks coming by, trucks coming by, trucks coming by, clear.
- 23 Boom. And I thought I hit a frickin' bomb or something. And I
- 24 just remember like reaching up and trying to figure out which way
- 25 was up and down, and it was like, lights out. There was so much

- 1 smoke that I thought we were on fire.
- 2 So I'm panicking. I get my seat belt off. I hear
- 3 next to me. He's rustling around. And I'm just attacking the
- 4 window. And I get the window broken out, I get Ed out. I see
- 5 we're on the side. I look at the vehicle. I run around it, and
- 6 there's like -- there's fluids leaking, but there's no flames.
- 7 So I hear everybody in there just screaming, and I
- 8 climbed up on the bus. Shit.
- 9 Q. Do you need a minute?
- 10 A. Climb up on the bus, and my window of the door -- I'm
- 11 trying to crank the door and I can't get it to budge. I yell down
- 12 to , ", hit the unlock button." I'm thinking maybe if it
- 13 unlocks, you know, it'll go.
- 14 Q. Is still in the vehicle?
- 15 A. What's that?
- 16 Q. Is \blacksquare still in the --
- 17 A. s outside the vehicle --
- 18 Q. Outside.
- 19 A. -- standing next to it. I'm on top of it --
- Q. I got you.
- 21 A. -- trying to get that out.
- 22 Q. Sure.
- 23 A. I'm still hearing , "Help me! Help me!" I
- 24 hear My arm's broke, you know, and I -- you know, and I --
- 25 that's pretty much all I hear is and and a lot of, oh,

- 1 you know, moaning and --
- 2 Q. Um-hum.
- 3 A. And so I -- the emergency window was blown out, so I go
- 4 back to the emergency window, but I can't see, I can just hear.
- 5 And I scream out, you know, give me a flashlight, somebody give me
- 6 a phone with a flashlight. And somebody hands me a little, small
- 7 light. And I go and look, and I look in there, but everybody's
- 8 down and too far away. I can't reach them. I got glass all over
- 9 me. So I'm -- I can't reach anybody. And I'm thinking, I may
- 10 mess somebody up worse trying to pull them up through this hole.
- 11 And I'm like looking at the Walmart truck, because I
- 12 remember a glare of it coming by in my peripheral. And I'm
- 13 standing there. I'm fucking screaming. I'm helpless and hopeless
- 14 and I'm like, what the fuck, Walmart; what the fuck?
- 15 Q. Um-hum.
- A. And I don't know if it was him outside of the vehicle,
- 17 but I saw somebody standing near the vehicle. And I'm just
- 18 screaming, what the fuck. And like, Ty, the divider, we'll
- 19 get them from the divider. And I was like, oh, you know, which
- 20 he's at my seat, so my driver's seat is on the ground.
- Q. Right.
- 22 A. And goes through the windshield that I broke out and,
- 23 but we couldn't get it -- we couldn't make it big enough. So
- 24 somebody came over with an axe and we're beating it, you know,
- 25 breaking some of it away, but it's -- it feels like we're just,

- 1 you know, the hole's this big, and we got a cup. And we're trying
- 2 to -- and I couldn't make any progress. We tried to kick it. And
- 3 we're still hearing them screaming, help. And I was glad that
- 4 they were at least screaming and they were vocal.
- 5 Q. Right.
- A. Never, never heard . And this dude comes over and
- 7 he looked like he played for the frickin' Giants. And he's like
- 8 in the car with Ed and he -- my hands are hurting me like I can't
- 9 beat anything anymore. My hands are killing me. And he's ripping
- 10 shit out of the car and he's just throwing it out of the car.
- And next thing you know, I see him and have
- 12 And face is bust -- it's like -- and I'm like, no, no, no.
- 14 put something on for his head and they're talking to him. And I
- 15 can see his leg was, was just, you know, and -- was just mangled
- 16 and -- or broken. And they're like, what's his name? And I'm
- 17 like, ah -- and I'm like, snap out. I'm like, I'm like, that's
- 18 I'm like, I'm like, And I'm -- and I see him like,
- 19 you know, jump, like his eyes moving.
- 20 Q. Um-hum.
- 21 A. And they're like, keep saying his name, keep saying --
- 22 and I'm like, And I'm screaming his name, and they seem
- 23 like they were -- and I think, from what I heard, is one of the
- 24 ladies was a nurse. So I think that was the lady that kept
- 25 telling me to say his name.

- 1 Q. Um-hum.
- A. So they're doing the same thing: "All right,
- 4 they're still kicking shit out, and we're like wondering, where
- 5 the hell is anybody?
- 6 O. Of course.
- 7 A. And I'm, you know -- so I see come out. And
- 8 comes out and he -- he's laid down, but he's, he's good.
- 9 He's like -- I'm like, oh, shit, he's like the best out of -- so
- 10 far. I mean, I'm like, other than me and Ed. I'm like, I'm like,
- 11 Harris. And he says, hey. And he saw me walking, so he was like,
- 12 you all right, man? And he went to get me, and I'm like no, just,
- 13 you know, lay back, lay back and we --
- Q. Was he still in the vehicle?
- 15 A. No, he's out and laying next to -- so shere, and
- 16 he's kind of like staggered, laying next to ____. And it was
- 17 like he wanted to get up, and I'm like, no, no, just stay
- 18 down, just stay down, we got you. We got to get everybody out of
- 19 the vehicle. So he's laying down and laying back. And I think
- 20 his clothes were ripped off. And then he just started kind of
- 21 shaking. And I was like, aw, shit, you know, and I called over.
- 22 And then people came and they're trying to help him. By then, I
- 23 think, EMT were on the scene.
- Q. Um-hum.
- 25 A. And the first thing they do is they go to the back of

- 1 the vehicle, where it was hit, and they start -- and I'm like, you
- 2 can't go that way. You know, you got to go up the front, you
- 3 know. And the guy's like, no, no, just get out of the way. I
- 4 said, no, I own the vehicle. There's a wall there. There's a
- 5 bench there. There's a refrigerator there underneath the seat.
- 6 It's blocked, you know.
- No, no, we're going to cut it, we're going to cut it.
- 8 And me and are just looking at each other like, there's a lot
- 9 of shit there. I knew from the view that I had above that
- 10 everything was compacted in that area. The wall was still intact.
- 11 So after you go through the doors, now you got a wall to go
- 12 through.
- 13 Q. Sure.
- A. And I'm like, we're up front. We're getting people out
- 15 the front. So I don't know how much time they spent back there,
- 16 but finally they brought something along to cut the windshield out
- 17 of the vehicle. And now you got room, and the TVs are coming out,
- 18 the dividers are -- I mean, all the big pieces are coming out now
- 19 that we can move. Seats, I believe, come out.
- 20 And now comes out, you know. And I see and
- 21 they're holding the back of shead with -- to kind of
- 22 compress, I guess, the blood. And -- but he's moving, and I'm
- 23 feeling better that he's moving.
- Q. Um-hum.
- 25 A. So I'm like, all right, you know. And then comes

- 1 out and I see sarm is all messed up. And I thought I saw
- 2 like a piece of his bone out of his arm. And I'm like -- but he's
- 3 moving. He's kind of like, you know, trying to move, and I'm
- 4 thinking, okay, you know, we're doing good, everybody -- we're
- 5 hurt, we're beat up, but we're doing this, you know.
- And they keep going back in. And then the first thing I
- 7 do is I see shoes, and was the only one I didn't see
- 8 move.
- 9 O. Um-hum.
- 10 A. And I looked -- well, I look, and they're coming out --
- 11 well, they're coming out head first. But I looked at his shoes,
- 12 and I'm like, you know, seeing him coming out. Then I turn and I
- 13 look at his head and I see his neck, and his neck looks like it's
- 14 huge.
- 15 Q. Right.
- A. And so I'm like, ____, no, no, and I'm just screaming.
- 17 And I said -- I was like, no, no, ____. And I'm thinking I can
- 18 do the same thing with equal e, you know, and he's going to just pop
- 19 out of it. So the guy goes and he puts a mask on him. And I'm
- 20 like, okay, , come on; come on, . And then I just see
- 21 blood like just kick out of his mouth and -- and I'm like, he
- 22 never moved. He never moved, you know. And I'm like, you know,
- 23 shit. And I, I was just done at that point. I just, you know --
- 25 Q. Um-hum.

- 1 A. And I'm praying we don't lose anybody else. And I'm
- 2 giving -- you know, the cops are asking me for anything I have.
- 3 And I'm like, dude, I got -- you know, I came out of the frickin'
- 4 car with just, just what I got. Everything that I have is in that
- 5 car, you know. I don't have -- and I think we found, I think
- 6 found the registration and insurance card to give them.
- 7 And you know, and was doing, you know, you know,
- 8 scrounging and trying to get something. There was a phone -- he
- 9 found another iPhone. He thought it was his because it was the
- 10 same style. He doesn't know it was his because it was smashed. I
- 11 didn't have my phone. I was looking for my phone. I kept calling
- 12 her with every phone that anybody had on the scene.
- And she thought I was just a drunk on Friday night
- 14 calling her for a ride home. So, you know, she ignored it,
- 15 because she didn't recognize the number.
- 16 Q. Of course.
- 17 A. And, you know, and -- so, you know, I got, I got rage.
- 18 You know, at that point I -- all I thought about was just ripping
- 19 that dude a new asshole in that Walmart truck, you know. And
- 20 then, you know, I got a little bit of a compassion for being a
- 21 trucker. I know what it's like to try and take care of your
- 22 family, you know, and I get it. And then, I'm like, fuck that. I
- 23 interviewed for Walmart. I got friends that work for Walmart.
- 24 Walmart's one of the best frickin' trucking jobs you can ever get.
- 25 There's no truckers that get paid to go to sleep. Walmart takes

- 1 care of their drivers.
- 2 Q. Right.
- 3 A. So my compassion left again and I got pissed. And I'm
- 4 at the truck -- the police station, and I'm like -- I'm there with
- 5 everybody that was helping on the scene. The gentleman that I
- 6 told you looked like the football player, he's covered in blood.
- 7 And I'm like, dude, are you all right? And he's like, no, it's
- 8 just -- it's everybody else's blood. I was like, shit, you know.
- 9 And so we're sitting there, and we're like -- I kept
- 10 saying, I'm going to wake up and I'm going to be in my bed and I'm
- 11 going to smell my wife cooking bacon.
- 12 Q. Yeah, it's going to be a dream.
- 13 A. I'm like this has got to be, you know --
- Q. Sure. If I could go back to just prior to the impact.
- 15 A. Right.
- Q. Can you remember seeing any kind of -- you know, did you
- 17 look in your -- were you able to look in your mirrors and see the
- 18 truck coming or --
- 19 A. No.
- 20 Q. -- could you see anything like that?
- 21 A. No. I don't have anything for directly behind me
- 22 because of the divider and everything.
- Q. Right.
- A. So all I could see was out of my right mirror. And I'm
- 25 checking the right lane because that's where I want to go. Even

- 1 when I'm looking into the right lane, I don't see anything normal
- 2 -- you know, out of normal. Like I don't see, like I don't see
- 3 anything -- but I'm turning right. You know, I mean, I'm already
- 4 turning right to get over there. I've already made my move. And
- 5 that's the thing that I keep playing like in my head. I'm like,
- 6 did I hear the screeching brakes? Like, do I hear that o-o-o-o,
- 7 you know, when they're all locking up and skidding.
- 8 Q. Um-hum.
- 9 A. And I'm like, I don't hear that. And then I'm
- 10 remembering the velocity at which we were tossed. And, I mean --
- 11 and when I saw it go by, it went by like, shew, like a train. It
- 12 went by like a frickin' freight train. It was like I parked on
- 13 the damn train tracks and with no sign, nothing, the train just
- 14 shoom, kicked my ass.
- And so, you know, and I'm sitting in there and I'm just
- 16 playing back this video that keeps going on in my head. And I'm
- 17 like, you know what -- and I'm like, the truck's straight, you
- 18 know. I know when you're loaded and you slam on those brakes, you
- 19 jack the trailer -- or the tractor.
- 20 Q. Um-hum.
- 21 A. And I know when you're empty, that frickin' trailer
- 22 starts coming around, because it comes on your kingpin and now the
- 23 weight -- so it's going to go either left or right. And I'm just
- 24 sitting there thinking -- you know, now I got a little bit of
- 25 survivor guilt. I got a little bit of like, what the fuck could I

- 1 have done different? Could I have called 911 when I saw this
- 2 asshole -- you know what I mean?
- 3 Q. Were you hurt in the accident?
- A. I was limping on the scene. I'm still stiff and, you
- 5 know, but --
- 6 Q. Did you have any injuries?
- 7 A. Just other than a couple cuts and blood and bruises, no.
- 8 I mean, I didn't, I didn't --
- 9 Q. Were you transported to the hospital?
- 10 A. No. I -- honestly, when -- all I wanted to do is make
- 11 sure they were taken care of. And me and Ed were pretty much, you
- 12 know, walking, talking, not bleeding, and I just said, take care
- 13 of them, we're fine. We got checked out.
- Q. Were you treated then, at the scene?
- 15 A. We were treated at the police station when the cops took
- 16 us. And I think that the EMT mistakened us for the people that
- 17 were helping. You know, they didn't know we were actually in the
- 18 car driving.
- 19 Q. I see. Okay, so --
- 20 A. So I'm up in the police station and the guy's like, look
- 21 -- I said, look, I got to make a phone call. I got to call, you
- 22 know -- I said, whenever you're done with me, I'm still 3 hours
- 23 away, so I'd like to let somebody know what's going on and -- you
- 24 know, every cop has a phone. Nobody wants to give up their phone.
- 25 I'm like, it's going to take 2 minutes, you know.

And so I see one guy outside. When I walked outside, I

- 2 said, you know, can I use your phone? And he says, well, just let
- 3 the guy know inside there. And he's like, well, who are you? And
- 4 I'm like, well, I'm the driver of the limo. He's like, anybody
- 5 check you out? I'm like, no, you know. So and -- so he says,
- 6 look, go in there, talk to them, tell them you need to make a
- 7 phone call.
- 8 And then I, I tell them what I -- I say, here's my
- 9 driver's list, and I'm trying to get in touch with this guy here,
- 10 Russ, you know. Because I know he's the closest to my wife and he
- 11 could come to the house. And so they make the phone call to Russ.
- 12 EMT comes in, checks us out. I got glass crap in my
- 13 hair, you know. I got little small cuts. My hands are all cut
- 14 up. I'm limping. Like the back of my calf is sore. And that's,
- 15 you know, pretty much the extent of. I just want to get home to
- 16 my kids, you know, and I was just like, look.
- 17 So while I was there, you know, I'm expecting, okay, I
- 18 know the protocol, we're going to give some blood, we're going to
- 19 give some pee. Because I'm -- even though they're not saying it,
- 20 I already, in my head, I'm convinced that, you know, gone
- 21 and there's a death. And once I knew that the road was shut down,
- 22 that furthermore convinced me of that, because I know they're not
- 23 going to let anybody run over what is a scene where somebody died.
- So now -- but I can't get a cop to tell me that. I
- 25 can't get anybody else to confirm that. Little bit of hope, but

- 1 not much. And then I had an affiliate from Philadelphia. And so
- 2 I -- I'm talking to the people there and I'm telling them like,
- 3 look, you know. And they said, oh, I saw it, you know, I saw it.
- 4 And I'm like, all right, well, everybody's got statements. And I
- 5 said, you know, I'm just praying this dude tells the truth, you
- 6 know.
- 7 And then I'm asking the cops, like, are there highway
- 8 cameras? Because I know here in Delaware, I can check on DelDOT,
- 9 and I can check my drivers. And that's what I used to do before I
- 10 had the tracking system. You know, I'd track the time, you know,
- 11 the times where they're -- hey, where you at? Oh, I'm getting
- 12 ready to go along Route 1. All right, cool. And I'd start trying
- 13 to look at the cameras see if I could find them, so --
- 14 Q. Sure.
- 15 A. So I can't -- you know, I'm waiting. He's like, oh,
- 16 we're going to interview you, we're going to do all this. And I'm
- 17 like, okay. And they come out and they said, hey, everybody take
- 18 a statement, write it down, and then we're done. So when I, when
- 19 I knew that, I was kind of like, okay, he fucking told the truth.
- 20 Thank God. You know?
- 21 O. Um-hum.
- 22 A. And I -- because, at that point -- because there was a
- 23 little bit of a point where like I -- some people were treating me
- 24 like I could have been a problem. And I was like, you know, I,
- 25 you know, I didn't do shit, you know. I was just coasting along

- 1 with traffic. I seen it. You know, I know who I got in the car.
- 2 You know, there's no Superman, Batman, any type of crap going to
- 3 happen with me.
- 4 Q. Going back to just before the collision, as you just
- 5 said, you were coasting along, can you recall about how fast you
- 6 were going? Were you --
- 7 A. I don't think I was -- I remember the last time I
- 8 checked my speedometer, I was at like 10.
- 9 Q. Ten. So were you on the brake, or going on and off the
- 10 brake or like your foot not even on the gas pedal, maybe, or --
- 11 A. I think I was just kind of like idling down and
- 12 covering. Because I usually, the way I drive, I kind of brake
- 13 down with the accelerator and cover the brake --
- 14 Q. Yes.
- 15 A. -- because I don't want that --
- 16 Q. Yes.
- 17 A. -- you know, reaction. So the first thing that I always
- 18 normally do before I hit brake is let up off the accelerator, let
- 19 it coast. So I'm kind of covering. Which is another reason why,
- 20 when I train the limo drivers, if they tell me their calf muscle
- 21 hurt, I know they're driving right. You know, me and her used to
- 22 always laugh about it.
- 23 Q. Earlier we were discussing that you have a GPS program.
- 24 Do you think your GPS program would show us what you were -- when
- 25 you -- or how fast you were going?

- 1 A. Well, I looked at it, and it's the last calling that I
- 2 -- the last thing that -- it says 60, 40 and 4.
- 3 Q. Okay.
- 4 A. So I want to -- I don't know exactly what the increments
- 5 are, when they do drop the flag, but I want to say it's between 3
- 6 and 5 minutes, you know.
- 7 Q. Okay. Perhaps you can print that out for us?
- 8 A. That's the thing I can't do because I don't pay for that
- 9 ability.
- 10 Q. Oh, I see.
- 11 A. So Omni like have to be --
- 12 DR. BECIC: We have their information, so we'll have to
- 13 contact them. So my understanding is they track everything and
- 14 they track in increments, which are probably maybe five times per
- 15 second. But depending on the service they provide to you, they
- 16 only release certain information to you.
- 17 MR. Right, right. So I can pay -- right now I'm
- 18 on a program paying \$80 a year.
- 19 DR. BECIC: Um-hum.
- 20 MR. I own the equipment. And I pay \$80 a year.
- 21 But the more information I want, it could go from \$30 a month to
- 22 \$60 a month.
- MR. FOX: Okay.
- 24 MR. So I just -- you know, having 14 units,
- 25 wanting all 14 done, you know, we just did -- we just budgeted the

- 1 best way that -- and I think the way that we did it was pretty
- 2 efficient because it's not -- I seen other companies, like Fleet,
- 3 Flight Time, there's 40 vehicles on one map.
- 4 DR. FOX: Okay.
- 5 MR. And it looks like --
- 6 MR. FOX: Yeah.
- 7 MR. -- spaghetti.
- 8 MR. FOX: Ensar, did you have any other follow-up
- 9 questions regarding the accident?
- 10 BY DR. BECIC:
- 11 Q. Yes. Do you recall just prior to the collision, when
- 12 was the last time you spoke or you heard the passengers in the
- 13 back?
- 14 A. The last time was when I -- when I noticed, oh, shit,
- 15 we're slowing down; damn it, you know. Because I didn't expect it
- 16 on the northbound side. I knew about it on the southbound side.
- 17 So basically what I experienced and went around on the southbound
- 18 side, I'm expecting it, at first visual, to be as bad. And I'm
- 19 like, damn, I didn't pay attention to my tracker before the exit,
- 20 you know, so that I -- if I needed to go around, I could have went
- 21 around.
- 22 Q. Okay.
- 23 A. So the first instinct was to look at my phone, see how
- 24 big it was. When I was coming down from house, hell, it
- 25 was like 2 inches long on the -- which, I knew it was long, on my

- 1 phone. This time it was like not even --
- 2 Q. Okay.
- 3 A. -- a blip on the screen.
- Q. So that was maybe 2, 3 minutes prior to impact?
- 5 A. Yeah. I would say the last conversation we had -- I
- 6 mean, there was constant talk through the window up until about
- 7 maybe 15 seconds.
- Q. Okay.
- 9 A. You know? Because they were like, so we going to be all
- 10 right? And I'm like, yeah. I said, it's not that long. We're
- 11 going to be all right, you know.
- MR. FOX: Sure.
- DR. BECIC: Okay.
- 14 MR. MR. And yeah, and I just -- you know.
- 15 BY MR. FOX:
- 16 Q. Is there anything else -- well, I forgot to ask you
- 17 about your vehicle. Was the van handling okay? Was there any
- 18 issues with your van?
- 19 A. The van was beautiful.
- Q. The van was fine.
- 21 A. Yup.
- Q. And is there any item or discussion that we have not had
- 23 about the accident that you can recall, that stands out, that we
- 24 have not asked any questions about?
- 25 A. You know, I guess for me, the biggest question I was

- 1 waiting to hear, if I heard anything about any brakes or any
- 2 screeching tires or anything like that, and there were none. So
- 3 that's -- none. Absolutely none. The sound was almost like
- 4 sitting next to a highway, and you hear the shew of the car, you
- 5 know.
- 6 Q. Um-hum.
- 7 A. And I keep playing that like -- there was no, you know,
- 8 no brakes skipping, you know, on the highway. It was just a
- 9 vehicle moving, you know. And then I, and then that -- so, you
- 10 know, that's -- all I been doing is kind of going over myself like
- 11 did I have enough time to call the police, you know? Did I expect
- 12 this guy to -- you know, in my own head, did I think this guy was
- 13 going to come back and pretty much have this like -- no, I went by
- 14 this guy believing that that two increments that I saw him shake
- 15 up in a minute and a half time, that, you know -- and I've been in
- 16 a situation where it's like, you know, 20 cups of coffee, like,
- 17 oh, shit. You know, next rest area, it's a wrap, you know, I'm
- 18 going down.
- 19 Q. Right.
- 20 A. Whether it's for 15 minutes or what. So when I saw him
- 21 maintaining lane control, you know, I was good. I wasn't even
- 22 going to pass him --
- 23 O. Sure.
- 24 A. -- until I knew that the lane control was there. Once I
- 25 went past him, I mean, I checked my rear view maybe -- not my rear

- 1 view -- my side mirrors, three, four times maybe on him, you know,
- 2 and we were spacing apart.
- 3 MR. FOX: Ensar, did you have another question?
- 4 BY DR. BECIC:
- 5 Q. A quick one. You mentioned that you were planning to
- 6 move into the right-hand lane and you were just about to do so.
- 7 Do you remember the direction your vehicle was facing at the time
- 8 of the impact?
- 9 A. When I -- I think I'm like -- if I was able to get
- 10 anything in the right lane --
- 11 Q. Um-hum.
- 12 A. -- I'm thinking maybe like my headlight was like ready
- 13 to --
- Q. Okay. So you were not --
- 15 A. Not straight.
- 16 Q. -- straight. Okay.
- 17 A. No. No. No. So I'm -- and like I said, I'm ready with
- 18 the wheel, you know, ready to go --
- MR. FOX: Make a lane change.
- 20 MR. Right. So and I -- you know, like I said, I
- 21 remember one time I looked back, shew, you know, a car came by
- 22 pretty quick, you know, rushing up the right lane. I saw the
- 23 truck. Wasn't going to try and, you know, beat him to the lane.
- 24 Let him go. And then -- you know. And then that was that, I
- 25 mean.

- 1 MR. FOX: Anything else?
- 2 DR. BECIC: No.
- 3 BY MR. FOX:
- 4 Q. I think that these are all the questions that we have at
- 5 this time.
- 6 A. Okay.
- 7 Q. Is there anything else you want to add to the
- 8 conversation?
- 9 A. I think, you know, for me, the overall demeanor of the
- 10 driver bringing in the police station, it disgusted me because it
- 11 looked like he didn't care. And that just really pissed me off.
- 12 You know, I looked at him trying to make eye contact, you know,
- 13 and he just, you know, wouldn't look at anybody. And I just --
- 14 you know, and I put myself there. I'm apologizing to somebody.
- 15 know there's quote/unquote politics involved when there's a big
- 16 accident and your company tells you don't speak to nobody.
- 17 Q. Um-hum.
- 18 A. But there's got to be some kind of remorseful feeling,
- 19 you know, in here. So, you know, I was disgusted by that. I
- 20 remember thinking that all the way home in the car, you know, that
- 21 -- you know, how the hell could you do something like this and be
- 22 involved in something like this and not even like give a shit.
- 23 Like, not even want to go up to 18 people, you know, I'm sorry
- 24 this happened.
- 25 Q. Um-hum.

- 1 A. Not admitting fault. Not admitting guilt. Like what
- 2 happened, I'm sorry -- something. Something. And there was
- 3 nothing, was nothing. And I think the -- I think my body language
- 4 was evident enough that a couple of the officers removed him. And
- 5 then, you know, it's -- everything I, everything I see in here, it
- 6 kind of adds up, like, you know, that we're definitely two
- 7 different types of guys.
- 8 Q. Thank you.
- 9 A. Um-hum.
- 10 Q. We appreciate your time today, sir.
- 11 A. And I appreciate yours.
- 12 Q. And we thank you for your cooperation. And if you have
- 13 nothing else to add, we're going to conclude the interview at this
- 14 time. And the time now is 6:12 p.m.
- (Whereupon, at 6:12 p.m., the interview was concluded.)
