Mr. Hussain,

Please be advised that a vehicle registered to you was found with a valid registration. The vehicle, VIN: 1FMNU40S51EB shows a registration as an 11 passenger Ford. This vehicle if used to transport passengers for compensation would require NYSDOT Authority. Your operations do not currently have NYSDOT Authority and your company will be subject to enforcement action if found to be transporting passengers for compensation in this vehicle.

There is also a disconnect from the seating capacity listed for the vehicle and seating capacity previously listed for the vehicle. We have previously seen this vehicle as being manufactured as an 18 passenger vehicle. If this is correct this would require the vehicle/driver to comply with having a USDOT number, CDLs, drug and alcohol testing and the company would need to comply with commercial motor vehicle requirements if using the vehicle if furtherance of any commercial enterprise.

If you have any further questions about the processing of your NYSDOT Authority you can contact Main Division (518) 457-7602.

NYSDOT requirements:

The transportation of passenger in a for hire capacity within New York State in vehicles with a seating capacity of more than 10 passengers including the driver generally requires a NYSDOT Certificate of Authority (or NYSDOT Authority). You can find more information about authority and applications at the weblink below: www.dot.ny.gov/divisions/operating/osss/bus/passenger

If you operate NYSDOT regulated vehicles, those vehicles will require a NYSDOT Bus Inspection. These will be required before your certificate to operate from NYSDOT is granted. More information on bus inspections and what is required can be found here:

www.dot.ny.gov/divisions/operating/osss/bus/inspection

If you operate NYSDOT regulated vehicles, NYSDMV requires that you only utilize 19A Certified drivers. This would generally require drivers to have a minimum of a CDL class "C" with a passenger endorsement. More information on the 19A bus driver certification process can be found here:

Federal Requirements:

If you are operating vehicles for compensation with a passenger capacity of 8 passengers or more (including the driver), you will have to fully comply with federal regulations. 
