CREW WILL BE ASSIGNED FIRE WATCHES TO INSURE FIRE DOESN'T REIGNITE. WHEEL MAN WILL CALL THE OFFICE AND SAY THIS IS A PRIORITY CALL I HAVE AN EMERGENCY AND NEED TO SPEAK TO THE PORT CAPTAIN ON CALL.

ALL VESSELS IN THE AREA WILL BE NOTIFIED ALONG WITH COAST GUARD OR ANY OTHER PERSONS OR AGENCIES INVOLVED OF SITUATION STATUS.

ALL PROPER REPORTING WILL BE COMPLETED BY WHEEL MAN AND CREW .. WHEEL MAN WILL WAIT FOR GO NO GO FROM THE PORT CAPTAIN OR OFFICE PERSONNEL.
