4	Harley. I'm an investigator with the National Transportation
5	Safety Board. Today is April 4th of 2023. It's 2:18 p.m. I'm
б	located at the West Reading Volunteer Fire Department located at
7	223 Playground Drive in West Reading, Pennsylvania.
8	And we are here today to talk about the explosion at the R.M.
9	Palmer Candy Company that occurred on the 24th at around
10	somewhere around 4:50 p.m.
11	And, gentlemen, I'm going to ask you to identify yourselves
12	for the tape.
13	CHIEF MOYER: I'm Fire Chief Chad Moyer.
14	LT. GUIDINAS: And I'm Lieutenant Andy Guidinas.
15	INTERVIEW OF CHAD MOYER & ANDY GUIDINAS
16	MS. HARLEY: Okay. All right. So, gentlemen, as we said
17	before, what I'd like you to do is kind of sort of walk me through
18	and you can do it one at a time, walk me through when the call
19	came out or when you first became aware of the incident and just
20	walk me through what you saw and what you did that day. Chief,
21	you want to start.
22	CHIEF MOYER: Yeah. So I was at Mama's Pizza getting some
23	dinner with my wife at Wyomissing when the call came out. We were
24	on our way to the bowling alley. So at that point, when I heard
25	some of the additional that was coming in, stopped eating, and I

started responding. Now, I had my wife's vehicle. So, I didn't have lights and siren. So it took me some time to get to the scene. So chronologically, this is going to be off a little bit because Andy had arrived before me.

So once I arrived at the scene, there were already rescue 5 6 operations that had taken place. There was already fire 7 extinguishment operations that were taking place. I spoke briefly with Andy about what he had because he was the first arriving 8 9 officer from West Reading. Spoke briefly about what he had done or had going to that point, and then my biggest concern at that 10 11 point, I could still smell gas in the street. So my biggest 12 concern at that point was making sure that we had the gas secured 13 and if we also had gas building up in the remaining Palmer 14 Building.

At that point I believe I sent Andy -- and I forget who you might have had with you.

17 LT. GUIDINAS: Bruce, Donna and Ashland (ph.) and the A team 18 crew.

19 CHIEF MOYER: To check on the conditions in Building 1 to 20 see, A, if they had gas and, B, if they had any fire that had 21 extended. They did report an odor to me, and they also reported 22 some fire that was -- I'll let him explain to you how it looked, 23 but he did report some fire in the basement to me.

Later, I talked to I believe it was Larry Moyer from the City. He was the person who was communicating with UGI about

getting the utilities shut down. From what I understand from him, 1 they did initially shut two valves down, but that didn't 2 3 necessarily stop the gas release. So they had to go to secondary valves at least on the one side, possibly both side to shut them 4 down. He didn't say that they gave him any problems at all 5 6 working with them. They seemed like they were working diligently 7 to get the gas shut off for us. At one point, they did report that they did have it shut down, but it would, it would take a 8 9 little bit of time for the 3,000 feet of pipe they said to bleed 10 off the remaining gas.

11 So, while all that was going on, the West Reading Police 12 Department was working with Palmer staff to figure out how many 13 people they were missing. I didn't deal directly with the Palmer 14 staff. So I don't know how cooperative they were, but the police 15 did not make any comments that they were uncooperative or anything 16 like that.

17 They came back. There was some flux throughout the period 18 of, you know, rescue. There was a little bit of fluctuation. 19 Obviously it was a very chaotic event until they were figuring out 20 who they were missing. Some people had -- I believe there were 21 three people who went to the hospital, walking wounded, that were transported by EMS. So there was some time until they were able 22 23 to figure out exactly how many people we were missing, but it was 24 eventually determined that it was eight.

MS. HARLEY: Okay. And, so just to clarify. When you got on

1	the scene, the fire in Building 2, Building 2 was still on fire.
2	Is that correct?
3	CHIEF MOYER: The rubble pile was still on fire, yes.
4	MS. HARLEY: Right. Okay. All right. Do you have some
5	sense of how long it took before they were able to before you
6	guys got the fire extinguished?
7	CHIEF MOYER: Without checking the recordings on the tape, I
8	don't know.
9	MS. HARLEY: Okay.
10	CHIEF MOYER: My timeframe for that evening is a little
11	evening it little bit skewed.
12	MS. HARLEY: Okay. Not a problem. Lieutenant, what can you
13	tell me?
14	LT. GUIDINAS: So, much like Chad, we are volunteer. I was
15	at home when I heard the explosion. I live literally a block
16	away. I didn't know what it was, but I knew we were going
17	somewhere. So I got dressed, started heading down. By the time I
18	hit the street, the pagers had gone off, made it down here. I was
19	driver only on the apparatus. I know 79 and 85 run straight. I
20	was unaware at the time that the City was operating and had
21	already been on scene. When I had gone responding, I didn't get
22	additional. I think I was the only one not to get additional. So
23	I honestly didn't know exactly what I was going into until I
24	turned onto 2nd Avenue. And then as soon as I saw, I called for a
25	second alarm.

Ladder 79 was coming down Franklin Street. When we met at the intersection, I flagged them to go through because I was driver only, and I put their crew to work immediately with the chief to work on rescue of the individual that they had found trapped.

6 There were some folks that were walking wounded. Two victims 7 were laying on the pavement on the adjacent side across the street. At that time, there was a strong odor of gas. We opened 8 9 up the man door like I had said on that, the A.D. [sic] Palmer, 10 and it was that thick that I had to close the door. It made my 11 eyes water, and then when Chad had asked later if there was an 12 odor of gas, it was still there but not nearly as bad as it was 13 previously.

14 CHIEF MOYER: Let me interject one thing that I saw in the 15 CAD was that Andy had called dispatch and asked them to have Met-16 Ed shut the grid down.

17 LT. GUIDINAS: Yes. So they weren't sure if it was Med-Ed or 18 PP&L, but they asked if they could deliver a remote shutdown, and 19 I said -- well, obviously said yes. And I know the City had 20 already done it, prior to me asking for it, but I also asked for 21 UGI as well.

22

MS. HARLEY: Okay.

LT. GUIDINAS: Originally when I pulled up, the fire conditions seemed manageable with a couple of master streams and maybe some, you know, maybe a 2 1/2, 3 inch, just to keep it in

check, but that rapidly changed to the point where me and Clane (ph.) and Finch went over the roof of the 5 story.

MS. HARLEY: Okay.

4 LT. GUIDINAS: I met up with Chief Moyer, and we kind of got 5 the game plan together that we'd set up a command post. 6 Originally it was going to be at 2nd and Penn to get kind of an 7 overview but that kind of migrated down to, you know, like Cherry 8 Street section so we could actually see the full area we were 9 working with. Again, by the time I got there, the building was 10 down to maybe a 15 foot pile of rubble.

As far as accountability, I had not made contact with anyone from Palmer's. However, in the same account was the employees or workers that we had come in contact with had a rough estimate of 10 people that were unaccounted for, and that's why I called for the level 2 MCI. So 2 would be up to 10 patients. I figured 10 missing and go from there but obviously that was confirmed with better guesstimates after the fact.

I asked for a drone right away from A team. They went en route relatively quickly, and I asked to suspend rail traffic. After that, it was just a matter of resources coming in, waiting until we had sufficient manpower to really do anything about it. The only thing I was mainly focused on was the rescue that was taking place, well, what would be the D corner there, and they were working hard on it.

CHIEF MOYER: But it was determined that there was

4	work right away because I thought it was the deceased they were
5	talking about, and when they said, no, the guy was underneath the

7	it. I had the Engine 42 was in next to arrive. I had them
8	stretch a long line and get the master stream off of Ladder 64 in
9	place to try and protect those guys. Up until that point, they
10	were operating without any hose lines in place.
11	MS. HARLEY: Okay.
12	LT. GUIDINAS: There's actually a photo floating around with
13	them starting to get that in place.
14	CHIEF MOYER: The City units had gone right to work rescuing
15	people in the apartment building.
16	LT. GUIDINAS: In the apartment building.
17	MS. HARLEY: Okay.
18	LT. GUIDINAS: So the apartment building attached to the
19	bank, former bank. Now, I guess it's a church,
20	CHIEF MOYER: Yeah.
21	LT. GUIDINAS: There were that was occupied. Half of that
22	was occupied. They, I think pulled five out of there, whether it
23	be walking wounded or off the aerial on ground matters. I
24	actually did the secondary in there to make sure it was clear.
25	That was after the fact though.

1 CHIEF MOYER: Because I believe the internal stairs were damaged here --2 3 LT. GUIDINAS: Yeah. 4 CHIEF MOYER: -- and the fire escape was damaged --5 LT. GUIDINAS: The fire escape was --6 CHIEF MOYER: -- was blocked by rubble. 7 Yeah. As far as the 5 story, when I -- when LT. GUIDINAS: we first pulled up, so it was Ladder 79 and me right behind them, 8 9 there were still employees coming out of that man door which I 10 can't believe how they were doing it because I couldn't even look 11 in there for a second. It was thick. 12 MS. HARLEY: And that's the odor of gas. 13 LT. GUIDINAS: Yeah. 14 MS. HARLEY: Okay. 15 LT. GUIDINAS: So after that, it was just until we got enough 16 resources and manpower to actually put kind of an effort into it. 17 I sent Ken Hurst (ph.), so Engine 69 and their chief and City 18 Engine 3 to the trolley side to start with master streams as well, 19 and trying to protect the guys in the rescue operation. In doing 20 so, they came across an employee that was in the building at the 21 time, and they were ambulatory. So I told them to direct them up to the front of Ladder 79, and that who we used to get a 22 23 guesstimate headcount as to how many people were unaccounted for. 24 MS. HARLEY: Okay. There are a couple of things I want to 25 So they -- so you're saying they actually found an ask you.

1 employee still in the building. 2 LT. GUIDINAS: So they came across an employee. I can't say 3 for sure because it was just a radio transmission. 4 MS. HARLEY: Um-hum. 5 LT. GUIDINAS: But he came across an employee that said he 6 was in the building. 7 MS. HARLEY: Oh, okay. All right. Okay. He said he was in 8 the building. 9 LT. GUIDINAS: Yeah. Now, there was multiple doors in that 10 side of the building they could have came out of. 11 MS. HARLEY: And what side are we looking at? 12 LT. GUIDINAS: So it would be --13 CHIEF MOYER: You say the building. Are you about 14 Building --15 LT. GUIDINAS: The 5 story. 16 CHIEF MOYER: -- 2? The 5 story. 17 LT. GUIDINAS: Yeah. 18 MS. HARLEY: Yeah. Okay. And what side you said this was? 19 LT. GUIDINAS: So it would be the Charlie side of --20 MS. HARLEY: Okay. 21 LT. GUIDINAS: -- Building 2. However, he was working in the 22 5 story which would have been, you know, that B side in the C 23 corner. 24 MS. HARLEY: Got it. I see. Okay. 1 was the situation with the gas involving the rescuers and the gentleman that was trapped under the rubble --2 3 LT. GUIDINAS: Yes. MS. HARLEY: -- in the alleyway of Cherry Street that 4 5 everyone calls it. б LT. GUIDINAS: Right, the Cherry Street alley. 7 MS. HARLEY: Yeah. LT. GUIDINAS: So the reports that I got from the 79 crewmen 8 9 and their officer was that they were, they were literally with 10 hands and sledgehammers pulling stuff apart but I actually got 11 flash burn from a pocket of gas that ignited that was in the pile. 12 MS. HARLEY: Okay. All right. The other thing I wanted to 13 talk to you about is that when you did your secondary search of 14 the building, you said the 5-story building. Did --15 LT. GUIDINAS: I actually did the primary on that as well. 16 MS. HARLEY: You did primary. So, I want to talk to you --17 well, let's first talk about the -- while you were in the 18 basement, there was an issue with fire. 19 Yeah. So, initially the search crew had gone LT. GUIDINAS: 20 in and said they had a strong odor, and they had reported that 21 there was fire in the basement. They didn't really specify as to They just backed out because they had no safety line in 22 what. place. Once Chad and I did a face-to-face, I went to work and we 23 24 stretched a line down in the basement, and then we attempted to do 25 a primarily on all the floors. The captain from E Team started on

the first and worked up. We went down, because we knew we had the 1 line in place. When we went down, the interior stairs, there was 2 3 a service elevator, and then adjacent to it, like a mechanical --4 what looked like to me like a mechanical limb, and that was the chaseway between the two buildings underneath the street. 5 We 6 encountered what looks like a gas fed fire coming through the 7 conduit from underneath the street that extended about 6 to 8 feet into the building. At that point, we put a fog pattern in place 8 9 to kind of keep it in check. There was a bunch of us searching 10 the subdivision as we could, and I relayed that message to -- at 11 They called command, and Jeff answered and told that point. 12 anyone working above, you know, they had a fire below them. They 13 needed to be diligent of what they were doing. 14 MS. HARLEY: Okay. Awesome. 15 CHIEF MOYER: Yeah, Jeff was helping to catch messages 16 because I was trying to get the manpower pulled right in front of 17 Building 1 shifted down to the intersection of 2nd and Franklin. 18 So we all standing right there. 19 LT. GUIDINAS: And that as a bear, too. 20 Yeah, getting them to move back was --CHIEF MOYER: 21 MS. HARLEY: Okay. So I was wondering if you can now talk to me about what I'm interested in, is the layout of the building of 22 23 the building you identified as the 5-story building, and

24 specifically as far as the ability of employees to egress, if

25 there was any choke points, that kind of situation.

1	LT. GUIDINAS: The only choke point that I would be aware of
2	was on the third I believe it was the third division on the
3	what would be Delta side. And it was almost by design I guess.
4	It's a series of cabinets and machinery along a wall which created
5	about I would say maybe 2 foot space between the wall to make like
6	a walk point. It's not meant to be an egress point I would
7	imagine because there's wires and conduit and stuff going across
8	it, but that's what we had utilized going in with the engineers.
9	And even not under duress, we were kind of fumbling around in
10	there as well.
11	CHIEF MOYER: The engineers from the
12	LT. GUIDINAS: From the USAR.
13	CHIEF MOYER: USAR, yeah.
14	MS. HARLEY: Okay.
15	LT. GUIDINAS: We were checking the structural integrity on
16	it.
17	MS. HARLEY: Did anybody from the SAR team take photographs
18	of the interior of that building?
19	LT. GUIDINAS: I don't believe so, but I cannot say for sure.
20	I know there were sketches. I know they had initially set up a
21	transit from across the street to check movement. That would have
22	been a contact for them is Joe Dishler. He's their lead.
23	MS. HARLEY: Can you spell his last name?
24	LT. GUIDINAS: Yeah, D-i-s-h-l-e-r.

1 LT. GUIDINAS: And his engineer was with them. He would --2 it was the two of those guys that would have been the ones, if 3 any, that would have taken photos. 4 MS. HARLEY: Okay. 5 LT. GUIDINAS: I mean obviously the Bravo side was 6 compromised, and he stayed out of that what I'd call an 8 foot bay 7 if you would, between the pillars and the supported system in the area --8 9 CHIEF MOYER: Area on the boardwalk. 10 LT. GUIDINAS: Yeah. 11 MS. HARLEY: All right. 12 CHIEF MOYER: Something I don't think we've necessarily 13 talked about in this meeting today, too, was the fact that we 14 didn't recognize that there was structural damage to that north 15 wall --16 LT. GUIDINAS: Yeah. 17 CHIEF MOYER: -- and that working in that area was definitely 18 within the collapse zone. 19 LT. GUIDINAS: Yeah. And was it 21? Is Jeremy 21 or 20? 20 Not that it matters, but Jeremy Searfoss almost immediately said 21 he would do safety, and there was radio traffic as well where we were both looking at the 5 story, and he said it was compromised, 22 23 and that we needed to set up some kind of a collapse zone. But, 24 at that point, they were still working on rescue. So, yeah. 25 MS. HARLEY: Okay.

1 LT. GUIDINAS: While in the suppression phase, in the basement, the commander radioed in and said that -- that's when 2 3 they said UGI had secured the gas, and we went down to get eyes on 4 it, and that's when the fire was noted to be out. We knocked 5 whatever class A materials that were burning and then we backed 6 out. 7 MS. HARLEY: Okay. 8 LT. GUIDINAS: One thing I didn't notice in -- was that Rehr 9 that did the report? 10 CHIEF MOYER: Rehr, Tommy Rehr. 11 LT. GUIDINAS: Yeah. One thing I didn't note in there was 12 that there is radio traffic from the City side that said that they 13 did have fire coming from -- and I actually corrected myself on 14 this because I was asked about it earlier, and I thought they were 15 referring -- I didn't listen to any of the City side radio 16 traffic. I thought they were referring to my radio traffic 17 conveying that there was fire coming through the conduit 18 underneath the street. 19 MS. HARLEY: Um-hum. 20 LT. GUIDINAS: And I have to be corrected because he did say 21 that they had fire coming the pavement and the street. MS. HARLEY: Okay. 22 23 CHIEF MOYER: Do you have, Sheryl, the City transmissions? 24 Were they included in that or was that only -- so we have county 25 radio and City radio.

This is -- what I have is -- looks like county. 1 MS. HARLEY: 2 CHIEF MOYER: Okay. We can also get you City. My apologies. 3 LT. GUIDINAS: We actually started listening to it while we 4 were waiting. 5 CHIEF MOYER: I can get you a copy of that --6 MS. HARLEY: Okay. 7 -- transcription also. CHIEF MOYER: MS. HARLEY: 8 Okay. 9 CHIEF MOYER: I thought that that was all included on the 10 same --11 Well -- so one of the things I'm going to do is MS. HARLEY: 12 I'm going to need to kind of, next part, kind of clarify some 13 things that I was reading to make sure I understood that. 14 So you had -- let's see. 1 LT. GUIDINAS: So that was later on after the Mont Co search and rescue team showed up. Chad detailed me as their liaison for 2 3 fire service. 4 MS. HARLEY: Um-hum. They made access off of Penn Avenue. 5 LT. GUIDINAS: Thev 6 come at a fence down and utilized ground ladders to get in the 7 operation. For their paperwork, just to make easy for their crews working, that was what they considered the A side. 8 9 MS. HARLEY: Okay. 10 So they contradict what the fire department's LT. GUIDINAS: 11 response has. 12 MS. HARLEY: Okay. Got it. But from there, they utilized the search dogs. 13 LT. GUIDINAS: 14 They had -- like I said, they had the structural engineer and a 15 med spec. 20 CHIEF MOYER: And then kind of while that was going on, 21 Empire was working on getting equipment brought in. The Borough 22 crew had brought up their backhoe and kind of working in 23 conjunction with the Boyertown rescue guys, they were working on 24 the Second Avenue side. They cleared out the rubble that was in 25 the street, and then slowly started removing that so they could

1 get closer to the building and try to search for some voids. And then once beyond the curb line, the curb line at that point was 2 3 kind of where that rescue operation kind of held up because of the 4 condition of that wall. At that point, I don't know that we had 5 the engineers in there to see what the condition was, even though 6 the condition was still -- it was poor for the wall structure. 7 MS. HARLEY: Okay. 10 CHIEF MOYER: I don't really believe so. I mean I think that 11 all of the factors besides, you know, what caused the explosion, 12 and we have no idea what caused the explosion. But, I mean all of 13 the factors after the explosion, I feel like you covered.

11 CHIEF MOYER: It was also -- so we realized -- so we realized 12 that there was free flowing water in that building and then we 13 also got word from the search and rescue teams that in the 14 exploded building, that there was also water flowing in there from 15 pipes. Public Works worked on getting some things shut down in 16 that way. I'm not sure when that exactly occurred. I was very 17 reluctant to turn any kind of water off especially to Building 1 18 until we knew for sure that there was no extension.

19 MS. HARLEY: Gotcha.

20 CHIEF MOYER: So it was definitely a little bit later on 21 until we could confirm that there was no extension, and then 22 Public Works was able to start shutting down some water that we 23 were able to stop it from flowing where we didn't need it. 24 LT. 1 that the water was in some places almost chest high in the 2 basement. 3 MS. HARLEY: Okay.
