
Per our conversation I wanted to follow-up with the requested information:

- Measurement from the south side of the south breezeway to the bumper on 7 Track (Pig Trap) – 76' 8"
- Radio/In-cab video recording systems Our mobile radio (locomotive radio) and locomotive in-cab video recording system both operate on a 12v power supply. There is a single 12v inverter that supplies power to both of these devices, there is a single breaker in the locomotive labeled as "Radio" that supplies power to the inverter. If power is lost to the inverter it affects both systems as was demonstrated post incident when the engineer operated the "Radio" breaker and both devices ceased operation.
- Employee hire dates and previous experience Per our conversation; in the file loaded to Kiteworks labeled "Date of Hire", the field "Original Hire Date" would only include a date if the employee had been re-hired, i.e. they worked for PSC in the past, left the company and we brought them back. The field "Last Hire Date" is populated with the date the employee was hired originally if they had never worked for PSC in the past. I have verified with our HR group that none of the 4 crew members were re-hires and as a result, the "Last Hire Date" for each of these employees is their <u>original</u> date of hire.
  - Conductor, Richard Garza, hire date: 5-29-2018, previous rail switching experience ~ 9 years
  - Engineer, Randy Gore, hire date: 4-2-2018, previous engineer experience ~ 12 years
  - Brakeman, Travis Marie Jr. hire date: 8-16-2021, previous switching experience ~
     20 years
  - Brakeman Trainee, Brandon Moton, hire date: 9-26-2022, previous switching experience ~ 6 years
