Young Eagles Flight # 6

June 5, 2021

After completing 5 YE flights my plane was fueled and parked on the apron. Weather was moving in and we did not know how many more flights we were going to do.

There was one more YE signed up and I visited with them in the SRE building. The father explained to me that his son was not able to fly last year because he was too young, his two older brothers were able to complete YE flights and he felt left out. We discussed the approaching weather and I offered to show him the moving map on ForeFlight. I told him we would have to walk out on the apron where my plane was with the iPad.

As we walked out, and prior to this while in the SRE bldg, chapter members talked to me about the potentially hazardous weather moving in. This was bouncing around in my head while walking across the apron.

Once to the airplane I opened ForeFlight and the YE's father and I spent some time looking at the weather overlay that clearly showed the direction of travel and intensity zones. I expanded and shrunk the display to get a better idea of the cell's size. It showed clear skies to the south without any chance of weather moving in between Alexandria and Glenwood. It appeared that everything would be past the airport in about 30 minutes. I told them we could take more time flying if we needed to allow the airport to clear. They were good to go and the decision was made to launch.

While on taxiway A going to runway 13 the wind was directly down the runway but starting to pick up. The weather to the north was closer than I realized so I elected to turn on to runway entrance B about 3/4 the way down 13 to expedite the take off. Once airborne the air was good and we flew for about 15 minutes between Alex and Glenwood. As I watched things toward the airport the main cell traveled to the east clearing the airport. However another wing stretching to the south had developed that I could see would move over the airport. It was producing lots of rain and appeared deeper than what I initially saw on ForeFlight. I realized a lot more time was going to be needed to wait this out. From my perspective to the south the airport looked clear so I decided to violate my decision to wait the squall out and land. While on down wind for runway 13 I

observed the wind sock indicating the wind was now straight down runway 31. Noticing an aircraft taxiing to 13 I inquired if I should keep 13 the active. That pilot told me indeed the wind had shifted and was down 31 but he was going to do a down wind takeoff. I entered a midfield downwind for 31 and extended it to allow him to clear the airspace.

Once on final at about 200' I entered the first unstable air foretelling conditions further down the runway, this colored my decision to avoid a go around. As I crossed the threshold about 10 feet up I encountered a downdraft and flared hard enough to avoid contact with the runway. Skimming the runway trying to bleed off speed a wind gust hit resulting in the first balloon up, to avoid porpoising I added power which unfortunately extended my landing run. After getting extremely close to the runway another gust hit and the same process repeated, except this time the balloon height became extreme. I nursed it back down finally making contact with the runway. I did not push the control yoke forward to decrease the angle of attack to keep the mains planted so with the next gust the right wing came up and with no control authority left could do nothing.

On impact the windscreen shattered, dust and debris was flying around and my YE passenger was suspended upside down. I could not get the passenger door open so unhooked him and got him out my side. When I released my seatbelt it hung up and the boy who was on the wing reached in and tried to help me. Unfortunately I did not shut the master switch and mags off before I got out of the plane which was done immediately by arriving pilots.

Everyone knows that the winds always precede the storm and I regret not respecting that principle fully. All the decisions made on this flight rest on the PIC. I was fully informed, felt I could handle the risk and proceeded anyway.

The two most viable options that would have prevented this was, not landing but continue loitering or divert to another airport, or doing a go around.
