Found

Owners reported that the subject vessel suffered contact damage from another vessel on 25 November 2021 at approximately 2300 while moored at Motiva Port Neches.

The stbd aft main deck bulwarks and stbd stack plating were found to have been set-in.

Recommended

It is recommended that permanent repairs be carried out to the satisfaction of the attending surveyor.

Rectified

The following permanent repairs were carried out:

- stbd main deck bulwarks were cropped and renewed as original, starting at frame 35 extending aft approximately 11'
- stbd upper stack plating was inserted on the forward side above the focsle deck, approximately 66" x 40" x 3/8" plating
- stbd upper stack plating was inserted on the outboard upper edge, approximately 43" x 24" x 3/8" plating
- stbd upper stack plating was inserted on the top side forward outboard corner, approximately 12" x 24" x 3/8" plating

Repairs were carried out by qualified welders using approved procedures and materials. Upon completion the welding was visually examined, tested for tightness, and found to be satisfactory as permanent repairs.

Closing Paragraph:

It is recommended that the Vessel, SABINE, be retained as classed with this Bureau.
