THIS UNIT WAS DISPATCHED TO INCIDENT ADDRESS SW 109TH AVE & SW 8TH ST IN REFERENCE TO A COLLAPSED BRIDGE IN THE ROADWAY. UPON ARRIVAL, THIS UNIT WAS ADVISED BY MIAMI-DADE FIRE RESCUE THAT THERE WAS SEVERAL VICTIMS TRANSPORTED TO KENDALL REGIONAL HOSPITAL WITH VARIOUS UNKNOWN INJURIES. THIS UNIT WAS ALSO ADVISED BY FIRE RESCUE THAT THERE WAS AN UNKNOWN NUMBER OF VICTIMS STILL TRAPPED IN THEIR VEHICLES UNDER THE COLLAPSED BRIDGE BELIEVED TO BE DECEASED.

FLORIDA HIGHWAY PATROL ADVISED THAT THEY WOULD HANDLE THE TRAFFIC CRASH PORTION OF THE INVESTIGATION AND THE MIAMI-DADE POLICE DEPARTMENT HOMICIDE UNIT WOULD HANDLE THE INDUSTRIAL ACCIDENT PORTION OF THE INVESTIGATION AS WELL AS THE DECEASED PERSONS PORTION OF THE INVESTIGATION.

OSHA AND NTSB RESPONDED TO ASSIST IN THE INVESTIGATION.
