MS. FRAYER-BRUNO: Round Lake Beach.

5 p.m., and we are in -- what city is this? I'm sorry.

MR. BRAGG: Round Lake Beach, Illinois.

MS. FRAYER-BRUNO: Um-hum.

MR. BRAGG: My name is Kenny Bragg. I'm an investigator with the National Transportation Safety Board Office of Highway Safety, and this interview is in regards to a highway crash which occurred in Arlington, Wisconsin, on June 12, 2020.

Would you please state and spell your first and last name please?

MS. FRAYER-BRUNO: Yeah, it's Victoria Frayer-Bruno. to spell the whole thing?

MR. BRAGG: Yes, please.

MS. FRAYER-BRUNO: Okay. V-i-c-t-o-r-i-a, F-r-a-y-e-r, B-r-u-n-o.

MR. BRAGG: Okay. And just to -- just for clarification, it is with your knowledge and consent that this interview is being recorded, correct?

MS. FRAYER-BRUNO:

MR. BRAGG: Okay.

INTERVIEW OF VICTORIA FRAYER-BRUNO

BY MR. BRAGG:

- 1 Q. Go ahead and tell me a little bit about your husband.
- 2 A. He was 53, I believe, truck driver, and he was a great
- 3 husband, good father to my sons. He was just a fun guy to be
- 4 around and really enjoyed life, loved his grandchildren and his
- 5 job; he loved what he did and was hoping to retire fairly soon,
- 6 maybe in the next 10 years, and move to Tennessee, and that was
- 7 our plan.
- 8 Q. And how long have you known your husband -- had you known
- 9 your husband?
- 10 A. About 12 years.
- 11 Q. Twelve years. And how long had you been married?
- 12 A. Three.
- 13 Q. Three years?
- 14 A. Um-hum.
- 15 Q. And you lived together since you were married?
- 16 A. Oh, yes. And before too.
- 17 | Q. And so, since you've known him, what occupations has he had?
- 18 A. Truck driver.
- 19 Q. All -- what kind -- what type of trucks did he drive, do you
- 20 | know?
- 21 A. Well, he -- yeah, he was driving -- well, he delivered
- 22 | freight, so just like a semi, I guess.
- 23 Q. Yeah, okay.
- 24 A. And then, then he moved to fuel, and now this time, he's back
- 25 to freight -- now, he was doing -- he had a sleeper truck, and

- 1 | that was kind of new for him. Well, he had done that a long time
- 2 ago, but not for a long time, so he had started back delivering
- 3 freight with a sleeper.
- 4 Q. And how long did he work for this company?
- $5 \mid \mid A$. I think it was going -- I think it was around a year.
- 6 Q. About a year?
- 7 A. With this company, yeah.
- 8 Q. And how did he like it?
- 9 A. He liked it a lot.
- 10 Q. So what was his typical day, you know, what did that consist
- 11 of?
- 12 A. Well, he'd get up, you know, early.
- 13 Q. What's early?
- 14 A. Like 2, 3 a.m.
- 15 Q. Okay.
- 16 A. Head out to Elk Grove Village.
- 17 Q. Where's that at?
- 18 A. Elk Grove Village, that's his -- that's who he worked for,
- 19 K Express.
- 20 Q. Okay.
- 21 | A. That was --
- 22 Q. So that's also Illinois, correct?
- 23 A. Illinois, like it's about an hour from here. He'd drive
- 24 | there, you know, and then get his truck and, you know, it would be
- 25 | all loaded for him, and he would start his route. He'd go out of

- 1 | state and overnight, and then I'd see him sometime -- so he'd be
- 2 gone a day, because he'd do an overnight, and then I'd see him the
- 3 | following day. You know, it -- the times varied, but usually it
- 4 would be somewhere around 4, 5, 6 o'clock at night.
- 5 Q. Okay.
- 6 A. He'd come home. Well, first he'd stop there, drop the truck
- 7 off, get his car, and then head back home.
- 8 Q. So, when he went out of state, did he go to the same location
- 9 every time? So did he have his --
- 10 A. No.
- 11 Q. So it just varied, depends on --
- 12 A. Yeah.
- 13 Q. -- whatever the load is.
- 14 A. He did like Michigan, Tennessee, Wisconsin, Minnesota, Iowa,
- 15 I think, or Ohio. Yeah.
- 16 Q. And what was his health like?
- 17 A. Well, he was -- he had diabetes --
- 18 | Q. Okay.
- 19 A. -- and he had high blood pressure, but he was under doctor
- 20 | care. He'd go to the doctor every three months or so, and they
- 21 would, you know, reevaluate, like check his diabetes and all that.
- 22 He had a doctor's appointment scheduled the Saturday after he
- 23 passed. He was supposed to go to -- me -- I was going to go with
- 24 him to the doctor the next day.
- 25 Q. And what was that appointment for?

- 1 A. I wanted him to go to the doctor, and I wanted to go with
- 2 him, because he was feeling just rundown, and he was just looking
- 3 -- just -- he just was look -- not looking right to me.
- 4 | Q. Okay.
- 5 A. I was concerned about him, and he -- so he agreed that we
- 6 would go to the doctor together. I wanted to talk to the doctor
- 7 with him.
- 8 Q. So what kind of symptoms was he having?
- 9 A. Just -- not really symptoms other than he was just, just
- 10 | feeling really rundown. No energy --
- 11 Q. Really tired?
- 12 A. Tired, no energy, his appetite wasn't like it usually is.
- 13 You know, he just wasn't feeling great. That's all he would say:
- 14 | I just don't feel good; just don't really feel good.
- 15 Q. Did he ever make any complaint about maybe getting dizzy or
- 16 anything like that?
- 17 A. No.
- 18 Q. No. Did he have any idea what was wrong?
- 19 A. I don't think so, but that's what we wanted to go and like
- 20 | maybe get bloodwork done or something and just see what's going
- 21 on.
- 22 Q. Okay. So how did he deal with his diabetes? Was he taking
- 23 medication, was he taking insulin, or --
- 24 A. Not insulin.
- 25 Q. Okay.

- 1 A. He was just taking pills, and he was good about taking his
- 2 | medicine, and I would send him with his daily pills. You know,
- 3 he'd take them with him, he'd come back, they'd be gone. He was
- 4 good about taking his medicine.
- 5 Q. Okay.
- 6 A. So he did, he did do that.
- 7 \mathbb{Q} . What medicine -- what kind of medications did he take, do you
- 8 know?
- 9 A. Let's see. I don't -- I -- it's been a while, so I can't
- 10|| tell you offhand, but --
- 11 Q. Do you know what it was -- instead of the name, do you know
- 12 | what it was for? So was it -- how many medications --
- 13 A. Diabetes. The -- yeah, the pills for his diabetes.
- 14 | Q. Okay.
- 15 A. And then there was pills for his blood pressure.
- 16 Q. Blood pressure, okay.
- 17 A. And he took like a baby aspirin. There was nothing -- like
- 18 no narcotics, nothing like that.
- 19 Q. Okay.
- 20 A. I don't even remember what all of them --
- 21 | Q. So I assume he had health insurance?
- 22 A. Yeah.
- 23 || Q. And who was his health insurance through?
- 24 A. Blue Cross.
- 25 Q. Blue Cross?

- 1 A. Um-hum.
- 2 Q. And is that through his job or --
- 3 A. No, we had Obamacare.
- 4 Q. You had -- okay.
- 5 A. Yeah.
- 6 Q. How long had you had that?
- 7 A. Well, we've had that for a few years now.
- 8 Q. And where do you get his medications, you know, prescriptions
- 9 filled at?
- 10 A. Walgreens.
- 11 | Q. Walgreens, the one right up here?
- 12 A. No, I would get them filled by my work in Lakemoor. I work
- 13 | right by a Walgreens.
- 14 | Q. Okay. So I saw that he had a motorcycle accident that was
- 15 pretty, pretty serious a while back.
- 16 A. Um-hum.
- 17 Q. That was in 2017 (indiscernible)?
- 18 A. Yeah, I think so.
- 19 Q. How was his recovery with that?
- 20 A. It was good. I mean, he -- I don't remember exactly how long
- 21 he was off work.
- 22 Q. Did he still complain of pain from injuries in that
- 23 | motorcycle accident?
- 24 A. Well, yeah. He had -- so it was basically like nerve pain in
- 25 his feet.

- 1 | Q. Okay.
- A. And that was, you know, another thing for him where he was -- he wasn't really the same after that accident. But, I mean, he
- 4 could walk and everything, it was just, you know, to walk long
- 5 distances and stuff like that, he -- his feet really bothered him.
- 6 But it was like nerve pain, and I don't think -- he had been to
- 7 different doctors to try to see if there's anything, you know,
- 8 that could be done about that, and I just don't think -- I think
- 9 that's just how it was going to be.
- 10 Q. Okay. So did it affect his ability to sleep? Did it wake
- 11 | him up at night? Or is it worse another time of the day, do you
- 12 know?
- 13 A. I don't remember him saying it affected his sleep.
- 14 0. So how did he sleep? Did he sleep well?
- 15 A. Yeah, he slept, he slept pretty good. I mean, he'd lay down,
- 16 and he'd be out within seconds. He would sleep pretty good. I
- 17 mean, he would have to get up, as he got older, more frequently
- 18 | like to go to the bathroom and stuff, which would kind of break
- 19 his sleep a little bit. But, I mean, other than that -- I mean,
- 20 he didn't take a sleeping pill or anything like that. He didn't
- 21 seem to need it.
- 22 Q. Did he snore?
- 23 A. Yeah, he snored.
- 24 Q. How bad?
- 25 A. I mean, he was a pretty loud snorer, but, I mean, I -- he'd

- $1 \mid \mid$ just always been like that.
- 2 Q. Really?
- 3 A. And he was a big guy. He was heavier. Since I've known him, 4 he's always snored.
- 5 Q. What was his height and weight that you remember?
- 6 A. I don't -- let's see. He was like 3 -- maybe like 320.
- 7 Q. Okay, 320.
- 8 A. Maybe like 320. Maybe like 5'9".
- 9 Q. Okay. (Indiscernible) have you -- did you ever hear him like
- 10 stop breathing or wake himself up? I know like my dad, my dad
- 11 sleep snores, and we used to joke that he had a problem with his
- 12 | knees; every time his knees bent, he'd go to sleep. Did he -- is
- 13 that his experience? Like did he easily fall asleep during the
- 14 day or --
- 15 A. During -- sleep during the day?
- 16 Q. Yeah. I mean, like if he was just sitting around the house
- 17 doing nothing, watching TV, would he fall asleep watching TV?
- 18 A. Not, not -- I mean, occasionally.
- 19 Q. Occasionally?
- 20 A. He wasn't like one of those that would just fall asleep all
- 21 the time.
- 22 Q. So I want -- I did want to clarify his work schedule. So you
- 23 | said he would, he would leave home about 2 o'clock, got to his
- 24 truck about 3 o'clock --
- 25 A. Um-hum.

- 1 \mathbb{Q} . -- and he would go somewhere, wherever his destination was,
- 2 and then he would stay overnight --
- 3 A. Um-hum.
- 4 Q. -- and then he would come back home.
- 5 A. Um-hum.
- 6 Q. Did he drive alone?
- 7 | A. Yes.
- 8 Q. Okay. When he stayed alone, did he -- would he always call
- 9 you?
- 10 A. Um-hum.
- 11 Q. When he got there? So about what time would he usually stop
- 12 driving?
- 13 A. God, I don't know. Maybe like by 5 -- 4, 5, 6 at night,
- 14 something like that.
- 15 Q. So, in the evening time, he'd usually stop driving?
- 16 A. Yeah.
- 17 | Q. And he'd beddown until when?
- 18 A. Like till 2 or 3 the following day. I mean, he had to follow
- 19 -- they had -- you know, they have rules about their hours and how
- 20 | long they have to be off the road and all that stuff, so he had to
- 21 | follow that.
- 22 Q. So once he stayed out overnight in the truck, is there -- did
- 23 he normally come right back home? Were there some nights he
- 24 | stayed out multiple nights?
- 25 A. Normally, he'd come back home, yeah. You know, like

- 1 sometimes, he would stay overnight, and then when he got up, he'd
- 2 have to do like a stop and then start his route back home and come
- 3 back with whatever he picked up, bring it back to the -- to
- 4 K Express in Elk Grove. But, but, I mean --
- $5 \mid Q$. How did he sleep in the truck? Did he ever complain about
- 6 it, said it was okay or it was comfortable?
- 7 \mid A. I always asked him, and he would -- said he would sleep
- 8 really good in there.
- 9 Q. Okay.
- 10 A. So --
- 11 Q. Did he always have the same truck?
- 12 A. Yeah, I think he had the same one the whole time, I believe.
- 13 Q. Okay.
- 14 A. They might've upgraded him to another -- to a newer truck
- 15 | recently, but I'm, I'm not really -- I don't really remember,
- 16 because I remember him saying they were getting some new trucks.
- 17 | They might -- or maybe that was going to happen, and it didn't
- 18 | happen yet, but --
- 19 Q. So how many days in a week would he work consecutively? How
- 20 | many days in a row? Work four days then have a day off? What was
- 21 his schedule like?
- 22 | A. Well, he would work like five days a week.
- 23 Q. Five days a week? Always Monday through Friday, or over the
- 24 weekend sometimes?
- 25 A. No, usually Monday through Friday, and then he'd be home from

- 1 Friday until -- when he got back home Friday, he'd be home all the
- 2 way and then through Saturday and then Sunday, and then he'd head
- 3 out usually like 2, 3 in the morning on Sunday.
- 4 \mathbb{Q} . Okay. When he got home when the -- in the afternoon, you
- 5 said about 5 o'clock, right?
- 6 A. Yes, somewhere --
- 7 \mathbb{Q} . Give or take, yeah.
- 8 A. Yeah.
- 9 0. So what did he do in the afternoons?
- 10 A. Well, he'd come home and usually shower. He'd have dinner,
- 11 watch a little TV, and go to bed.
- 12 Q. What time would he usually go to bed?
- 13 A. Like he'd go to bed early. Like 7, 8 o'clock. I mean, as
- 14 soon as -- pretty much as soon as he ate, he'd watch about a half
- 15 hour of TV and go to bed. I mean, he was tired.
- 16 Q. And what time did you go to bed? I mean --
- 17 A. Me?
- 18 Q. -- same time, a little later?
- 19 A. I go to bed like 10.
- 20 Q. Okay.
- 21 A. 10, 10:30, something like that.
- 22 Q. And not to be intrusive, but you guys slept in the same room?
- 23 | A. Yeah.
- 24 Q. Okay. So I'm not sure if you're aware, but to drive a truck,
- 25 he had to have a medical certification.

- 1 A. Um-hum.
- 2 Q. You heard about that?
- 3 A. Yeah.
- 4 Q. Okay. Did you guys ever talk about his process with that?
- 5 A. He, he got his medical certification, I know that.
- 6 Q. Okay.
- 7 A. I know he was having a little bit harder time these past --
- 8 this past year, because I think -- now, I don't know if that's the
- 9 \parallel same as a DOT card.
- 10 Q. Yes, it is.
- 11 A. Okay.
- 12 Q. Yeah.
- 13 A. I know he had an issue where they wouldn't give him like the
- 14 year card or something, or the two-year card. I think they only
- 15 would give him a six-month.
- 16 | Q. Okay.
- 17 A. Because I believe it was his blood pressure.
- 18 | Q. Blood pressure.
- 19 A. So -- and I think he had to -- I don't remember what he had
- 20 | to do, if he had to go to the doctor or, or go back and have the
- 21 test again or something, and then he passed.
- 22 Q. Okay.
- 23 A. Something like that. But I know he was having an issue
- 24 there.
- 25 Q. Did you happen to know, your husband take a sleep study?

- 1 | Either at home or in a sleep clinic or anything?
- 2 A. I don't think so.
- 3 0. You never heard of it --
- 4 A. Not since we've been together.
- 5 Q. Not since you --
- 6 A. No, no.
- 7 Q. Okay. And, at one point, he owned his own trucks; is that
- 8 | correct?
- 9 A. Um-hum.
- 10 Q. Why'd he get out of that business?
- 11 A. He had his own truck for almost 10 years I think.
- 12 Q. Yeah.
- 13 A. Just because, you know, it wasn't profitable enough --
- 14 Q. Okay.
- 15 A. -- as time went on. There's a lot of expenses, you know, all
- 16 the taxes, the fuel, everything, and I think he was just tired of
- 17 | it and just wanted to just sell the truck, be free of it, and
- 18 | then, you know, go and work for someone else and finish out his
- 19 years until he retired.
- 20 Q. Okay.
- 21 | A. The maintenance, all that stuff.
- 22 Q. So the crash happened on Friday, June 12th.
- 23 A. Um-hum.
- 24 Q. So let's -- if you can, can you walk me through that week?
- 25 So what time did he leave Friday morning, do you know?

- A. Yeah, I think he left about 2 -- I want to say about 2 a.m.
 2 Maybe 1:30, 2 a.m.
- 3 Q. And what about the day -- what time did he go to bed the 4 night before?
- A. Early, because I think that night, the night before, he got home around 6, I want to say. But he was tired, and he -- actually -- or maybe -- I know I figured this out before, and I, I want to say that the night before the accident, he actually got a good amount of sleep, more than usual, so maybe he got home earlier.
- 11 Q. Okay.
- A. I'm not real clear on the time, but I remember that the night before, he did get about 7 hours of sleep. And he was not even driving that long before that accident happened.
- 15 Q. I know, because he started --
- 16 A. Like 3-ish, I think.
- 17 Q. Yeah, yeah. So he got -- he got to bed about 7 o'clock on
- 18 | Thursday?
- 19 A. And that, and that might not be right, because --
- 20 Q. Okay, but give or take?
- 21 A. Yeah.
- 22 Q. And so did he work Thursday morning?
- A. Yeah -- wait a minute. So he was coming back, the accident was on Friday -- yeah, he -- well, he was heading back from
- 25 wherever he was. I don't remember.

- 1 Q. So Thursday, Thursday morning, he -- Thursday morning, he had 2 stayed away somewhere.
- 3 A. Um-hum.
- 4 0. And then --
- A. And then he was heading back. I don't remember if he made any stops that day, pickups or deliveries, I don't know.
- 7 Q. But he got home Thursday afternoon, and you said he went to 8 bed early that night.
- A. Yeah, he ate dinner, and he went to bed, and he -- I remember he was trying to get an earlier start, I think, because he had the doctor's appointment on Saturday morning, and he wanted to make sure that, you know, he was back and stuff for that.
- Q. Okay. So then, when was the last time he was at home that night? Was he at home --
- 15 A. Thursday night.
- Q. And then -- but before that, prior to that Thursday. Because you said Wednesday night, he stayed overnight somewhere.
- 18 A. So Tuesday.
- 19 Q. All right.
- 20 A. I think. Yeah, I --
- 21 Q. Okay. Do you remember what time he would've went to bed
- 22 Tuesday?
- A. I don't. I mean, I really don't. But, but on average, I will tell you that Phil normally would be in bed the latest like
- 25 7:30. I mean, 8 o'clock, he was pushing it.

- 1 Q. Actually, even though you don't remember specifically, you
- 2 don't remember anything unusual about, you know, the time he went
- 3 to bed on Tuesday?
- 4 A. No.
- 5 Q. Okay.
- 6 A. Not at all.
- 7 Q. And had he, had he been on the road on Monday night and then
- 8 got up Tuesday and came home Tuesday evening?
- 9 A. Yeah, I believe so.
- 10 Q. Because he would've been off Sunday, right? Because he's off
- 11 on Sundays.
- 12 A. He's off Sunday -- yeah, he was off Sunday, left early out in
- 13 the morning for Monday.
- 14 Q. Same time, about 2 o'clock?
- 15 A. Yeah. So then would've been home Tuesday.
- 16 \mathbb{Q} . And about his cell phone. Did he have one -- only one cell
- 17 phone, more than one?
- 18 A. Just one.
- 19 Q. No company cell phone?
- 20 | A. Huh-uh.
- 21 Q. What kind of cell phone was it?
- 22 A. Samsung Galaxy.
- 23 Q. Okay.
- 24 A. I never got it back. I don't --
- 25 Q. So you, you haven't seen it since that --

- 1 A. (Non-verbal response.)
- $2 \mid Q$. Okay. And is he a -- a heavy cell phone user?
- 3 A. I mean, yeah, I would say so.
- 4 Q. So what does he use his phone for? Other than -- does he, 5 does he like --
- 6 A. He talks. He had a, a head -- earpiece.
- 7 Q. Okay. Does he watch -- does he use Facebook or anything like 8 that? Does he play games?
- 9 A. Oh, no. He's not a game guy. No. I mean, he had a tablet
 10 so that at night, when he was in the truck for the night, he could
 11 watch like Netflix or something.
- 12 Q. Okay.
- 13 A. But, I mean, mainly his phone was like, if he talked to
- 14 people during the day, you know, he would -- he always wore his
- 15 earpiece.
- 16 Q. Okay.
- 17 A. You know, he wasn't a gamer or anything like that. He did --
- 18 he was on Facebook, yeah, but, I mean, I don't think he was like
- 19 obsessive with Facebook or anything.
- 20 Q. My wife would say I'm obsessive, but --
- 21 A. Yeah.
- 22 Q. I can't think of anything, anything else I need to ask. If I
- 23 have some other questions, can I contact you by email?
- 24 | A. Um-hum.
- 25 Q. Okay.

MR. BRAGG: Well, I'm going to go ahead and conclude the interview. Thank you very much for talking with us. MS. FRAYER-BRUNO: Okay. (Whereupon, the interview was concluded.)
