## Dear Mr. Johnson:

We reviewed references (a) through (f), submitted by your emails dated May 9, June 13, and June 19, 2023 (MSC Document Nos. 2313701, 2314507, and 2314617), for compliance with 46 CFR Subchapter H. References (a) and (b) are **Approved**. The installation, workmanship, and testing shall be accomplished to the satisfaction of the cognizant Officer in Charge, Marine Inspection (OCMI). References (c) through (f) are **Examined**. Specific approval of these references is not required; however, they contain information that is needed to verify compliance and subsequent approval of required plans. The following comments apply:

## Reference (a)

1. Your plan and reference (c) indicate the heat exchanger operates at a temperature of less than 200°F and under 15psig. Therefore, as per 46 CFR 54.01-15, the Hydroniq DN100-03-L heat exchanger is exempt from shop inspection and plan approval. This issue shall be addressed to the satisfaction of the cognizant OMCI. This comment supersedes comment 3 of reference (i).

## Reference (b)

2. The scope of our review is limited to the modifications to the fuel oil service piping since the plan was previously approved by reference (j). We note the inclusion of a fuel oil transfer system cross connect that was not covered in this review. Should you require approval for the transfer system, please submit additional plans to the cognizant OCMI or Marine Safety Center for review.

3. As per reference (d), your plan indicates the use of Leser Type 441 relief valves, designed to ASTM A216. As per reference (g), the valves are set to 4 psi in accordance with the engine manufacturer requirements. Our approval is granted with the understanding that the shut off valves will remain open while the vessel is operating. Per reference (h), this issue shall be addressed to the satisfaction of the cognizant OCMI. This comment supersedes comments 4 through 6 of reference (i).
