## 1 INTERVIEW (11:57 a.m.)2 3 MR. FOX: This is Michael Fox, investigator for the National 4 Transportation Safety Board, out of the Washington, D.C. Office. 5 I am located at Westfield Transport, Incorporated, at 6 in Westfield, Massachusetts. We are here conducting a on-7 site visit with the motor carrier involved in the crash that we're 8 currently investigating. Today is June the 25, 2019. The time is 9 11:57 a.m. There are several folks in the room with us, and we're going 10 11 to go around the room and we will introduce each person by their 12 name, their title, and we'll ask them to spell their last name. 13 So we'll go ahead with the president of the company. 14 Sir, can go ahead and speak loudly, say you're name? 15 MR. DARTANYAN GASANOV: My name is Dartanyan Gasanov and then 16 I'm the owner of the company. 17 MR. FOX: Spell your last name for the record. 18 MR. DARTANYAN GASANOV: G-A-S-A-N-O-V. 19 MR. FOX: Okay. 2.0 MR. COMIRE: Investigator Robert Comire, Federal Motor 21 Carrier. 22 MR. FOX: Damien. 2.3 MR. DAMIEN GASANOV: And I'm vice president and supervisor. 2.4 My name is Damien, it's easy to pronounce, but my real name is 2.5 Dunyadar, and my last name is Gasanov, same spelling as my

brother, owner of the company, G-A-S-A-N-O-V.

- MR. FOX: So, thank you all for being here today. We are
- 4 trying to learn more about the company. And we've already been
- 5 talking, so we just wanted to go on record on some of the
- 6 questions and answers here.
- 7 INTERVIEW OF DUNYADAR "DAMIEN" GASANOV
- 8 BY MR. FOX:
- 9 Q. So, I believe, Damien, you said that you're basically the
- 10 brains of the company. Is that correct?
- 11 A. Yeah. I'm dispatching and I'm -- well, I do a lot of the
- 12 hiring and training. I take care of the maintenance. Do a lot of
- 13 dispatching. Yes.
- 14 Q. And does your brother have any functions with the company
- 15 | besides being the president?
- 16 A. He doing the same, he just -- I just -- I'm just like his
- 17 | right hand. I'm helping him. I helping out with all of that
- 18 because his English little weaker than mine, let's put it this
- 19 way.
- 20 Q. Okay.
- 21 A. So it's easier for me to communicate than for him, so I try
- 22 to communicate.
- 23 Q. And currently you employ six drivers. Is that correct?
- 24 A. Yes, sir.
- 25 Q. And you have how many vehicles?

- 1 A. About seven, but they're not all running, though.
- 2 Q. Seven? Now that's power units. Do you have any trailers?
- 3 A. Yeah. The trailers are attached to them.
- 4 0. And what kind of trailers are these?
- 5 A. Majority of them are Shipshe Trailers from Shipshewana,
- 6 Indiana factory. They -- the oldest would be probably 2015, would
- 7 be the oldest. We like to use the new equipments. So they are
- 8 three car hauler with the good quality trailers.
- 9 Q. Three of them are car hauling?
- 10 A. Yes, sir.
- 11 Q. And what are the other four?
- 12 A. They all seven are car hauling trailers, seven --
- 13 Q. Oh, all seven are car hauling?
- 14 A. Yeah.
- 15 Q. Okay. And you mentioned that the business originally started
- 16 in 2013 and you were doing medical transport?
- 17 A. Yes, sir.
- 18 Q. And that was in a sedan?
- 19 A. Yeah. That was not emergency transportation. So people been
- 20 asking for rides sometime. We been doing even schools, jobs, non-
- 21 emergency transportation, taking the people to the hospitals, to
- 22 they doctor's appointments.
- 23 Q. What was the name of that company?
- 24 A. Same name, Westfield Transport.
- 25 Q. Westfield Transport?

- 1 A. Yes.
- 2  $\mathbb{Q}$ . And you did that type of operation for  $3\frac{1}{2}$  years?
- 3 A. About  $3\frac{1}{2}$ , yeah.
- 4 Q. And then you decided, because you had other colleagues in the
- 5 business hauling autos, that you would go into the trucking
- 6 business?
- 7 A. Yes, sir.
- 8 Q. And that was in 2016?
- 9 A. It was in 2016. Yes, sir.
- 10 Q. And did you start off with just one truck or --
- 11 A. We started off just with one truck.
- 12 Q. And you would be hauling automobiles with that?
- 13 A. Yes, sir.
- 14 Q. Did you haul any cargo with that?
- 15 A. I try a few times, but it was more -- a lot more
- 16 responsibility and it was a lot harder. So I, like I said, I try
- 17 | maybe two or three times at the most. And after I see that, that
- 18 | it's not for our trailers, not -- it's not safe as is hauling the
- 19 cars and -- I have to give up. I never did, never did that since.
- 20 Q. You were hauling pipes and machinery? Is that what you said?
- 21 A. Yeah. Just one time pipes, one time machinery. And no more
- 22 | since that.
- 23  $\mathbb{Q}$ . Um-hum. And at some point you decided to get your CDL?
- 24 A. Yeah. I got caught -- the new trailer that I -- the second
- 25 trailer that I just bought, it was too heavy for my non-CDL

- 1 driving, and I got stopped by DOT police and I got the violation
- 2 for driving a non-CDL trailer. They told me you have to have a
- 3  $\parallel$ CDL for that trailer. That was a new trailer, and I was -- I
- 4 don't know, I was misunderstood in how the things work in this
- 5 process. At that time I was new in this business. And then after
- 6 that, I went and got my CDL right away. I got it in 1 month,
- 7 | not -- I believe not even.
- 8 Q. Did you go to truck driving school?
- 9 A. I didn't went to the truck driving school because the CDL I
- 10 | got, it's with the air restriction. So I don't -- like, I don't
- 11 | need it -- it's pretty much a -- they are kind of simple to --
- 12 similar to our non-CDL combination, but they are more heavy dutier
- 13 | axles on the bottom. So all I need is just the combination, get
- 14 | the combination done and the general test. And after I got my
- 15 permit, all I got to do is take the same combination with someone
- 16 who have a driver license or 1 year experience, and give it to the
- 17 | -- get to the driving DOT test. And I first in the -- and I pass
- 18 on the first try.
- 19 Q. Did anyone train you how to operate?
- 20 A. We have, we -- the thing is, I have lot friends who doing the
- 21 same job. So I'm very familiar with the trucks, like -- but they
- 22 have air combinations. And the combination that I passed the CDL
- 23 | with is just of -- it just little, little heavier than the other
- 24 trailers that we have. So it was very similar to the regular non-
- 25 CDL combination trailers. Very, very similar, just little heavier

- 1 axles.
- 2 Q. What area are you delivering to?
- 3 A. We doing -- a majority of our job, it's in Northeast. In the
- 4 beginning, when I just started working, I was kind of traveling
- 5 all over the place. I was going to see the country and it's -- it
- 6 was something new for me. So after I figured out that it's not
- 7 profitable for us to driving around country with the small car
- 8 | haulers, it's not profitable, I started doing the Northeast. It's
- 9 harder, there is a lot of tolls, but it pays a little more. So we
- 10 end up, we doing -- we start from Massachusetts, Connecticut,
- 11 Rhode Island, Maine, New Hampshire, Vermont, New York,
- 12 | Pennsylvania --
- 13 Q. Maryland.
- 14 A. -- Maryland, West Virginia, New Jersey, and Delaware, sir.
- 15 Q. Okay. You said you -- the tolls are difficult. How do you
- 16 handle that? Do you have an E-ZPass?
- 17 A. Yes, sir.
- 18 Q. Okay. So all the vehicles have E-ZPass?
- 19 A. Yes, sir.
- 20 Q. Okay. And automobiles is your only cargo?
- 21 A. Yes, sir.
- 22 Q. And I think you mentioned that you have a series of brokers
- 23 that you get your loads from?
- 24 A. The main platform would be the Central Dispatch, where all
- 25 the drivers -- all the car hauling businesses are getting they

- 1 loads from.
- 2 MR. FOX: So at this point we're going to take a short
- 3 recess, for a moment. So I'm going off the record.
- 4 (Off the record.)
- 5 (On the record at 12:16 p.m.)
- 6 MR. FOX: So, at this time we're going back on the record.
- 7 It's 12:16. We'll continue with the interview after a short
- 8 recess.
- 9 BY MR. FOX:
- 10 Q. We had just discussed the area of delivery that you went to,
- 11 which is basically the Northeast, and that you actually had E-
- 12 ZPass to help you with the tolls, and that automobile is the only
- 13 cargo that you're hauling. Is that correct?
- 14 A. Yes, sir
- 15  $\mathbb{Q}$ . And I think we discussed a long list of brokers that you use.
- 16 Is that correct? Is that how you generate your revenue?
- 17 A. Yeah. And the majority of the platform that we will get the
- 18 loads from, it would Central Dispatch.
- 19 Q. Central Dispatch?
- 20 A. Yep.
- 21  $\mathbb{Q}$ . And that is a, that is a --
- 22 A. Because --
- 23 Q -- a company?
- 24 A. That's a app -- that's a website where we -- where you can
- 25 get the loads and where all the brokers and all the car carriers

- 1 are registered at. And in order to register at Central Dispatch
- 2 here, you have to have your DOT and all that so you can -- you
- 3 have to get the -- you have to have insurance, you have to have a
- 4 DOT, and then C number, in order to register there.
- 5 Q. And then you have an account with them?
- 6 A. Yes, sir.
- 7 Q. And you also have other companies that -- or apps that you
- 8 use, and that includes uShip?
- 9 A. Yeah. They -- all the rest of the apps, it will be the
- 10 company that still puts the loads on Central Dispatch. So --
- 11 Q. I see. So that's uShip and Metro Logistics, and cars arrive
- 12 | at United Road?
- 13 A. United Road. All the, you know, all the leased stuff.
- 14 Q. Shipped cars?
- 15 A. Yep. They all would be on Central Dispatch, all the brokers.
- 16 Q. As far as staff, it's you and your brother, and are there any
- 17 other employees at the company?
- 18 A. My wife, she helping us with the paperwork.
- 19 Q. And what's your wife's name?
- 20 A. Yeah. Her name is Olga.
- 21 Q. Olga?
- 22 A. Yep.
- 23  $\mathbb{Q}$ . And you have two other folks that work for you?
- 24 A. We have -- we just hired two girls from North Carolina so
- 25 they can start learning how to do dispatching. They just started

- 1 about a week ago.
- 2 Q. I see. And I think you mentioned that you also had a
- 3 | consultant, a safety consultant, Dennis?
- 4 A. Yes. We also sign up for TFC [sic] Services about -- it was
- 5 right before the crash happens. About a week before the crash
- 6 happened. It is called a TVC, which Tri-(indiscernible) Services.
- 7 They will do -- they will interview the drivers. They will do the
- 8 training. And they will help you to -- with the law. If there is
- 9 any problems, they will provide a lawyer. Stuff like that.
- 10 Q. So this is something you just started?
- 11 A. Yes. About a -- all together, it would be about maybe 3
- 12 weeks, at the most.
- 13 Q. And you said that they do the hiring of the driver?
- 14 A. They don't do hiring, but they do, like -- it's lots into it.
- 15 I believe they even do the interview, the -- they can interview
- 16 the drivers, too.
- 17 Q. So have you used this service to interview or hire any of
- 18 your drivers?
- 19 A. No, not yet.
- 20 Q. So was this something you just getting --
- 21 A. I just --
- 22 Q. -- ready to begin?
- 23 A. I just got this about -- it's about a, maybe, week before the
- 24 crash happened.
- 25 Q. Is this a local company?

- 1 A. No. The -- TVC Services, they all over the country.
- 2 Q. Okay. Do you have a hiring process on how you recruit and
- 3 bring folks to the company to drive for you?
- 4 A. Yes.
- 5 Q. And what is that process?
- 6 A. The process, we just go by required law requirements. We
- 7 | will ask for -- has to have a active driving record -- I mean
- 8 driving license, because we have to check the driving record. For
- 9 a cargo, we have to send them in to insurance -- insurance have to
- 10 approve them. And then we have to -- also, obviously, we
- 11 personally talking to the driver asking about his background and
- 12 his driving record. And after that, we pulling his driving
- 13 record.
- 14 Q. Are any of these procedures written down? Do you have a
- 15 standard operating procedure for any of these items that you're
- 16 describing?
- 17 A. Yeah. We have a driving record --
- 18 Q. No. I mean, do you have a policy or procedure manual on how
- 19 you hire people or it just comes out of your head?
- 20 A. No. I have notes on my phone that I save from each time when
- 21 | we hire drivers. So, we go -- it's starts up from the paperwork,
- 22 start up form personal talking to him, and also, as into the
- 23 driving training, and talk about -- discuss about the operating
- 24 that, of the -- yeah, operating non-CDL combination.
- 25 Q. Is there a minimum age for hiring?

- 1 A. Has to be over 21.
- 2 Q. Okay. And how do you check their license?
- 3 A. We pulling they driving record.
- 4 Q. And do you have a procedure or an account with the DMV or
- 5 something?
- 6 A. My wife help me out with this, so she would be answer -- she
- 7 | would be able to answer to that question, sir.
- 8 Q. Okay.
- 9 A. How she --
- 10 Q. Maybe we'll talk to her later.
- 11 A. Yeah, how -- she's the one who pulling the driving records
- 12 for us.
- 13 Q. And do you perform any drug tests on your drivers?
- 14 A. If it's a CDL driver, yes.
- 15 Q. Do you have a service that does drug testing?
- 16 A. We sign up for a drug testing program and --
- 17 | O. Who is that with?
- 18 A. I'm sorry?
- 19 Q. What's the name of the company, sir?
- 20 A. I don't know. It's inside the documents that we got ready
- 21 for you guys. I will be able to provide that information --
- 22 Q. Okay.
- 23 A. -- a little bit.
- 24 Q. So do you have CDL required equipment that you operate?
- 25 A. Required equipments like -- what do you mean?

- 1 Q. Tractor trailer or, I mean, do you have -- you said you do
- 2 have drug testing, and I'm asking why do you do drug testing? Do
- 3 you have CDL required equipment?
- 4 A. Yes. We have to -- it's required by law, if you have CDL,
- 5 you have to do the drug test.
- 6 Q. So my question to you is, do you own vehicles that require a
- 7 CDL?
- 8 A. Yes, sir.
- 9 Q. And what are they?
- 10 A. It's same thing, car hauling trucks.
- 11 Q. Is it a -- what's the --
- 12 A. It's a Ram 4500 -- they both 2017 Ram 4500s, with the Shipshe
- 13 Trailers. It would be --
- 14 Q. How many of those do you have?
- 15 A. Just two.
- 16 Q. You have two?
- 17 A. Yes.
- 18 Q. And those are operated by CDL holders?
- 19 A. Right now, it's only one of them operated by me. The second
- 20 is not because it's very few -- very difficult to find a CDL
- 21 driver and, on the top of that, I try to stay away from it
- 22 | because, as I find out in my experience, they -- it's very hard to
- 23 | find a good driver.
- 24 Q. It is. Now when you're hiring someone, do you require an
- 25 application for each driver?

- 1 A. There is a -- applications. Which ones are --
- 2 Q. You know, a form that you say your name and your driving
- 3 | history and your address and who you work for. Do you have an
- 4 application?
- 5 A. We taking the copies of the names and address would be on his
- 6 driving license. So we taking a copy of his driving license.
- 7 And, like I said, that we pulling his driving record, his Social
- 8 | Security must be in it. That's pretty much it.
- 9 Q. And that whole process is conducted by yourself? You do all
- 10 | the hiring?
- 11 A. Yes, sir.
- 12 Q. Okay. And do you have any policies or procedures, written
- policies or procedures on how you do your safety for the company?
- 14 A. Yes, I do.
- 15 Q. So can you produce them in a few minutes? Do you have a book
- 16 or something that shows what your safety's supposed to be?
- 17 A. That's safety for -- it's the ones that I bring up in the
- 18 meetings or safety for agreements that we have?
- 19 Q. Yeah. For any of your safety procedures or policies. Do you
- 20 any written policies that you have for your drivers? Do and
- 21 | don'ts?
- 22 A. It's, again, with the my wife. When she will come back, I
- 23 | will provide those here.
- 24 Q. Okay. Do you provide your drivers with any of these written
- 25 policies?

- 1 A. Provide the drivers with this -- yes.
- 2 Q. You do? Okay. The drug testing, you said, is with a
- 3 | company, but you don't know the name?
- 4 A. Yeah.
- 5 Q. And -- but all the drivers, are they in a random pool?
- 6 A. No. That's -- that program is just for a CDL drivers.
- 7 Q. Okay. Does your wife handle that?
- 8 A. Yeah.
- 9 Q. So maybe we can talk to her in a few minutes. Describe how
- 10 you do dispatch. How is dispatch operating?
- 11 A. It's -- we going into the load board on Central Dispatch, and
- 12 | all the brokers are what's they loads over there. And before we
- 13 start taking any loads, the brokers are always asking about
- 14 insurance that we (indiscernible) and they also send the contracts
- 15 | to know what kind of equipments are operating with and stuff like
- 16 that. They're also pulling your DOT record --
- 17 Q. Right.
- 18 A. -- of operating.
- 19 Q. That's more for getting your load. But, I mean, as far as
- 20 dispatching driver number 1 or number 2 or whatever, how is that
- 21 done?
- 22 A. It would be on the phone, and the drivers are getting text
- 23 messages with the dispatch sheet.
- 24 Q. All right. So --
- 25 A. And all the addresses on that dispatch sheet: Pickup

- 1 address, delivery address, car information, names, numbers, and
- 2 all that.
- 3 Q. And this is one of your duties? You handle dispatch?
- 4 A. Yes, sir.
- 5 Q. And do you monitor the hours of service with the drivers on
- 6 how many hours they have?
- 7 A. They driving with the electronic logbooks, with the
- 8 KeepTruckin, and we have accounts of all the drivers --
- 9 Q. They have ELD on there?
- 10 A. Yes, sir.
- 11 Q. Okay. What service to you use?
- 12 A. KeepTrackin [sic].
- 13 Q. Keep Tracking?
- 14 A. Yes, sir.
- 15 UNIDENTIFIED SPEAKER: KeepTruckin.
- 16 BY MR. FOX:
- 17 Q. KeepTrucking [sic]?
- 18 A. Yes.
- 19 Q. And are you the one that monitors to make sure that the
- 20 drivers are maintaining the hours of service?
- 21 A. Yes.
- 22 Q. Compliance?
- 23 A. Yeah, if -- it's very convenient to have that, because if the
- 24 driving will get the violation, I would receive the message that
- 25 tell him that driver are violating his hours of operations.

- 1 Q. And is that come on your phone? Is that --
- 2 A. It would come out on my phone right away.
- 3  $\mathbb{Q}$ . It gives you an alert?
- 4 A. Yes, sir.
- 5 Q. And then, if you do get an alert like that, what is your --
- 6 A. I would have --
- 7 Q. -- procedure?
- 8 A. I would have to call and figure out what's going on, what
- 9 happened. And we go from there. The last one was, my driver stop
- 10 at the gas station to gas up and then he put himself -- after on
- 11 duty, he put himself off duty. And then he said he moved for a
- 12 second, and that's when the violation come right up. Because he
- 13 have to stay there for 30 minutes and they have to take 30 minutes
- 14 of break. So he said he just removed the truck from one parking
- 15 | to another. He tried to. And it came out right away.
- 16 And after that, we have a DOT inspection and he showed that
- 17 to the DOT inspectors. I say, when you -- because when the DOT
- 18 | will stop him, they also going to see red button on his ELD, that
- 19 saying that it's been violated. So he can go -- the DOT inspector
- 20 can go and see when and where and what time that happened, and for
- 21 how long violation would happen. And after he explained that, the
- 22 DOT say that's not a big of a mistake; it's only just to remove
- 23 the truck from one spot to another.
- 24 Q. Okay.
- 25 A. So he didn't give him violation for that, sir.

- 1 Q. Was there a electronic log on the accident vehicle?
- 2 A. On the accident vehicle was electronic logbook. It wasn't
- 3 connected. He was going with the paperwork and, by law, we can --
- 4 we have 30 days with the paper log, sir.
- 5 O. But it did have a ELD on the truck?
- 6 A. Did have a ELD on the truck, sir.
- 7 Q. But it was not turned on?
- 8 A. It's not turned on.
- 9 O. Okay. Let's switch over to maintenance. Did you say you,
- 10 | you're responsible for maintenance?
- 11 A. We also do maintenance with the meetings on every weekends.
- 12 When the drivers get home and when they get to the truck stop, we
- 13 go -- first what do is, we go from the trailer to the truck, see
- 14 | what's -- if there is any problems. Because the drivers have to
- 15 check, do their pre-trip inspection every morning.
- 16 Q. Is that paper, or they do it electronically, I guess?
- 17 A. I -- yes. They tell me when the come over, also. And,
- 18 obviously, they must remind about that, that has to be done right
- 19 away. And all our equipments are -- they pretty much are brand
- 20 new, so there is not really a lot of maintenance on them. But, we
- 21 do the recalls, we do the electric, we do everything that needs to
- 22 be done, and then, whatever the manufacturer's recommended too.
- 23 Q. Um-hum. And you --
- 24 A. We go by that.
- 25 Q. -- you personally oversee the maintenance? Do you do any

- 1 physical maintenance on any of the equipment?
- 2 A. I can help, but if I -- if -- I'm there all the time, so I
- 3 can help with anything. I can -- I have -- I myself can fix
- 4 | brakes, let's put it this way, or change the oil. That's the
- 5 simple things I can do myself.
- 6 Q. Okay. So that's just an overview on the company. Let's talk
- 7 specifically about the accident driver. How was he recruited for
- 8 the position?
- 9 A. It was a day when he come over. We were -- there was
- 10 weekends, by the way, we were at the truck stop doing --
- 11 Q. And where was the truck stop?
- 12 A. Here in West Springfield.
- 13 O. Does that have an address?
- 14 A. What was the name of the street?
- 15 MR. DARTANYAN GASANOV: Western Ave.
- MR. DAMIEN GASANOV: On West --
- MR. COLLINS: That's where you stored --
- 18 MR. DAMIEN GASANOV: Western Avenue.
- MR. COLLINS: That's where the -- property where you store
- 20 | the vehicles?
- MR. DAMIEN GASANOV: Yes, sir. And --
- 22 BY MR. FOX:
- 23 Q. And can you recall when that was?
- 24 A. Yes. I was on Sunday. Tell you right now. Sunday, 15 -- no
- 25 | -- I'm sorry -- 16.

- 1 O. The 16th of June?
- 2 A. Of this month, yes.
- 3 Q. And that's when you first encountered the driver?
- 4 A. Yes.
- 5 Q. And how did that happen? Did he come up to you and --
- 6 A. He just come -- yes, he just come to us, ask if we need any
- 7 drivers. We, at this moment, we have one open position. So we
- 8 talked to him. We have a meeting and we got driving record; he
- 9 provided it. We --
- 10 Q. You reviewed his driving record?
- 11 A. Yes, sir. We --
- 12 Q. And --
- 13 A. And on his driving record, all I see is just one DUI. He was
- 14 caught drunk and driving on 16, I believe. I'm not remember
- 15 | exactly, but in 2016 -- the copy of his driving record is here.
- 16 Did you guys get provided with it?
- 17 O. Yes.
- MR. COLLINS: No, we don't have a copy of it here.
- 19 MR. DAMIEN GASANOV: I would --
- MR. FOX: Of your copy, but we have our own copy.
- 21 MR. DAMIEN GASANOV: And then we check if -- I mean, the
- 22 first, before we check his driving license, if it's active or not
- 23 | after that, obviously we make a meeting with him. We ask him if
- 24 he works somewhere. He said he'd been doing this for many years,
- 25 and he named the companies.

- 1 Q. What companies did he work for?
- 2 A. He named the FBI, he named the West -- Western Massachusetts,
- 3 Western Mass. or -- yeah, Western Massachusetts. What else?
- 4 He --
- 5 Q. Is that Western Massachusetts Trucking or something?
- 6 A. Yeah. I don't remember off my head. But they is a companies
- 7 that they are operating. I see they trucks in West Springfield a
- 8 lot.
- 9 Q. Did he fill out a, a driver application for employment?
- 10 A. Not at this moment. It's -- we go through, we go through --
- 11 | we go with -- through asking him a questions. We were talking to
- 12 him a lot. He's been there for 2, 3 hours. And we've been asking
- 13 questions that we have in our knowledge, like how to operate --
- 14 questions that we haven't been given the problems with. I always
- 15 keep the notes. And I've been going through my notes with him.
- 16 He was answering -- all his answers was right. He sound like he
- 17 | are have a lot of experience of that, doing that job.
- 18 Q. Did you -- I think that you early -- mentioned earlier that
- 19 your insurance company had to do an approval. Did you send this
- 20 driving record to the insurance company? Did they approve this
- 21 driver?
- 22 A. On the liability policy, we don't have to send no one in.
- 23 The approval needs to be send only for the cargo. So we did send
- 24 | the -- for the cargo in to the insurance, his name.
- 25 Q. You did?

- 1 A. Yeah.
- 2 Q. And did they -- they approved him?
- 3 A. Not yet, because it's been sent out.
- 4 Q. Oh. So it hadn't even been approved?
- 5 A. Not for cargo.
- 6  $\mathbb{Q}$ . So on June the 16th, you interview the driver for about 2
- 7 hours. You ascertained his previous employment, and then you sent
- 8 the information to your insurance company. You had not heard
- 9 | back. When did he start -- when was the first time you dispatched
- 10 him?
- 11 A. It was a Wednesday when -- I'll tell you the date exactly.
- 12 He started (indiscernible) 19, right? 19th? Yeah, he start at
- 13 the 19th. He had --
- MR. DARTANYAN GASANOV: I got the papers.
- 15 MR. DAMIEN GASANOV: Yep. He started 19.
- 16 BY MR. FOX:
- 17 Q. Okay. Now were there any other procedures that you did as
- 18 far as the hiring process? Did you do -- you did not do a drug
- 19 test?
- 20 A. No. We didn't do it, because we not required by law. But
- 21 | obviously I wish I --
- 22 Q. Now did you contact any of the previous employers to see
- 23 about their -- his driving history there?
- 24 A. I haven't contact them, no.
- 25 Q. You did not contact either, either one?

- 1 A. No.
- 2 Q. Did he mention any other company besides FBI and Western
- 3 Massachusetts?
- 4 A. There was a, there was a other third company that -- yes.
- 5 That I know --
- 6 Q. Do you -- can you recall what that was?
- 7 A. Not really. I don't remember, but I can get it for you, sir.
- 8 Q. That would be great.
- 9 A. I can get it -- at the end of the interview, I will give --
- 10 get you that company.
- 11 Q. Yes, sir. That'll be, that'll be great. Did you do any
- 12 training program for the driver?
- 13 A. Yeah. I have -- I ask him to sit in the truck and try to
- 14 back in and back forward, just to see if he knows what he's doing.
- 15 After obviously -- after his words, I believed to him, but I just
- 16 want to see him to. He done, he done it perfect. And he have a
- 17 CDL in his hands. And the combinations that we are require him to
- 18 drive, it was non-CDL combination, which is very simple and much
- 19 easier than CDL.
- 20 Q. So the --
- 21 A. But still need --
- 22 Q. -- you're saying CDL. So he was driving what type of
- 23 | combination vehicle?
- 24 A. It's -- it was a two car hauler commercial, commercial
- 25 vehicle.

- 1 Q. And what was the gross vehicle weight rating of the truck and
- 2 trailer?
- 3 A. 24,000.
- 4 Q. So what was the gross of trailer?
- 5 A. That's combination, combined would be 24,000. The trailer is
- 6 14,000 pounds and truck is a 10,000 pounds.
- 7 Q. What's the make of the trailer?
- 8 A. Trailer was a Quality trailer.
- 9 Q. Where did you purchase the trailer?
- 10 A. I purchase with -- from one of my friends. That was my first
- 11 trailer that I was working with, long time ago, that I was started
- 12 with.
- 13 Q. How long have you owned it?
- 14 A. Since 2016.
- 15 Q. Do you have a bill of sale for that?
- 16 A. I do have it somewhere. Yes.
- 17 Q. And what was the make and model of the accident truck?
- 18 A. It was a 2016 Ram 2500.
- 19 Q. Repeat the year again.
- 20 A. 2016 Ram 2500.
- 21 Q. Dodge?
- 22 A. Yep.
- 23  $\mathbb{Q}$ . And how long have you owned that?
- 24 A. Since 2016.
- 25 Q. Did you buy it new?

- 1 A. Yes, sir.
- 2 Q. Where did you buy it from?
- 3 A. Metro in Chicopee. It is Metro Dodge/Jeep/Chrysler dealer in
- 4 Chicopee.
- 5 0. Where is that? What state?
- 6 A. Massachusetts. It's about maybe 15 miles away from here.
- 7 Q. Now you said that you gave the driver a road test. When was
- 8 | that? Was that also when you interviewed him on --
- 9 A. Yes.
- 10 Q. -- the 16th?
- 11 A. On the same day, yeah.
- 12 Q. And then between June the 16th and June the 19th, did you do
- 13 anything with the driver?
- 14 A. It was just in training (indiscernible) that you did
- 15 | anything, any driving, like did you take him to the gas station,
- 16 | like we're always doing in the beginning and start with him, start
- 17 | with a little ride.
- MR. DARTANYAN GASANOV: He was a -- knows everything. Then,
- 19 like, I just gassed him up (indiscernible) --
- MR. DAMIEN GASANOV: Did -- where did you gassed him, we gas
- 21 him up?
- MR. DARTANYAN GASANOV: Right gas station.
- MR. DAMIEN GASANOV: So you take him to the -- we take him to
- 24 the gas station's about maybe 3 miles away. And my brother been
- 25 | followed -- are you followed with him or were you followed behind

- 1 him?
- 2 MR. DARTANYAN GASANOV: Behind him.
- MR. DAMIEN GASANOV: He -- my brother followed behind him,
- 4 | watched his -- him driving it and, like he said, it's --
- 5 MR. DARTANYAN GASANOV: He's professional driving.
- 6 MR. DAMIEN GASANOV: He seems, he seems like a -- he knows
- 7 what he's doing.
- 8 BY MR. FOX:
- 9 Q. Now earlier in our interview you mentioned that for about 30
- 10 days you would drive with a new driver.
- 11 A. Yep.
- 12 Q. But you did not do that with this driver?
- 13 A. He's a, he's a -- he was in 30-day trial. And not all of
- 14 | them are going through all 30 days. Some of them you can see
- 15 | right away, they doing good in 3 weeks or 2 weeks of the trial.
- 16 If they have experience, you can tell right away. When you
- 17 driving with him, you can tell in first week if the driver know
- 18 what he is doing. The driver, Volodymyr Zhukovskyy, he know how
- 19 to do the logbook. He definitely knew how to drive, how to
- 20 operate the -- our equipments.
- 21 Q. Now did -- you gave him a road test. Did you witness him
- 22 load any equipment? Load any automobiles?
- 23 A. The -- yes. Yes, on the trailer, the first load he did at
- 24 the truck stop. At the dealer?
- MR. DARTANYAN GASANOV: At the yard.

- 1 MR. DAMIEN GASANOV: At the yard. Yes.
- 2 BY MR. FOX:
- 3 Q. And he successfully did that?
- 4 A. He successfully did that, like the driver with a lot of
- 5 experience, to be honest. Because if he won't be able to put that
- 6 on the trailer, he's not going nowhere.
- 7 Q. Now did --
- 8 A. And if you -- to take it off, it would be more
- 9 responsibility. It's harder to take it off.
- 10 Q. Did you do any other training with the driver?
- 11 A. No. Any other trailer -- besides just, just that day on
- 12 Sunday and day on Wednesday when he was get little more training
- 13 with my brother.
- 14 Q. And did you go over any company policies with the driver,
- 15 what's the dos and don'ts with the company?
- 16 A. I mean, the company policies, like they very easy and simple
- 17 policies, like I know be -- just be safe driver, treat the
- 18 customers right, be careful with the loads, like when you unload
- 19 them and load them, stuff like that. Yes, we went through -- with
- 20 this guy, I went through all that, all that. Policy is like if
- 21 you got caught with some type of non-acceptable violation,
- 22 something that, yeah, it's like it really will show it's your
- 23 | fault, you will lose your job right away, you're not qualifying to
- 24 get hired with us. Yes, I went through all that.
- 25  $\mathbb{Q}$ . Now you said you know that he was familiar with the logbook.

- 1 How do you know that he was familiar with the logbook?
- 2 MR. DARTANYAN GASANOV: He fill out front of me.
- MR. DAMIEN GASANOV: He fill up in front of us.
- 4 BY MR. FOX:
- 5 Q. Did you get a record of his hours of service before he came
- 6 to work for you?
- 7 A. No, sir.
- 8 Q. Do you know if he was working before he came to you? Like a
- 9 couple of days before you, was he pulling loads?
- 10 A. No. I don't know that.
- 11 Q. No. So you don't know or you don't have a record of it or
- 12 | did you ask him?
- 13 A. When did he last time work for somebody, how far? How long
- 14 ago? He says, but I don't remember.
- MR. DARTANYAN GASANOV: He was coming and say he was -- he
- 16 used to work and have that -- we ask him question, and his answer
- 17 was that which companies he was -- you already told him this.
- 18 MR. DAMIEN GASANOV: And --
- MR. DARTANYAN GASANOV: Which companies he was work.
- MR. DAMIEN GASANOV: No, no, no. The question is, when did
- 21 he stop working --
- MR. DARTANYAN GASANOV: No. We are not (indiscernible).
- 23 MR. DAMIEN GASANOV: When did he stop working? When didn't
- 24 him that question. When did he last time --
- 25 BY MR. FOX:

- 1 Q. You didn't ask him? Okay.
- 2 A. -- he stop working.
- 3 Q. Do you have the loads that he pulled for that week?
- 4 MR. DARTANYAN GASANOV: Yes.
- 5 MR. DAMIEN GASANOV: Yes, sir. We have all --
- 6 MR. DAMIEN GASANOV: (Indiscernible) copy, everything.
- 7 BY MR. FOX:
- 8  $\mathbb{Q}$ . So he started the 19th and the crash was the 21st?
- 9 A. 21st.
- 10 Q. So he -- did he -- where did he go; do you know?
- 11 A. The first of all, he take the cars at the yard. He load them
- 12 | in front of us. He done --
- 13 Q. Here locally?
- 14 A. -- logbook in front of us. My driver -- my brother follow
- 15 | him to the gas station, fill him up, and then -- that was on 19th.
- 16 Q. What gas station was that?
- 17 A. The gas -- which gas station did he gas up? The Pride,
- 18 right?
- 19 MR. DARTANYAN GASANOV: Pride.
- MR. DAMIEN GASANOV: Pride gas station in Springfield. It's
- 21 about maybe  $2\frac{1}{2}$ , 3 miles away from our truck stop. And then he
- 22 | went to the -- to deliver the load to the Massachusetts. It's
- 23 like a Boston area, south of Boston. And then --
- MR. DARTANYAN GASANOV: You emailed to the police department,
- 25 which police department.

- 1 MR. DAMIEN GASANOV: To the -- so after that, he went to pick
- 2 | up load in New Hampshire and take it to Maine.
- 3 BY MR. FOX:
- 4 Q. What city?
- 5 A. New Hampshire?
- 6 Q. In New Hampshire.
- 7 A. That was Londonberry [sic].
- 8 Q. London?
- 9 A. Berry.
- MR. DARTANYAN GASANOV: Londonderry.
- MR. DAMIEN GASANOV: Londonderry. Londonderry. We have a
- 12 copies of this loads as well.
- 13 BY MR. FOX:
- 14 Q. Oh. You have copies of the bills of lading?
- 15 A. Yes, sir.
- 16 Q. Okay. And then, from Londonberry, New Hampshire --
- 17 A. He went and delivered that load to the New York -- to the
- 18 Maine. I'm sorry.
- 19 Q. To Maine?
- 20 A. Yes.
- 21 Q. What city?
- 22 A. That was Augusta, Maine.
- 23 Q. He went to Augusta, Maine?
- 24 A. Yep.
- 25 Q. And then --

- 1 A. She stayed there overnight.
- 2 Q. Where did he stay?
- 3 A. Probably somewhere around Augusta area. Or maybe -- depends
- 4 | how far his logbook go. I don't remember --
- 5 MR. DAMIEN GASANOV: Do you remember the town that he stays
- 6 | in?
- 7 MR. DARTANYAN GASANOV: Truck stop, Bangor.
- 8 MR. DAMIEN GASANOV: He stop at the Bangor? He stop at the
- 9 Bangor in Maine. So he delivered the load, because Bangor is more
- 10 north of Augusta. And then in the morning, he pick up the cars.
- 11 There was two vehicles from Maine. He delivered them to
- 12 Massachusetts and Connecticut. He was right on the way home, and
- 13 he stay home on 20th.
- 14 BY MR. FOX:
- 15 0. On the 20th?
- 16 A. Yep. On the 20th, he were at home.
- 17 | O. Home? In his own home?
- 18 A. Yes, sir.
- 19 | Q. Where's home for him?
- 20 A. In West Springfield. He lives in West Springfield. So he
- 21 parked the truck in the yard. He got home.
- 22 Q. Okay.
- 23 A. And then after that, in the morning, he was empty, so he went
- 24 to Albany, pick up the load.
- MR. COLLINS: And this was the morning of the 21st?

MR. DAMIEN GASANOV: Yes. And, he went to delivery and he delivered the car in New Hampshire. And --

BY MR. FOX:

- Q. Wait. He went from Albany to where?
- 5 A. New Hampshire, just with one car.
- 6 Q. One car to New Hampshire?
- 7 A. Yes, sir. And after he deliver car, he was on the way home,
- 8 empty. On the way to New Hampshire, when he pick up the car, we
- 9 called him several times. All day long, he didn't answer the
- 10 phone. And we have -- we print out the document up, too. We
- 11 print that he wasn't answer -- he wasn't communicating for all
- 12 day. And then at the end of the day, only at end of the day,
- 13 after the crash happened, he called for a few seconds to my
- 14 brother and tell him he involved into the accident with the --
- 15 | with some bike drivers, he said, and hang up after that and didn't
- 16 answer the phone at all.
- On the way to New Hampshire, when he was going to deliver the
- 18 car, he -- when he were not -- non-communicating -- that's another
- 19 policy of the company. If you not communicating on your training,
- 20 | it means you not -- you probably not going to communicate at all
- 21 When you at work. So that's not going to work, so you losing your
- 22 job. Either he's had bad service or something. I don't know.
- 23 But we tried several times.
- Right at that moment when my brother call me and say he's not
- communicating the run, probably 4:30, before the crash happened, I

- 1 | call the driver that used to work for me in medical transportation
- 2 −− his name is David Pedrosa (ph.) -- and ask him if he wants --
- 3 | if he still wants to get a job. He told me yes. And I text him
- 4 at 5:38, I text my brother with the David Pedrosa's phone number
- 5 and the name after I talked to the David and David say, yes, I
- 6 | would love to join you guys. But it was too late.
- 7 Q. Right. You said you have copies of the bills of lading for
- 8 these loads that we went through?
- 9 A. Yes, sir. We do. It should -- you -- did you find them?
- MR. DARTANYAN GASANOV: Yeah, send me -- we should send it to
- 11 | the police department.
- 12 MR. DAMIEN GASANOV: Yes.
- MR. DARTANYAN GASANOV: Send me over, I'll print it up and --
- 14 MR. DAMIEN GASANOV: But we have them right, right here.
- 15 They on the table.
- MR. DARTANYAN GASANOV: That?
- MR. DAMIEN GASANOV: Yes, they on the table. Let me see
- 18 that.
- MR. DARTANYAN GASANOV: No, no. Not --
- MR. DAMIEN GASANOV: She take it out? Okay. They on the
- 21 table.
- MR. FOX: So I'm going to take a pause for a second. I'm
- 23 | going to allow my other, fellow investigators, ask questions.
- MR. DAMIEN GASANOV: Okay.
- MR. FOX: Dennis, you have --

- 1 MR. COLLINS: I have none right now.
- 2 BY MR. COMIRE:
- 3 Q. You said that he wasn't able to communicate with you guys and
- 4 | the only conversation you had was when he called your brother?
- 5 A. That's after accident. It was around probably -- probably
- 6 after 6 o'clock.
- 7 Q. Was this the phone that he called? Your brother's cell phone
- 8 here?
- 9 A. Yes, sir.
- 10 Q. Okay.
- 11 A. We got this, we got this printed too.
- 12 Q. Okay.
- 13 A. So we got --
- 14 Q. You have that printed up, the record of the communication?
- 15 A. Yes, sir.
- 16 Q. Okay. If you'd bring that out, it'd probably be useful.
- 17 MR. FOX: Yes.
- 18 BY MR. COMIRE:
- 19 Q. As far as the conversation, we talked about hiring practices.
- 20 You know, this guy came in, he told you he was a CDL driver, there
- 21 wasn't a lot of documentation involved. Did you document any of
- 22 your other drivers' qualifications?
- 23 A. The same procedure, I do with them all. This is like non-CDL
- 24 | combination, like I said. They don't require as, like -- I just
- 25 was going by law. I should, I should go -- I should add more

- 1 of --
- 2 Q. Yeah.
- 3 A. Yeah. I should add more of my procedures. Hopefully, would
- 4 be big lesson for all the country, to be honest with you.
- 5 MR. FOX: Yeah. All right. So I think we'll take another
- 6 pause for minute.
- 7 MR. DAMIEN GASANOV: Thank you.
- 8 (Off the record.)
- 9 (On the record at 1:06 p.m.)
- MR. FOX: We're back on the record. The time is 1:06 p.m.
- 11 BY MR. FOX:
- 12 Q. I'm looking at your insurance policy. I see four vehicles:
- 13 a 2016 Dodge, two 2017 Dodges, and a 2018 Dodge Ram.
- 14 A. Yep.
- 15 Q. Is this -- so this is just four vehicles?
- 16  $\blacksquare$  A. It should be two more somewhere else. That would be a 2018
- 17 GMC 3500 and 2018 Chevy 3500.
- 18 Q. I don't see the -- there's only one that has a VIN on it, the
- 19 2018 Dodge Ram. The other, the others don't --
- 20 A. The insurance it's -- that's not the right paper, probably.
- 21 We will provide you with the better paper that would have --
- 22 Q. That have the full listing of --
- 23 A. Yep.
- 24 Q. -- of all your equipment --
- 25 A. Yes, sir.

- 1 | Q. -- because it doesn't show it's on there.
- 2 A. Okay.
- 3 Q. And it's not in these other documents. So we'll have to --
- 4 I'm just asking for it.
- 5 A. Yep. We got to get them from insurance. I'm pretty sure
- 6 | I'll be able to get that.
- 7 Q. And then would the insurance company also provide a list of
- 8 your drivers?
- 9 A. No, I don't -- not that I know.
- 10 Q. They don't list a -- listing of your drivers?
- 11 A. I got to ask my wife about that.
- 12 Q. Have you had any accidents in the past year?
- 13 A. No, sir.
- 14 Q. Besides this one?
- 15 A. No, sir.
- 16 Q. None at all?
- 17 A. No.
- 18 Q. Okay. Lost my page here. How do you pay your drivers?
- 19 A. It's goes by the -- it's -- it goes by the percentage. Yeah.
- 20 | It's --
- 21 Q. Percentage?
- 22 A. Yeah.
- 23 Q. What's the percentage?
- 24 A. It's 25 percent, like all the car haulers are doing in this
- 25 industry.

1 Q. So they get 25 percent profit?
```

- 2 A. Yep. And all -- ends up with being about \$200 a day.
- 3 Q. 200 a day?
- 4 A. Yep. Between 180 to 200.
- 5 Q. And when do you pay?
- 6 A. Every weekends when they come back to the truck stop, they
- 7 getting paid.
- 8 MR. FOX: Stand by.
- 9 (Telephone interruption.)
- 10 (Off the record.)
- 11 (On the record.)
- MR. FOX: I'm sorry for the interruption. I got a phone
- 13 call. So we're back on the record.
- 14 BY MR. FOX:
- 15 Q. We were talking about pay for the drivers. They get
- 16 compensated 25 percent of the load, which is about \$200 per day?
- 17 A. Yep.
- 18 Q. How often do you pay your drivers?
- 19 A. Every week. Weekly.
- 20 Q. Weekly?
- 21 A. Yes, sir.
- 22 Q. And do you have any other -- do you have any benefits or
- 23 anything for the drivers? Do they get any kind of other
- 24 compensation? Insurance? Do they get health benefits or
- 25 anything?

- 1 A. No, sir.
- 2 Q. No?
- 3 A. They are independent contractors. So they have to -- I mean,
- 4 they will have what they want.
- 5 Q. And do you have any other -- do you have any kind of reward
- 6 program for safe driving?
- 7 A. If the driver gets no violation, it's between 50 to \$100.
- 8 | always like to tip them up.
- 9 Q. For a roadside inspection?
- 10 A. For a roadside inspection, if they pass safety and all that
- 11 DOT inspection. Yep.
- 12 Q. And is there any other incentive program that you have?
- 13 A. If they pass -- if they did the -- if they got the violation,
- 14 they're not getting a bonus for next non-violation. So they have
- 15 to follow the policy and the rules.
- 16 Q. Do you hold any safety meetings with your drivers?
- 17 A. Every week.
- 18 Q. And where is this held?
- 19 A. At truck stop. On the phone.
- 20 Q. Oh, on the phone. You call them?
- 21 A. No, no. It's like on the top of that. Every week on -- at
- 22 the truck stop, always on the phone, when something that comes up
- 23 on my mind and it's something new, then I call all the drivers.
- 24 They have a headsets, so it's legal for them to answer the call.
- 25  $\mathbb{Q}$ . You do this all at once? You call all the drivers at once or

- 1 do you call them individually?
- 2 A. I'll call individually. Some -- yeah.
- 3 Q. Is this documented?
- 4 A. Just the notes on my phone. I put the notes all the time,
- 5 saving what do I have to talk with the drivers about.
- 6  $\|Q$ . So these are notes that we could look at later --
- 7 A. Yes, sir.
- 8 Q. -- on your phone? Okay. Do you have any other terminals or
- 9 businesses that you operate out of this facility?
- MR. DARTANYAN GASANOV: Yes. East Transport.
- MR. FOX: So you have East Transport?
- 12 MR. DAMIEN GASANOV: We also have --
- 13 MR. DARTANYAN GASANOV: LLC.
- MR. DAMIEN GASANOV: -- East Transport, LLC.
- 15 BY MR. FOX:
- 16 Q. And what does that company do?
- 17 A. Same, exactly. They hauling the cars. It's my brother.
- 18 Q. And who owns that company?
- 19 A. Dartanyan.
- 20 MR. FOX: You own that company too?
- 21 MR. DARTANYAN GASANOV: I'm trying it by myself.
- MR. FOX: And how many drivers do you employ there?
- MR. DAMIEN GASANOV: Just Dartanyan.
- MR. DARTANYAN GASANOV: Just me.
- 25 MR. FOX: Just yourself?

- 1 MR. DARTANYAN GASANOV: Yeah. And then, I have friend of
- 2 mine. His name Tonio -- not Tonio -- Jose el Nieves (ph.),
- 3 Nieves.
- 4 MR. DAMIEN GASANOV: Okay. See, he have a friend of him that
- 5 help drive for him sometime. They both operating the electronic
- 6 logbook.
- 7 MR. DARTANYAN GASANOV: Yep. I have (indiscernible) --
- 8 MR. DAMIEN GASANOV: They both have a E-ZPass and --
- 9 BY MR. FOX:
- 10 Q. Is this CDL required equipment?
- 11 A. No. Just a basic two car hauler, small two car hauler
- 12 combinations. Oh -- yeah, two car.
- 13 Q. Are you affiliated with any other companies?
- 14 A. No.
- 15 Q. So it's just East Transport and then --
- 16 A. Westfield Transport.
- 17 Q. -- Westfield Transport? What's the purpose of having two
- 18 different companies like that?

MR. FOX: So this is Michael Fox, investigator for the NTSB out of Washington, D.C., Office of Highway Safety. I'm here at East Transport, LLC, Avenue in West Springfield, Massachusetts. Today is June the 28th, 2019, right? And there's some folks in the room. Similar to our other conversation, we'll just go around the room and just, if you could, state your name and then spell your last name.

MR. DARTANYAN GASANOV: And I'm Dartanyan Gasanov. So I'm also owner of the company.

MR. FOX: Okay. So today, we wanted to clarify a couple of things that we were going over during our first initial interview with the motor carrier. Let's start at the top with the accident driver that was involved in the crash, Volodymyr. Can you please explain how you hired the accident driver? I think it's a little different than what you were explaining to me in the car, that he was someone's son or a relative of a landlord. Can you elaborate on that?

MR. DAMIEN GASANOV: But that has nothing to do with the

1 hiring, though. It didn't make any changes on the hiring. MR. FOX: Well, let me ask a different question, then. 2 MR. DAMIEN GASANOV: Yes, sir. 3 MR. FOX: How did you know the accident driver? 4 5 MR. DAMIEN GASANOV: He always been around. We see a lot of 6 people down here. And also, we know him as a -- we used to live 7 in Westfield. That's why we named the company as Westfield 8 Transport. 9 And Westfield, is that Westfield, Massachusetts? 10 MR. DAMIEN GASANOV: Massachusetts, yes. 11 MR. FOX: Okay. 12 MR. DAMIEN GASANOV: And then when he come to that place -- I 13 mean, the landlord has a son the same age as Volodymyr. MR. FOX: And who is the landlord? 14 15 MR. DAMIEN GASANOV: Landlord was -- what's his name? Ι 16 don't remember his name. 17 What was the landlord's name? 18 MR. DARTANYAN GASANOV: Silosi (ph). 19 MR. DAMIEN GASANOV: Oh, his last name was Silosi. So he 20 have a son the same age as Volodymyr. So Volodymyr was around, I 21 would say, several times. I see them down there. Back in the 2.2 day, back in then, I believe they were going to school together. So these were two young men or boys together 2.3 2.4 growing up? 25 MR. MR. FOX: So, and then how did you -- aside from you just seeing him as a child, how did it come about that he wanted a job for the company?

MR. DAMIEN GASANOV: Also, after this -- obviously, it's a small town. So we're in the car transportation business. All the transportation businesses in this town, the majority of them, almost all of them gas up at the Pride gas station.

MR. FOX: Where is the Pride gas station?

MR. DAMIEN GASANOV: In Springfield. Right across the bridge. And then I see him a million times over there driving for different companies. I didn't pay attention what's on the door, but I kind of knew sometime he work for Mass Transport. I knew he worked for FBI Transport. And there is other companies I've seen him working. I even see him when he were training as a driver, too. I mean, I remember him working when he had no CDL. He began to train and stuff like that. Then, also, I knew he have a DUI in 2013, but I also know -- also, I didn't know that he's having problems with the drugs. We didn't know that. If you guys --

MR. FOX: You didn't know that?

MR. DAMIEN GASANOV: No. If you guys concerned about that, no, we didn't know that. If we have any little potential signs of

anything that saying the driver using the drugs, we do not want them to work for us. Same thing happened to the previous driver long time ago, Andy. As soon as he got caught with marijuana twice in the same -- not the same day, it was at night and then next morning. At night when he got caught, I ask him to come home, sir. And in the -- and at -- oh, he was -- so from Vermont, it took him 2 days to get here somehow. I don't remember what exactly, either 1 day, either 2. And then as soon as he got home, that was his last trip. Even not for crack. It was not for crack or any Class A drugs like heroin. That was marijuana.

Even the marijuana has nothing to do behind the steering wheel. Even if you have a license from your -- a medical license from your doctor that you legally can smoke marijuana, I still won't hire this person.

MR. FOX: Okay. Now the childhood friend of Volodymyr, the accident driver, did he ever have a drug problem, do you know?

MR. DAMIEN GASANOV: One more time? I'm sorry.

MR. FOX: The friend of your -- the landlord's son, did he have a drug problem?

MR. DAMIEN GASANOV: Not in the past. At one point, I asked him if he wants to work for me, or something like that; then he said yes, we been driving around with this kid. And then I got in situation when he tried to do what the guy -- he asked me, he got to pick up his money and his wallet from the guy, can I give him a ride. I said yes, of course. And so I give him a ride and then I

see something fishy is going on. So I just get out of the car right away and I jump into this situation. The guy that bring him his stuff end up being a drug dealer. He ran away to his car and disappeared because of me being upset about and mad about all this.

And then another thing is, I caught -- I grab his hand and I say open up. And when he open, I see some type of bags and stuff. So at that point, I just, you know, I just left him on that street and I left. I -- then I left.

MR. FOX: I see. So when did the accident driver actually start for the company?

MR. DAMIEN GASANOV: Accident driver start for company just like we said in the previous. He come over on Sunday. I even have the dates for you guys. He come over on Sunday, 15th, to the truck stop.

MR. DAMIEN GASANOV: We were in there -- the first round, I say about 2 hours, but I would like to fix myself. He were there almost for half a day. So it was much more than 2 hours with me and the other drivers around this kid, being explained to him what do we see on the road and our experience of what's on the road. Like, we did a big meeting for this. He asked for a job, so we did a big meeting. And I asked him, is your driver's license valid? He said yes. And I asked him, like, do you have a medical card? He said yes. Because if you don't have, you have to get

it. And then I asked him if he -- what else did I -- I asked him a lot of questions.

Like, you know, when I personally hire somebody, we ask them a lot of questions. And I already at that time, I already knew he have a lot of experience of driving the trucks. I see him in the different trucks without a CDL. And then I asked him to show me his license. He showed me. It was a commercial CDL. But at this time, I already knew he was driving the big trucks so he have to have that.

Then we ask him to try the truck and show me if he can just back into the, like an alley dock parking. It's very important because that's -- when you go in to do your driving test for a CDL, they will -- that's one of the hardest -- not one, that's the hardest parking. And I asked him to do it. So he done it perfectly, like professionally. Then next day -- I mean, after we talk about this, make a meeting and everything, we got the paperwork from the kid. And then the same day we got the paperwork from that kid, we check his driving record. His driver license was active, sir.

And then, also, the next day my brother load him on the truck that he got in accident. No, not the next day. I'm sorry. I'm wrong. It was not next day. After Sunday, he show up on the 19th, which is 3 days after that. So we've been checking his driving record and, I don't know, there is probably no loads for him or something. So when the people gets through training, we

1 definitely not pushing them. They're not going crazy with it.

So, in 3 days, he come to the -- on 19th, he come to the yard. My brother was there in the morning and he watch him load the cars onto the trailer. Again, he done it professionally, sir.

Then we have a mileage wise. Each time when the driver sees miles appears on his dashboard up to 10,000, it means time for oil change. So no matter what, he's coming at that point, he's coming to the yard and getting his oil changed. Each time when he's seeing 20,000 on his -- which is 10, 20, 30, 40. So each time when he sees 20, 40, 60, it means he's getting all the fuel filters, all the air filters replaced, with oil on top of that.

Each 50- to 60,000 -- not really 60. I would say each 50,000 miles, which is 50, 100, 150, when the driver realize that he's at the 50 point something, he's coming for -- there is a main filter that stays on the top of the engine that clears the oil, clean the oil for turbos and stuff like that.

The government holds you accountable for that. 3 I think -- you know, an easy way to understand 4 MR. COMIRE: 5 this is, you know, you can see just by looking at this yourself, 6 you can see that this driver did exactly what we've been talking 7 about. 8 MR. DAMIEN GASANOV: I see it. 9 MR. COMIRE: Right. 10 MR. DAMIEN GASANOV: I do see it. 11 MR. COMIRE: You know, if it's common practice amongst your 12 drivers and owners of the company to unplug these because you feel 13 restricted by these rules so that you can make these trips, this 14 is a systemic problem. Like literally, I did see this. And after he got caught the second time, I tell him, listen, I know you're my brother, my cousin. I mean, I have to be nice to you, but this is not about that. This is about you going to hurt me, you're going to hurt people that works for me, you're going to hurt my family, so this is not the way it's going to work. If you get another violation, you're going to get fired. Then he got another violation and he's out.

MR. COMIRE: So what I'm getting at, and I don't -- I understand, you know, your frustration -- he was placed out of service on this day, meaning that he was an out-of-service driver

due to the violation.

MR. COMIRE: Right. So how did he get put out of service the second time, 10 days later?

MR. DAMIEN GASANOV: Because my stupid cousin went home and didn't get -- forget his bag with the medical certificate in it. But I personally, I do know because I have a copy of his medical certificate.

MR. COMIRE: Okay. So you understand, though, that ultimately, as the person dispatching these loads, that you're responsible for a few things. I'm going to run through it real quick. You're responsible to make sure that the loads that you dispatch don't -- are not required to have the driver exceed the hours. That's the first, right?

MR. COMIRE: The second thing is that you cannot dispatch a driver who is not qualified. And you can't dispatch a driver who is in an out-of-service condition without evidence that that condition has been resolved, right?

COMIRE: So that seems to be where this breakdown has been happening, is that you have unqualified drivers who are being dispatched loads -- you have loads that are being dispatched that can't be met within the hours of service regulations. And therefore, what's happening is the drivers are disconnecting and falsifying their logs, et cetera, et cetera, et cetera. Would you agree with that?

MR. DAMIEN GASANOV: Agree with what? That he is not taking his -- he forgot his medical card at home?

We pay for that, so they have to give us also Massachusetts with it, right? That's how it work, no, Robert?

MR. COMIRE: If you're getting the inspection as a statemandated periodic inspection, then you should be receiving the documentation that you need and the evidence to prove it. And I'm not doubting that you did something. I just don't have any evidence to show that you've complied with the state requirement. MR. DAMIEN GASANOV: On the top of that, Robert, I would like to add some more into this comment. The thing is we also getting the federal annual inspection from the factory, they give us. But just because by knowing I need inspection in Massachusetts, I'm not using the factory's inspections. I'm bringing to Massachusetts with the license plate, legally. After that, before I put them on the road, I put them on the insurance. And then before, again, I put them on the road, I put them under inspection in Massachusetts. And that's what it exactly is. MR. COMIRE: Okay. So you're going to need to --MR. DAMIEN GASANOV: Go to the inspection place and get the paperwork? MR. COMIRE: You're going to need to address that issue because --I'll do it. MR.
