2 MR. FOX: This is Michael Fox, investigator, National  
3 Transportation Safety Board. Today is July the 23rd, and I'm  
4 located at [REDACTED] Street, in Westfield, Massachusetts and we're  
5 currently interviewing Pavel, P-A-V-E-L, Ciloci, C-I-L-O-C-I.

6 MR. CILOCI: Ciloci.

7 MR. FOX: Ciloci. I'm -- excuse me.

8 MR. CILOCI: It's okay.

9 MR. FOX: Ciloci, and his wife, Irina.

10 MS. CILOCI: Yes.

11 MR. CILOCI: Ciloci.

12 MR. FOX: Ciloci.

13 MR. CILOCI: Ciloci.

14 MR. FOX: And we're just trying to get some more information  
15 about their son, who was good friends with the accident driver,  
16 Volodymyr Zhukovskyy.

17 (Whereupon, and unidentified speaker translated the questions and  
18 answers for Mr. and Ms. Ciloci, as needed.)

## INTERVIEW OF PAVEL AND IRINA CILOCI

19  
20 MR. FOX: And just so I can -- and you, ma'am, you say you  
21 did know the accident driver?

22 MS. CILOCI: Yes.

23 MR. FOX: And how did you know him?

24 MS. CILOCI: You know, her son was friends with him, that's  
25 why she knew him.

1 MR. FOX: They went to school together; is that what she said?

2 MS. CILOCI: Yes, yes, yes, yes.

3 MR. FOX: Since the fifth grade?

4 MS. CILOCI: Yep. Um-hum.

5 MR. FOX: What school did they go?

6 MS. CILOCI: Went at the West Springfield Elementary School.

7 MR. FOX: And did you also know Dunyadar? Was it Dunyadar?

8 MS. CILOCI: Yeah, Dima (ph.). Yes, because he lived  
9 downstairs.

10 MR. FOX: He lived downstairs?

11 MS. CILOCI: Yes, yes.

12 MR. FOX: How long did he live here?

13 MR. CILOCI: About 5, maybe 4. I don't know.

14 MS. CILOCI: Four or 5 years.

15 MR. CILOCI: Maybe about 5 years, about.

16 MS. CILOCI: Five years.

17 MR. CILOCI: Don't know exactly. I don't -- maybe 4, maybe  
18 5.

19 MS. CILOCI: Yes.

20 BY MR. FOX:

21 MR. FOX: And during that time did your son have a drug  
22 problem?

23 MS. CILOCI: No.

24 MR. FOX: No?

25 MS. CILOCI: Well, Dima (indiscernible) -- well, we called

1 him Dima shortly. When he lived downstairs, she say her son  
2 didn't have any drug problems.

3 MR. FOX: Okay. When did he start to have a drug problem?

4 MR. CILOCI: He looking for job, couldn't found a job, he  
5 start having -- I lot of time spent in factory, not enough.

6 MS. CILOCI: Have enough time for kids.

7 MR. FOX: And so, can they put a timetable on when it was,  
8 when the drug problem was?

9 MS. CILOCI: He's asking me when I moved in because I moved  
10 in 2016.

11 MR. FOX: And was her son -- was their son here?

12 MS. CILOCI: No, no. My son was here. Say around 2016 the  
13 problem started.

14 MR. CILOCI: About, yeah.

15 MR. FOX: And when --

16 MS. CILOCI: (Indiscernible) he said no.

17 MR. CILOCI: We cannot exactly say because he not talking  
18 with us. But later was (indiscernible).

19 UNIDENTIFIED SPEAKER: But that was later. When they found  
20 out it was in 2016.

21 MR. FOX: What kind of drugs was he taking? Do they know?

22 MS. CILOCI: Pills, some pills.

23 UNIDENTIFIED SPEAKER: Some pills.

24 MR. FOX: And so, and they did know? I'm sorry.

25 MS. CILOCI: Yeah, it's okay. Yes.

1 UNIDENTIFIED SPEAKER: So, sorry. 2014, she had surgery and  
2 that's when they found out he stole her painkillers.

3 MR. CILOCI: And we understand she had problem  
4 (indiscernible).

5 MS. CILOCI: About 2014, about.

6 MR. FOX: 2014?

7 MS. CILOCI: Yes.

8 UNIDENTIFIED SPEAKER: That's when they find out, when he was  
9 report.

10 MR. CILOCI: Found, find out.

11 UNIDENTIFIED SPEAKER: But they don't know exactly how long  
12 that they didn't know.

13 MR. FOX: And at that time, he was still best buddies with  
14 Volodymyr?

15 MR. CILOCI: No.

16 UNIDENTIFIED SPEAKER: Yes. Yes.

17 MR. CILOCI: But he living in Florida -- no?

18 UNIDENTIFIED SPEAKER: They were friends, yeah. They're just  
19 try to figure, you know, remember everything.

20 MR. FOX: And did they think, did they, did they know if  
21 Volodymyr had a drug problem?

22 UNIDENTIFIED SPEAKER: They don't know. They have no idea.  
23 They work separately.

24 MR. CILOCI: Separate the work.

25 MS. CILOCI: Yes, yes, because --



1 UNIDENTIFIED SPEAKER: (Indiscernible) was working in  
2 construction and she doesn't know where the Volodymyr was.  
3 Sometimes they working on the (indiscernible).

4 MR. CILOCI: You know, we came together, spend time.

5 UNIDENTIFIED SPEAKER: Yes, spend time together on weekends.

6 MR. FOX: And I think they said that he went to some  
7 rehabilitation, their son?

8 UNIDENTIFIED SPEAKER: Yeah.

9 MR. FOX: What, do you, where did he go?

10 MR. CILOCI: Philadelphia.

11 UNIDENTIFIED SPEAKER: Philadelphia.

12 MR. FOX: Do they know where?

13 UNIDENTIFIED SPEAKER: They don't remember. Sometimes there  
14 was the jealous.

15 MR. FOX: Did he go to more than one rehab?

16 UNIDENTIFIED SPEAKER: Yeah, more than one.

17 MR. FOX: Where else?

18 UNIDENTIFIED SPEAKER: Florida. And Florida. So, Florida --

19 MR. CILOCI: Two times.

20 MR. FOX: Twice, at the same facility?

21 MS. CILOCI: Yes.

22 MR. CILOCI: Yeah, probably, yes.

23 MS. CILOCI: Yes, yes. I think yes.

24 MR. FOX: What made him go to Florida?

25 MR. CILOCI: My daughter live in Florida here. She called,

1 come here.

2 MR. FOX: I see. Are you still in touch with your son?

3 MR. CILOCI: Yeah.

4 MS. CILOCI: Yes, yes. Yes.

5 MR. CILOCI: Through phone.

6 MR. FOX: Through phone, yeah.

7 UNIDENTIFIED SPEAKER: Just phone calls.

8 MR. COMIRE: Were these programs court ordered due to  
9 something that your son got into trouble with, or was this  
10 something that you helped him get into?

11 MR. CILOCI: No.

12 UNIDENTIFIED SPEAKER: The first one, first one was court.

13 MR. COMIRE: And was that in Florida, though?

14 MR. FOX: No, the first one was Philadelphia.

15 UNIDENTIFIED SPEAKER: (Indiscernible) away from here. You  
16 have to come and check, the court has the order for that one.  
17 Yes. But our for --

18 MR. FOX: Did he get arrested for a drug problem?

19 UNIDENTIFIED SPEAKER: Yes, he got --

20 MS. CILOCI: No.

21 MR. CILOCI: No.

22 UNIDENTIFIED SPEAKER: He had a different problem that he  
23 got --

24 MR. COMIRE: Where did the arrest occur? Was it here in  
25 Massachusetts?

1 MS. CILOCI: It was, yes.

2 MR. COMIRE: And so the court in Massachusetts, as part of  
3 his conditions, ordered him to attend a drug treatment program?  
4 Is that what happened?

5 MR. CILOCI: Yeah.

6 UNIDENTIFIED SPEAKER: I think so.

7 MR. CILOCI: No, I --

8 MR. COMIRE: Which court was that? You said, Belchertown?

9 MS. CILOCI: Yes, yes.

10 MR. FOX: It's Robert Comire, special agent, FMCSA, who's  
11 also asking questions.

12 MR. COMIRE: Westfield?

13 MS. CILOCI: Yeah.

14 MR. COMIRE: Okay. So the Westfield court. Your son was  
15 involved in some sort of an altercation.

16 MR. FOX: About what year?

17 MR. COMIRE: Do you recall what year that was?

18 MR. FOX: 2014 or so, right, maybe? What is your son's name?

19 MR. CILOCI: Mark.

20 MR. FOX: Marc, M-A-R-C?

21 MS. CILOCI: Yes.

22 MR. CILOCI: Mark.

23 UNIDENTIFIED SPEAKER: With a K. K.

24 MR. FOX: K?

25 MR. CILOCI: No. Mark was there already in more 1 year now

1 no using.

2 MR. COMIRE: He has the same last name?

3 UNIDENTIFIED SPEAKER: Yes, yes, yes.

4 MS. CILOCI: But I don't remember when he last time, what  
5 time. Sorry. I think it's -- well, it's '14, '15. Maybe '15.

6 MR. COMIRE: '14, '15 time frame?

7 UNIDENTIFIED SPEAKER: Yes.

8 MR. CILOCI: Maybe.

9 MR. COMIRE: And, you know, if you're okay with telling us,  
10 do you recall what the actual incident was that caused him to go  
11 to court?

12 UNIDENTIFIED SPEAKER: They got in somebody's house and stole  
13 something.

14 MR. COMIRE: Okay. Thank you. And so that happened here in  
15 Massachusetts? Court conditions were a drug treatment program?

16 UNIDENTIFIED SPEAKER: He was under -- he wasn't 18, so --

17 MS. CILOCI: It was 6 years ago, 6, 7 years ago.

18 UNIDENTIFIED SPEAKER: Seven years ago.

19 MS. CILOCI: It was, yes, yes, before then.

20 MR. COMIRE: And then you said he had attended two other  
21 programs in Florida?

22 MS. CILOCI: Yes. Um-hum.

23 UNIDENTIFIED SPEAKER: Yeah.

24 MR. COMIRE: Were those programs that you helped him get into  
25 or were those --

1 UNIDENTIFIED SPEAKER: Yeah, that they helped him.

2 MS. CILOCI: We (indiscernible) paid.

3 UNIDENTIFIED SPEAKER: It was (indiscernible).

4 MR. COMIRE: It was through the church?

5 MS. CILOCI: Yes.

6 MR. CILOCI: Yeah.

7 MR. COMIRE: And do you have any information related to that,  
8 that you could tell us that would help us locate the program that  
9 he was in?

10 MR. FOX: What's the date of birth of your son?

11 UNIDENTIFIED SPEAKER: [REDACTED].

12 MR. FOX: [REDACTED]? His birth date? Your son's birthday is [REDACTED]  
13 [REDACTED]?

14 MS. CILOCI: Not [REDACTED]. [REDACTED].

15 MR. CILOCI: [REDACTED]

16 MR. FOX: I'm sorry. I apologize.

17 MS. CILOCI: [REDACTED].

18 MR. FOX: [REDACTED]?

19 MS. CILOCI: [REDACTED].

20 MR. FOX: Okay. Good. I don't see him listed here because  
21 he's no longer a resident. He's now a resident of Florida?

22 MS. CILOCI: No.

23 MR. CILOCI: No.

24 UNIDENTIFIED SPEAKER: Because I don't have any forms.

25 Sorry.

1 MR. FOX: But he lives in Florida?

2 UNIDENTIFIED SPEAKER: Yeah.

3 MR. CILOCI: Yeah. Yeah, live and working in Florida.

4 UNIDENTIFIED SPEAKER: And works.

5 MR. CILOCI: Works.

6 MR. FOX: So he's still a resident here?

7 MR. CILOCI: No.

8 MS. CILOCI: Alaska.

9 MR. CILOCI: In Alaska, live in Alaska.

10 MR. FOX: He lives in Alaska?

11 MS. CILOCI: Yes, yes, yes. He's not here.

12 MR. FOX: I thought he said he lives in Florida.

13 MR. CILOCI: His friend, we have sent him.

14 MS. CILOCI: Was October, I think. October will be 1 year,  
15 because he live in Florida --

16 UNIDENTIFIED SPEAKER: Because he lived in Florida.

17 MR. FOX: Oh, lived in Florida.

18 MS. CILOCI: Yes. After and then friend send the  
19 (indiscernible) --

20 UNIDENTIFIED SPEAKER: So one of the friends told him to go  
21 to Alaska like farther from his friends and drugs and stuff like  
22 that.

23 MR. COMIRE: Florida, 90 degrees, hot and humid --

24 UNIDENTIFIED SPEAKER: Yes, yes.

25 MR. COMIRE: -- to Alaska.

1 UNIDENTIFIED SPEAKER: Yes, yes, yes. But that's where, it's  
2 really good. That was good.

3 MR. CILOCI: A Couple of days ago it was temperature in  
4 Alaska was --

5 MR. FOX: And like 90.

6 MR. CILOCI: Yeah, like Florida, same temperature.

7 MR. FOX: Yes, it was.

8 MR. COMIRE: Does your son speak pretty good English?

9 MS. CILOCI: Yes. Yes.

10 MR. CILOCI: Yeah.

11 MR. COMIRE: He does?

12 MS. CILOCI: Yes, yes.

13 MR. COMIRE: You said you spoke to him recently.

14 MR. CILOCI: Yeah, of course.

15 MR. COMIRE: Do you have a contact number for him?

16 MS. CILOCI: Yes, yes.

17 MR. CILOCI: Yeah. Yes.

18 MS. CILOCI: I think it will be better if you call him.

19 MR. FOX: Yeah, we can give him a call. Yes.

20 MS. CILOCI: Yeah.

21 MR. CILOCI: Yes.

22 MR. FOX: What's his phone number?

23 MS. CILOCI: Here, one second.

24 MR. COMIRE: Do they have phones in Alaska?

25 MR. CILOCI: Okay.

1 MS. CILOCI: Oh yes. Yeah.

2 MR. CILOCI: One --

3 UNIDENTIFIED SPEAKER: Okay. Hold on.

4 MR. CILOCI: Do you see?

5 MR. FOX: It's [REDACTED].

6 MS. CILOCI: Oh, now his good --

7 UNIDENTIFIED SPEAKER: Now he's going to church and stuff,  
8 so --

9 MR. FOX: [REDACTED]. No, I know. And he's not in trouble.  
10 Again, we're just trying to get more information about the  
11 accident driver.

12 MS. CILOCI: Okay. Because --

13 MR. FOX: And again, at any time when your son and Volodymyr  
14 were together, did you ever see Volodymyr with a drug problem?

15 MS. CILOCI: He was nice.

16 MR. CILOCI: No.

17 MS. CILOCI: On the chill side.

18 UNIDENTIFIED SPEAKER: Yeah, she -- they said he had  
19 problems.

20 MR. FOX: And you know that? They did know that?

21 UNIDENTIFIED SPEAKER: Yes. They're not 100 percent sure, so  
22 I'm not sure. She heard somebody was saying it, but she  
23 personally haven't never see him doing drugs or him doing  
24 anything.

25 MR. FOX: Volodymyr?



1 UNIDENTIFIED SPEAKER: Yeah.

2 MR. FOX: But she had heard rumors that he had --

3 UNIDENTIFIED SPEAKER: Yeah.

4 MR. FOX: -- was --

5 UNIDENTIFIED SPEAKER: She heard rumors.

6 MR. FOX: And do you think that he influenced your son?

7 MS. CILOCI: No.

8 MR. CILOCI: No.

9 UNIDENTIFIED SPEAKER: No, they don't think so.

10 MS. CILOCI: I think it was separate.

11 MR. FOX: Separate?

12 MS. CILOCI: Yes.

13 MR. CILOCI: He would -- Mark work always in construction.

14 MS. CILOCI: Yes.

15 MR. CILOCI: Now Volod cannot work in construction. Separate  
16 the work.

17 UNIDENTIFIED SPEAKER: So they're saying their son was  
18 working construction and Volodymyr was working somewhere else. So  
19 he probably got hooked on it somewhere else and their son got  
20 hooked on it somewhere else.

21 MR. CILOCI: Oh, no we can't. We can't (indiscernible) --  
22 (Phone ringing.)

23 MR. FOX: I'm here in -- let me come and get you.

24 MR. BRAGG: Okay.

25 MR. FOX: Are you outside?

1 MR. COMIRE: I can go down and grab him if you want to keep  
2 talking.

3 MR. FOX: All right. I'm in that [REDACTED]. But I'm up  
4 here conducting an interview. I'm going to send down Beau to get  
5 you.

6 MR. COMIRE: I'm just going to run down and go get one of our  
7 associates.

8 MS. CILOCI: Okay.

9 MR. FOX: My supervisor is coming. So I'm sorry for all this  
10 upsetment, but he'll only be -- well, we're almost finished.

11 MS. CILOCI: Okay.

12 MR. FOX: So she thinks -- she's not, she's not certain if --  
13 she stepped away.

14 UNIDENTIFIED SPEAKER: Yeah, she's just (indiscernible).

15 MR. FOX: Yes. Again, I'm sorry, ma'am, for interrupting.  
16 This is just --

17 MS. CILOCI: It's okay.

18 MR. FOX: This is an urgent matter and we'll get out of here  
19 in another minute. So I apologize.

20 MR. CILOCI: But it's okay. Don't worry.

21 MS. CILOCI: I'm just cleaning. Sorry.

22 UNIDENTIFIED SPEAKER: Yes. She was in the middle of  
23 cleaning the house.

24 MR. FOX: So, yeah, of course. Now it was my understanding  
25 that -- it was my understanding that Damien --

1 MS. CILOCI: Dima, yes.

2 MR. FOX: -- he saved your son's or intervened for their son.

3 MS. CILOCI: What do you mean?

4 MR. FOX: That he saw their son doing drugs and he stopped  
5 your son from doing drugs.

6 MR. CILOCI: No.

7 MS. CILOCI: No, no, no.

8 MR. CILOCI: Only what --

9 UNIDENTIFIED SPEAKER: He gave him a job, you know, like to  
10 help him to fix his life.

11 MR. FOX: Say that one more time?

12 UNIDENTIFIED SPEAKER: He tried to help him find a job  
13 somewhere at a restaurant, Damien.

14 MR. FOX: Yes. To find him a job in a restaurant?

15 MS. CILOCI: Yes, yes.

16 MR. CILOCI: Springfield. Yeah, that restaurant.

17 MS. CILOCI: West Springfield.

18 MR. FOX: What restaurant?

19 MS. CILOCI: A pizzeria.

20 MR. FOX: Yeah, pizzeria?

21 MR. CILOCI: Yeah, West Springfield market.

22 MR. FOX: McCrory's?

23 MS. CILOCI: What? McCrory's did he say, yeah?

24 MR. FOX: Yes.

25 MS. CILOCI: I don't know.

1 UNIDENTIFIED SPEAKER: Somewhere in West Springfield.

2 They're not sure. He was too young so nobody would hire him.

3 MR. FOX: Right. Right. But he did get a job in a pizzeria?

4 UNIDENTIFIED SPEAKER: Yeah.

5 MS. CILOCI: Yes. Right.

6 UNIDENTIFIED SPEAKER: Dima, I guess.

7 MR. FOX: But did Damien, did he try to intervene with your  
8 son's drug problem?

9 UNIDENTIFIED SPEAKER: When father find out that Mark has  
10 some problems, so Dima told them that look out, so he will be like  
11 staying away from his friends, their son. They're like, so --

12 MR. FOX: Damien was trying to be a positive influence?

13 UNIDENTIFIED SPEAKER: Yes.

14 MS. CILOCI: Yes, yes, yes.

15 UNIDENTIFIED SPEAKER: So Mark wouldn't tell them, the  
16 parents anything, so Dima just told them like maybe you should,  
17 guys, keep your son away from his friends. Because he was working  
18 about 10, 12 hours a day, so they didn't really have much time to  
19 keep an eye on him, you know.

20 MR. CILOCI: Not enough time spend.

21 UNIDENTIFIED SPEAKER: He didn't pay enough attention, like  
22 spend enough time with his son.

23 MR. CILOCI: Yeah.

24 MR. FOX: Okay.

25 MR. CILOCI: Now good. No more trouble.

1 UNIDENTIFIED SPEAKER: Now everything is good with Mark.

2 MR. FOX: Okay. Very good. And tell them that we're -- I'm  
3 glad that everything is good with their son.

4 And did they -- are they aware of the accident?

5 UNIDENTIFIED SPEAKER: Yeah. I mean, we all watched the  
6 news.

7 MS. CILOCI: Yes, yes, yes.

8 MR. CILOCI: And I read the news. Yes.

9 MR. FOX: Now have they ever heard of Bros Transportation?

10 MS. CILOCI: What? Bros?

11 MR. FOX: Bros Transportation?

12 MR. CILOCI: No.

13 MS. CILOCI: No.

14 UNIDENTIFIED SPEAKER: No, what were --

15 MR. FOX: That's Dartanyan's company.

16 MS. CILOCI: Oh, it is?

17 MR. FOX: It's supposed to be here at [REDACTED] Street.

18 UNIDENTIFIED SPEAKER: Because he -- I mean, he doesn't have  
19 no mailbox, so he's not sure. He never heard of the company.

20 MR. FOX: Does he still -- does Damien still have an office  
21 here?

22 UNIDENTIFIED SPEAKER: I live there.

23 (Knock at the door.)

24 MR. CILOCI: Yeah, come in.

25 MR. FOX: You live, you live --

1 UNIDENTIFIED SPEAKER: I live on the first floor where he  
2 used to live.

3 MR. FOX: You live in the same apartment that he used to live  
4 in?

5 UNIDENTIFIED SPEAKER: Yes.

6 MR. COMIRE: (Indiscernible) right now just in case --

7 UNIDENTIFIED SPEAKER: No office there. That's for sure.

8 MR. FOX: So you used to -- you took over the Damien's --

9 UNIDENTIFIED SPEAKER: Yeah. When they moved out, I moved in  
10 after a little while, because they were going to do the painting  
11 and stuff.

12 MR. FOX: Okay. Perhaps -- this is my supervisor.

13 MS. CILOCI: Hello.

14 MR. FOX: Perhaps when we go, he can call his son and let  
15 them know we were here.

16 MS. CILOCI: Okay.

17 MR. FOX: And that we will try to give him a call so that  
18 they would -- he would be able to take our phone call.

19 MS. CILOCI: Okay.

20 MR. CILOCI: Yes. Okay. I call him. It's 4 hours  
21 different.

22 MR. FOX: Yeah. So it can be later. It can be later on, but  
23 I will try to give him a call just to ask my own questions to him.

24 MR. CILOCI: Okay.

25 MS. CILOCI: Okay.

1 MR. FOX: So -- but again, during the time that you knew  
2 Volodymyr, you did not -- you only just heard that he had a drug  
3 problem, but they did not witness him have suspicious behavior?

4 MS. CILOCI: No. No. Yes.

5 UNIDENTIFIED SPEAKER: Yes, she just heard but she never  
6 actually saw it.

7 MR. FOX: Okay.

8 UNIDENTIFIED SPEAKER: They never, they didn't really see him  
9 so often, the parents. I mean --

10 MR. CILOCI: They were together in school.

11 UNIDENTIFIED SPEAKER: They went to school, you know, since  
12 they were little kids and stuff, but then I guess they kind of --  
13 when they grew up, they working different jobs and stuff, so --  
14 they saw each other sometimes on the weekends.

15 MR. FOX: Now did you ever see Damien with Volodymyr?
