We have a grass airfield close to us and we assumed since he was flying in different patterns and low to the ground , it was one the the planes from there . We see these planes on a regular bases. I didn't see the crash but my daughter and a friend seen it very low and go out of site , then they heard the crash.

We went in different directions to try and locate the plane to help someone.

I Greg Wyatt, was the first on scene and directed the Jasper county deputies to the location.

Unfortunately the man was deceased.
