Narrative:

Ms. Anderson was about one-half mile from the accident site when she observed the airplane "going up and down," doing "dips in the air." She noted five or six "dips" where the airplane would "come back up" each time. She subsequently observed the airplane enter a "nosedive" and begin "spiraling down." The airplane was initially heading south when it entered the dive and appeared to be intact at that time. As it descended and neared the ground, the airplane "burst into pieces in the air." Shortly afterward, she heard it impact the ground.

Ms. Anderson recalled that it was a "beautiful,	sunny" day, with "no wind."

Narrative:

Mr. and Mrs. Edwards were about one-half mile from the accident site when they heard the airplane. Mrs. Edwards noted the airplane "got really loud" and initially she thought it was doing aerobatics or crop dusting.

Mr. Edwards observed the airplane descending in a 70° to 80° nose down attitude. It appeared to be in a left spin/spiral and may have been inverted. The engine sounded like it was at a "high, extreme rev" as if it had no load against it. As the airplane descended thru about 1,000 feet above ground level, parts started to separate from the airplane. He responded to the accident site. He recalled seeing some light smoke at the site and smell what seemed to be some burning plastic; no fire was visible. There was some paper still in the air, falling at the site.

Mr. and Mrs. Edwards recalled that it was a "very nice" day. The wind was about 5 mph from the south
There were some high clouds and no restrictions to visibility.
