INTERVIEW OF TAD DUARTE

MR. DUARTE: -- Mack was on my right road guarding. And I remember, as we pulled out, taking a left, I looked in my rear view mirror to make sure Big Mack was coming up on my right, which we was. And exact -- all within -- this all happens in seconds. You know, when you tell a story, it sounds like it happens 10 minutes, but, I mean, it all happens in seconds.

So as soon as I took my eyes off my rear view mirror to make sure Big Mack was clear coming up, back up on my right -- because I started it out on the right-hand side and I moved immediately over to the left because I like to be on the left side.

- 13 Q. Okay.

- 14 A. I like to avoid all those storm drains and all the sand and
- 15 | all the edge of the road, where the road and the tar meet.
- 16 Sometimes I find that dangerous over there.
- 17 Q. Sure, sure.
- 18 A. But I moved myself over to the left lane immediately and made
- 19 | sure that Big Mack was coming up on my right. And as soon as I
- 20 took my eyes off the mirror to clear myself from Big Mack, and I
- 21 looked forward, what all happened in the exact one moment, the
- 22 truck was coming across the center line taking the middle of the
- 23 pack out with his truck, and immediately on impact, I'm guessing
- 24 | from the fuel tanks exploding from the motorcycles --
- 25 Q. Right.

- 1 A. -- igniting with the hot engines, everything was a wall of
- 2 fire, immediately. Before the truck even cleared out of the road
- 3 and came to a stop in the ditch, it was already a wall of fire.
- 4 Q. Okay.
- 5 A. It was on impact.
- 6 Q. Right. Yeah, from the gas tanks most likely. You are
- 7 correct. Yeah.
- 8 A. Yep. Yeah. And the first thing I did was to avoid, was to
- 9 | veer to the left, because I couldn't go straight or to the right
- 10 because that's where all the action was going. So I just veered
- 11 to the left. And I remember Hayward being right in front of me,
- 12 Doug, and we both veered to the left because I have photographs of
- 13 -- as soon as it happened, first thing I did was I called -- first
- 14 thing I did, as soon as I got off the bike, I said to my wife, are
- 15 you okay? She was. I shut the bike off right there on the -- in
- 16 the lane with the opposite direction coming at me on the edge of
- 17 | the tar, and I immediately pulled my phone out to call 911.
- And I remember not being able to do nothing because I had
- 19 leather gloves on and the push button thing wouldn't work. So I
- 20 | had to rip my gloves off to make the phone call. And I made the
- 21 | call to 911 to let them know where we were, what we have. And
- 22 once I cleared myself with 911, I told them, I said, I'm hanging
- 23 up, I need to go assist.
- 24 So I hung up, and while I had my phone in my hand at that
- 25 exact second, I don't know why, but I just started taking pictures

- of everything laying all over, the bodies, the truck on fire. I just took about a half a dozen pictures real quick.
- 3 And then I put the phone into my pocket, and then I went
- 4 straight to the first one. And I'm not exactly sure who it is
- 5 that was -- the deceased under the trailer, that was pinned in the
- 6 back axel of the trailer under his bike. That was -- I'm not sure
- 7 | if that was Fritz?
- 8 Q. Yeah, I couldn't tell you. I haven't seen those reports yet.
- 9 A. Okay. All right. Because Danny Boy was to my left. I don't
- 10 know how his body was to the left and everybody else's body was on
- 11 the right. My guess was, is that when the truck came through, the
- 12 truck came across, dragged two bikes into the ditch, all on fire,
- and there was three people, being Taz and his wife, were pinned in
- 14 the fire, and the female -- what was her name Desma?
- 15 Q. Desma Oakes, yes.
- 16 A. Yeah, I think she was pinned in the fire also. And -- Desma
- 17 was with Aaron, right?
- 18 O. Yes.
- 19 A. Okay. And Aaron's body -- and I'm not sure if that Aaron's
- 20 body or Fritz's body underneath the trailer. I never really spoke
- 21 to anybody exactly to find out which one that was under the
- 22 | trailer because the -- it was either Desma -- it was either Aaron
- 23 or Fritz or -- and whichever one the opposite was, the other one
- 24 was dead between the tree and the truck on the hill, also.
- 25 Q. Oh, okay.

- 1 A. And then you had Danny Boy, who was not dead on impact. They
- 2 | were trying to give him CPR on the left-hand side of the road, up
- 3 on -- in the grass. And --
- 4 Q. Somehow Big Lou escaped out of there.
- 5 A. Big Lou went over the handlebars, because he was right behind
- 6 Danny. The way I have it, the way I remember it, it was myself,
- 7 Doug Hayward, Lou, and then Danny.
- 8 Q. Right. Okay.
- 9 A. That's how I remember it.
- 10 Q. Yeah, and you were on the inside.
- 11 A. Yes.
- 12 Q. Yeah.
- 13 A. Yeah, and with those names I just mentioned --
- 14 Q. Yes.
- 15 A. -- were all on the inside in front of me.
- 16 Q. Right, right.
- 17 A. Because the pictures I have shows you all those bikes laying
- 18 down in that order. And --
- 19 Q. Would you be able to send me some of those photos? I'm sure
- 20 you probably shared them with the State Police.
- 21 A. Yeah, I can send them to you. Just send them to the number
- 22 | that I called you on?
- 23 Q. That'll be fine. Yeah, this is my cell phone.
- 24 A. Okay.
- 25 Q. Yes, sir.

- 1 A. All right. And, yeah, I can send you those pictures.
- 2 Because I know the second day we were there, the State Police, a
- 3 plainclothes gentleman came --
- 4 Q. Detectives. Yeah.
- 5 A. -- and detectives took a recorded statement also and took
- 6 pictures of my pictures.
- 7 Q. Oh, okay. Yeah we haven't seen --
- 8 A. Because we couldn't --
- 9 |Q. -- we haven't -- we've gotten written statements, but I know
- 10 they recorded some; we haven't gotten those yet.
- 11 A. Right.
- 12 Q. Because, like I said, we kind of share information back and
- 13 forth. But I just -- so I never -- I wanted to get the spelling
- of your name, your last name -- first and last name. Could you do
- 15 | that for me, please?
- 16 A. Yeah, first is T-A-D.
- 17 Q. Tad. Okay.
- 18 A. Yeah, and then D-U-A-R-T-E.
- 19 Q. T-E, okay.
- 20 A. Yeah, Duarte.
- 21 Q. And your wife's first name?
- 22 A. Deborah.
- 23 Q. Deborah, okay. And this is a good contact number if I wanted
- 24 | to call back and have any follow-ups?
- 25 A. Oh, yeah, this is a good number, yeah.

- 1 Q. Okay. Okay, sir. So you've given me a great description.
- 2 | So you said pulling out you were probably only in second or third
- 3 gear?
- 4 A. Yep.
- 5 Q. When you looked up, and that's when you saw the truck had
- 6 come across --
- 7 A. The truck making contact, yeah.
- 8 Q. Right.
- 9 A. Yeah. My quess is, is from what I've -- I've sat down and
- 10 went over this many a times --
- 11 Q. Yes.
- 12 A. -- and I put everybody's name down on paper, like as if we're
- in the road and circled those that are deceased. And my guess is,
- 14 is the truck took out Fritz, Taz, and Aaron, and I think the
- 15 | trailer whiplashed or fishtailed, if you want to call it, and took
- 16 out the rest of the people. I don't think the truck did all that
- 17 damage. Because there's -- the bodies are so far apart and then
- 18 different sides of the road, that that's my guess from what I can
- 19 look at on paper and from what I visually saw.
- 20 Q. Right. Yeah, I haven't, like -- again, I haven't gotten
- 21 | those documents. I haven't seen those yet. But I know they have
- 22 | sketches and the diagrams and all that of, I'm sure, the post-
- 23 crash.
- 24 A. Yeah, yeah. And Woody being the president, he was dead on
- 25 site. I mean, his brain was in the road and he lost a leq.

- 1 Q. That's horrible.
- 2 A. Yeah. And then his body --
- 3 Q. Are you doing okay from this, sir? Are you doing okay?
- 4 A. Yes. The first few days were tough. I mean, I think the
- 5 part that really, really bothered me the most was that I had
- 6 stopped and let all those folks in front of me and it should have
- 7 | been the other way around. I should have been where they were.
- 8 Q. Oh, right. Yeah.
- 9 A. So that's the part that I was trying to swallow, you know.
- 10 Q. Sure.
- 11 A. Thinking, man, I just put these people in their grave by
- 12 being the gentlemen and letting them in front of me. And that's,
- 13 you know, and I -- but, you know, what if -- you know, it's one of
- 14 those things, what if, could've, you know?
- 15 Q. Yeah, right. Yeah, would a, could a, should a.
- 16 A. Yeah. But you never know, you know. You don't know this is
- 17 going to happen, so --
- 18 Q. Right.
- 19 A. So, but I'm feeling better. And what gets me to, what gets
- 20 | me through this is actually, you know, speaking to people. I
- 21 don't want to -- I don't like to bottle it up, you know.
- 22 Q. How about your wife? Is your wife doing -- is your wife
- 23 doing good too?
- 24 A. She's doing better. Yeah, she took I it hard. Yeah, she's
- 25 doing better. Yeah.

- 1 Q. Yeah. Okay.
- 2 A. She's doing better.
- 3 Q. Well, I'd ask for a statement from -- I'm sure she'd probably
- 4 | tell me pretty much everything you did, or would she have anything
- 5 more to add?
- 6 A. No, I think she saw exactly what I saw. Because, you know,
- 7 we were both looking the same direction at the same time, saw the
- 8 same thing. When she got off the bike, she saw the first body
- 9 underneath the trailer, and then said, that's all she could take
- 10 and then she went back down the hill. She said, I can't see this;
- 11 I got to get out of here.
- 12 Q. Right, right.
- 13 A. And so I said go, go.
- 14 Q. So was that (indiscernible).
- 15 A. Because I had to -- I wanted to -- I went to assist. No she
- 16 just went down the hill a little further where all the people were
- 17 | gathering that were in the cars behind us and --
- 18 Q. Okay.
- 19 A. And then, Woody, the president, for some reason, his wife
- 20 stayed back at the cabins.
- 21 Q. Okay. At the cabins, yeah.
- 22 A. So if she would have been on the bike with him, and who knows
- 23 what would have happened to her, you know?
- 24 Q. Right, right.
- 25 A. So, and then we had three bikes that were at the hotel, the

- 1 cabins also. One guy couldn't get his bike to start so he didn't
- 2 go.
- 3 Q. Okay.
- 4 A. Another guy's wife was feeling ill, so he said, you guys go
- 5 | ahead, I'm going to stay with her, she's not -- feeling ill. And
- 6 another one of our presidents of a chapter, he was inside taking
- 7 | an insulin shot, and we didn't realize it that he was inside and
- 8 | we took off without him, and he missed out going.
- 9 O. Oh.
- 10 A. So there's three more bikes that should have been -- should
- 11 have been, could have been in that accident.
- 12 Q. Yeah. Oh, my gosh.
- 13 A. So, and then the rest of the group was coming in. They got
- 14 there about a half hour after the accident. So they were running
- 15 late. So if they would have been there on time, we would of had
- 16 more bikes. And who knows who would have been in what position,
- 17 but --
- 18 Q. Right.
- 19 A. Again, it's that thing is, well, what if we left 30 seconds
- 20 | earlier or 30 seconds later?
- 21 Q. Right.
- 22 A. But you don't -- you can't control that.
- 23 Q. So when you said when your first group pulled out from the, I
- 24 quess, the further west point, and then you let the other group
- 25 | in, how many bikes would you estimate you let in?

- 1 A. Oh, six to eight.
- 2 |Q. Okay. And those would have been probably the first six or
- 3 eight bikes that are up towards the front, ahead of you?
- 4 A. It would have been --
- 5 Q. Woody, Rib, Demon, Hard Charger, Danny?
- 6 A. No. No, Woody and Demon and Manny and Hooker were in front
- 7 of me from the get-go. I think Dawn was already in front of me.
- 8 The ones that I let in front of me was Danny Boy, Lou, Desma.
- 9 Aaron, Fritz, Taz, because those were all staying in the same
- 10 group of cabins.
- 11 Q. Cabins? Yeah, okay.
- 12 A. Yeah, so that's -- those are the ones that I let in front of
- 13 me.
- 14 Q. Right, okay.
- 15 A. And the majority of them are gone.
- 16 Q. Well, I hate to have to put you through this. I appreciate
- 17 you giving me a call back and giving me all the details
- 18 (indiscernible) --
- 19 A. No, I mean, anything we can. I mean, I hate to say this, but
- 20 | I'd like to see justice, you know, on our part from the guy that's
- 21 like, you know, at fault for making this happen. You know?
- 22 Q. Right.
- 23 A. I'm hoping, you know, he gets --
- 24 Q. Oh, he's going to be doing some hard time, I'm sure.
- 25 A. I hope so.

- 1 Q. Yeah, I don't see how he's going to get out of that.
- 2 A. And I don't want to say that about somebody, but I mean, he
- 3 | really put a -- he really made a mess of people's lives.
- 4 Q. A lot of people's lives, yep.
- 5 A. You now, so -- and then the, let's see, it was Demon, he was
- 6 the one, his leg was mangled. That's the one we put a tourniquet
- 7 on his leg because he was losing so much blood he was turning
- 8 white.
- 9 Q. Right. Yeah.
- 10 A. That's the one that they sent in a helicopter.
- 11 Q. Right. Yes.
- 12 A. And Lou went to the hospital. He came back the next morning.
- 13 Q. Yeah, for being hit, he was a pretty lucky individual.
- 14 A. Yeah. I'll send you some pictures and if, by chance, you
- 15 | need to call back and talk more about the pictures in front of
- 16 you, you know, sometimes when you see the picture in front of you,
- 17 | you can ask more questions.
- 18 Q. Yes, sure, get a description.
- 19 A. You know, for example, where I was sitting, parked my bike,
- 20 | you'll see Doug's bike is to my left. Then you'll see a red one
- 21 laying down; that was Lou's. And the next one in front of that,
- 22 yellow, all mangled up, that was Danny Boy's.
- 23 Q. Okay.
- 24 A. And then you'll see another one standing up a little further,
- 25 that was Big Mack's. And during the fire, he got it away out

- 1 of -- from the fire more, and he rolled it up further left, where
- 2 he was not really originally in the line. He just moved his bike
- 3 from the fire.
- 4 Q. Okay.
- 5 A. But, you know, again, I'll send you the pictures and if you
- 6 | need to ask questions about the pictures in front of you, I can
- 7 help you out.
- 8 Q. Yeah, I can text you back and if you have a pen, I can give
- 9 you my email as well.
- 10 A. All right. I'm ready.
- 11 Q. Okay. It's
- 13 A. G-O-V?
- 14 Q. Yes, G, as in government, short for gov.
- 15 A. All right, so
- 16 Q. N -- for National Transportation Safety Board, NTSB, as in
- 17 boy, yeah.
- 18 A. Yeah.
- 19 Q. Board, tor.
- 20 A. Okay. NTS, okay, NTS.gov.
- 21 Q. NTSB.gov.
- 22 A. Okay. Yeah, I got the B. Yeah, now -- NTSB.gov. Okay.
- 23 Q. Okay, sir. Well, I thank you very much for your time and
- 24 your description, and -- yeah, and if you do talk to any of the
- 25 other people that -- the guys and gals that were in the group and

- 1 | want to give a statement, because I'm not getting callbacks. But
- 2 | I understand, you guys -- it's been a pretty traumatic thing and
- 3 some people may not want to talk about it, so -- because most of
- 4 you -- I'm sure everybody's given a statement to the police
- 5 already, as well. So --
- 6 A. Oh, yeah, yeah. But, I mean, I don't -- I'd rather it be
- 7 passed on, the right information, you know, so --
- 8 Q. Sure. I understand.
- 9 A. So, and the only thing is --
- 10 Q. Okay --
- 11 A. -- the only thing different from what you're saying, is the
- 12 way I think the bikes are set up, but then again, you know, it was
- 13 so fast and chaos that I don't know -- everybody's story could be
- 14 different how who was where, you know?
- 15 Q. That's true, yeah. Yeah, there may be a couple people that
- 16 | are maybe shuffled around, but I think -- yeah, I'm not sure, but
- 17 I appreciate the information you've given us.
- 18 A. Very good.
- 19 Q. Okay. Thank you, sir. God bless.
- 20 A. All right. You're welcome. Thanks.
- 21 Q. Bye-bye.

1 INTERVIEW OF TAD DUARTE

- 2 BY MR. KAMINSKI:
- 3 Q. What I was wondering is the -- I wanted to get the type of
- 4 | bike you were riding, and if it has a windshield on there and --
- 5 | why don't you just tell me that?
- 6 A. I was driving a 2002 Yamaha Road Star.
- 7 Q. Okay.
- 8 A. And it's a full-size bike with the side bags and crash bars,
- 9 and it has a full-size windshield.
- 10 Q. Okay. And then, well, how about, were you and your wife
- 11 wearing helmets?
- 12 A. Always.
- 13 Q. Okay, what type of helmets? Do they have the face guard or
- 14 any eye protection?
- 15 A. No. They're pretty much the three-quarter or half-open
- 16 helmets. DOT helmets though.
- 17 Q. Okay.
- 18 A. And, you know, because I have cold weather and warm weather
- 19 helmets and we were wearing the warm weather helmets.
- 20 Q. Okay.
- 21 A. And --
- 22 O. Go ahead.
- 23 A. And definitely always, without a full helmet on you got to
- 24 | wear, by law, you have to wear eye protection -- well, you know,
- 25 | sunglasses or safety --
- 26 Q. Right, something --

- 1 A. -- riding glasses, yeah.
- 2 Q. Right, okay. And then how about gloves, a vest, pants,
- 3 boots?
- 4 A. I, myself, always wear riding boots.
- 5 Q. Okay.
- 6 A. I never ride in sneakers. I never ride in sandals like I see
- 7 some people doing. And I always wear jeans. I never wear a pair
- 8 of shorts when I'm riding. And I had -- we -- my wife had a
- 9 | riding jacket on. I had a riding jacket on with my leather vest
- 10 on the outside of it. And I had leather riding gloves on.
- 11 Q. Okay. And then, that's what I was going to ask, the riding
- 12 gloves. And how about your wife? Does she wear any gloves?
- 13 A. I want to say on this particular ride, no, because it wasn't
- 14 as cold, but she could have had them on. I don't -- I want to say
- 15 no. I think I remember asking her, I said, are you going to put
- 16 your gloves on? I think she says, no, she says, we're just going
- 17 down the road; I'm not going to put my gloves on. Yeah.
- 18 Q. Okay. And, you know, another thing I forgot to ask you about
- 19 is, did you get any -- what kind of injuries did you sustain?
- 20 A. None. My bike -- we didn't go down at all. Nothing. No
- 21 injuries.
- 22 Q. You didn't go down. You were able to just hit the brakes?
- 23 A. No. Out of the 14, and I know you -- out of 14 or 15 bikes,
- 24 only 4 or 5 bikes remained at standing out of all those bikes, and
- 25 mine was one of them.

- 1 Q. Okay. And do you have ABS on yours?
- 2 A. No.
- 3 Q. Okay.
- 4 A. No.
- 5 Q. But you said you did have the crash bars on there. Okay
- 6 A. Yeah.
- 7 Q. And how about Big Mack, who was behind you? What type of
- 8 bike does he have; do you know?
- 9 A. His was the big Harley. If you saw -- did you get my
- 10 pictures?
- 11 Q. Yes. Yes.
- 12 A. Okay. I hope they're helpful.
- 13 Q. Oh, yeah. Oh, yeah. I gave them to one of the
- 14 reconstruction guy.
- 15 A. Yep. Big Mack, I think there's the picture with -- where you
- 16 see the trailer, with the body under the trailer?
- 17 Q. Yes.
- 18 A. That's Big Mack, I think -- that's Big Mack standing there
- 19 looking at the body with his hands on his hips.
- 20 Q. Yeah, yeah, okay.
- 21 A. And that's his bike, I think, standing -- I know that's his
- 22 bike right next to him.
- 23 Q. Okay.
- 24 A. And then when you see Danny Boy's body in the grass on the
- 25 left and the blood --

- 1 Q. Yes.
- 2 A. -- on it, that's Doug's bike right there, the first one, and
- 3 then Danny Boy's bike in front of that -- I mean that's Big Mack's
- 4 bike, the next one up. He moved it over because the fire got
- 5 intense.
- 6 Q. Oh, okay. Okay.
- 7 A. The yellow one that's all mangled-up, that was brand spanking
- 8 new. That was Danny Boy's. And Lou's was the red one, and just
- 9 to the right of the front of the yellow bike down, that was Mighty
- 10 Mouse, Dawn's bike, that she laid down.
- 11 Q. Yeah, there's two yellow ones on the right.
- 12 A. Yep. Yeah, the other good yellow one is Hooker's, him and
- 13 Pat's. They were on that one.
- 14 Q. Okay. Okay, right. Okay. Well, I appreciate your added
- 15 | info. Yeah, we're, you know, interested in getting all the safety
- 16 | gear and what your bike had on it, so I'm glad I -- were able to
- 17 | get you, get ahold of you and get that information.
- 18 A. Yeah, like I said, you need any information, feel free to
- 19 text me or call me, and I'll help out any way I can.
- 20 Q. Awesome. I appreciate your help.
- 21 A. I don't know if everybody had a (indiscernible) --
- 22 Q. You broke up there. Yeah, you're breaking up. I guess
- 23 | you're --
- 24 A. -- if you do have to have one on.
- 25 Q. You're breaking up there for a little bit. They don't have a

- 1 helmet law in New Hampshire.
- 2 A. New Hampshire.
- 3 Q. Yes.
- 4 A. Correct. Yeah, but I -- my wife and I wear one at all times.
- 5 Q. Great.
- 6 A. It's just that we're used to it because in Massachusetts you
- 7 have to have one, so --
- 8 Q. Right.
- 9 A. But -- and I'm not sure if, I'm not sure if Woody, the
- 10 president who died, had a helmet on not because, I mean, his brain
- 11 was in the road. I don't know if that would have made a
- 12 difference. I don't know.
- 13 Q. Right. Yeah, I don't how he got hit, you know, and how much

INTERVIEW OF MICHAEL MCEACHERN

MR. MCEACHERN: -- just get on the phone, call 911, tell them we're, you know, about a quarter mile east of the hotel. I need ambulances. We need fire trucks.

I walked up to check on my friends and I saw Joanne, she was deceased, to the front right of the bumper. Fritz was deceased in front of the bumper. And my best friend, Aaron, and his girlfriend, they were in the woods, deceased.

The fire started. I was able to -- I tried putting -- I put Joanne out, and then I put Fritz out and covered them up with whatever I could. And then the truck basically caught fire from the fuel from the motorcycles. And then, you know, we just -- and I kind of did crowd control and tried to keep the spectators away from what was up on the berm and prevent pictures from being taken. And then once the truck was fully engulfed, I had to push everybody back about 100, 200 feet.

- 17 BY MR. KAMINSKI:
- 18 Q. Sure, sure.
- 19 A. And about 40 minutes later, I think the fire department
 20 showed up and they were able to put the fire out. You know, they
- 21 -- then the state --
- 22 Q. Well, it wasn't 40-minutes. It probably seemed like 40

- 3 MR. KAMINSKI: Hello, Mr. Piwowarski?
- 4 MR. PIWOWARSKI: Yes. This is him.
- 5 MR. KAMINSKI: Hi. This is Ronald Kaminski with the National
- 6 Transportation Safety Board.
- 7 MR. PIWOWARSKI: Hi there, Ronald. How are you today?
- 8 MR. KAMINSKI: Good. I appreciate you trying to get back to
- 9 me, and I'm sorry to bother you when you were out of the country.
- MR. PIWOWARSKI: No, no, of course. I mean, you know, it's
- 11 important, so --

- 12 MR. KAMINSKI: Right.
- 13 INTERVIEW OF STEPHEN PIWOWARSKI
- 14 BY MR. KAMINSKI:
- 15 Q. I just wanted to get -- I know you were a key witness there.
- 16 You were following the truck, correct, the first vehicle?
- 17 A. That's right.
- 18 Q. Okay.
- 19 A. That's right.
- 20 Q. So why don't we start, why don't you give me your first --
- 21 | spell out your first and last name.
- 22 A. Sure. It's Stephen Piwowarski, S-T-E-P-H-E-N; Piwowarski is
- 23 P as in Peter, I-W-O-W-A-R-S-K-I.
- 24 Q. Okay. And you were -- you were the driver? You were
- 25 driving?

- 1 A. That's correct.
- 2 Q. Okay. And did you have you wife in the car with you?
- 3 A. That's right.
- 4 Q. Okay. And her name?
- 5 A. Her name is Anne Baron, A-N-N-E, B-A-R-O-N.
- 6 Q. Okay. And she was in the back seat; is that correct?
- 7 A. She was in the back seat, that's right.
- 8 Q. Okay. And so why don't you just give me a description of
- 9 when you first noticed something about this driver and just tell
- 10 me what you saw?
- 11 A. Okay. Sure.
- 12 Q. And if you don't mind, I'm going to tape this so I don't have
- 13 to interrupt you and I can just follow up with questions when
- 14 you're done talking.
- 15 A. That's fine with me. Yeah.
- 16 Q. Okay, great. Go ahead, sir.
- 17 A. Okay. So we had left Gorham -- well, passed through Gorham,
- 18 | I should say, and going westbound on Route 2 outside of Gorham.
- 19 There are a couple overtaking lanes as you're going up hills.
- 20 Q. Right.
- 21 A. And, you know, I was -- I was two cars behind the truck and
- 22 | trailer. And then at one of the overtaking lanes, I had passed
- 23 the car behind, behind the truck and trailer, so then I was the
- 24 car behind the truck and trailer.
- 25 Q. Okay.

- 1 A. I'm not sure exactly how far I -- I know when the state
- 2 police interviewed me, I gave an estimate but I believe, in
- 3 subsequently like driving that stretch of road again, that it's
- 4 actually further than I thought it was. I thought it was 3 miles
- 5 or something, but I think it's a little bit more like 5 miles.
- 6 Q. That you had passed or you had gotten behind him?
- 7 A. Yeah, that I had gotten behind him. So from that overtaking,
- 8 wherever the overtaking lane is, until the scene of the accident,
- 9 I was behind him. But it was not long after the overtaking lane
- 10 where I wound up behind him, that I noticed that his driving was
- 11 | erratic, and I actually pointed out to my wife. We were, you
- 12 know, in the car. Like she was -- we have a 1-year-old, so she
- 13 was in the back seat with our 1-year-old, you know. And --
- 14 Q. Sure. And describe erratic, what do you mean by erratic?
- 15 A. So, good -- yeah, what I mean by erratic is both crossing the
- 16 white line into the shoulder and then the double yellow into the
- 17 oncoming lane.
- 18 Q. Okay. Was it because his -- was it because you think he was
- 19 just driving that way or was he having trouble controlling his
- 20 trailer? Or what --
- 21 A. Right, yes. So early on, you know, I said, whoa, I'm going
- 22 keep my distance from this fellow, like there's something not
- 23 quite right about his driving. And so I kept back a little ways.
- 24 But, at first, yeah, I thought it might have been his trailer
- 25 because it was an empty trailer.

- 1 Q. Right.
- 2 A. You know, he didn't have like a -- he didn't have a load on
- 3 | the trailer. So it's like, well, maybe it's, you know, maybe he's
- 4 having some trouble keeping the trailer in line. But in watching
- 5 | it, I think it was almost completely due to the driver, you know.
- 6 It was being guided by the truck.
- 7 Q. Okay.
- 8 A. In other words, it was not being guided by something
- 9 happening in the back and him correcting in the front. It was
- 10 happening in the front and following through in the back, yeah.
- 11 Q. Got it. Okay. So you were following, you were going
- 12 westbound.
- 13 A. That's right, going westbound. And, you know, it got to the
- 14 point where I said, you know, I may just pull over and call the
- 15 police or something. But I never did, which --
- 16 Q. How far was he crossing over the oncoming lanes; do you
- 17 | recall? Was he just a couple of feet? A foot? A couple feet?
- 18 A. Several feet. I'd say a third of a car length.
- 19 Q. Okay. Was there any near misses?
- 20 A. No, no. I mean, that was sort of the fortunate thing. There
- 21 was not a lot of eastbound traffic that I noticed.
- 22 Q. Okay.
- 23 A. So no, there weren't any near misses until the one that was
- 24 not a near miss, unfortunately.
- 25 Q. Right. And in that case, I guess he crossed over and he just

- 1 kept going; is that correct?
- 2 A. Yeah, and that was sort of the weird thing, right? You know,
- 3 | so getting to exactly where the accident happened, the way it
- 4 | works there is the road sort of -- going westbound, there's a
- 5 little bit of a crest. It's not like a steep hill or anything,
- 6 | but it just comes to a point where the road crests and you can't
- 7 really see what's down over the other side.
- 8 Q. Okay.
- 9 A. And, you know, maybe like a small grade coming up eastbound.
- 10 O. Yeah.
- 11 A. And, you know, it was just suddenly these bikes were in view
- 12 and he veered into the other lane, and just started taking out
- 13 bikes, you know. It was just really pretty, pretty bad.
- 14 Q. How fast were you going prior to, right before he crossed
- 15 | over? How fast would you say you were traveling behind him?
- 16 A. I'd say between 55 and 60 miles an hour.
- 17 Q. Okay. And you think he was probably doing the same, about
- 18 | the same?
- 19 A. Yeah, I don't -- I wouldn't say that he was going much faster
- 20 than that, no. My inclination is that he was probably going right
- 21 | around the speed limit.
- 22 Q. Okay. Well, you know, I think the speed limit is 50.
- 23 A. Is it 50? I thought it was 55 in that section. Okay.
- 24 Q. I think everybody does.
- 25 A. Yeah, yeah, yeah. I think that section everyone thinks is 55

- 1 and, I mean, I think because of the width of the road and the
- 2 | condition of the road, people, you know -- I mean, I don't drive
- 3 that stretch like that often because I don't have much reason to
- 4 go over there.
- 5 Q. Right.
- 6 A. But having lived in a similar situation, with a road in a
- 7 | similar situation in Vermont, you know, if the road appears to be
- 8 built for a speed limit, that's the one people choose, not the one
- 9 that is posted.
- 10 Q. Okay.
- 11 A. You know what I'm saying?
- 12 Q. Yeah. So when the vehicle crosses over, do you recall seeing
- 13 how many bikes did the truck take out and how many bikes hit the
- 14 trailer? Do you have any kind of recall on that?
- 15 A. You know, it was -- because the bikes, you know, were
- 16 traveling as a group, and they had, I think -- they had really
- 17 | just -- well, what learned afterward, they had just pulled out.
- 18 O. Correct.
- 19 A. So they were grouped pretty closely together. So it was, you
- 20 know, almost hard to say exactly how many, you know, as it
- 21 | happened, because it happens very quick. The bikes were
- 22 definitely all on their side of the road. There's no doubt about
- 23 that. The one thing I would say is that, you know, there may have
- 24 | been a couple bikes early on -- well, I know there were a couple
- 25 bikes early on, that did -- you know, that passed unscathed

- 1 because they were, you know, they were towards the right side of
- 2 | their lane.
- 3 Q. The outside lane, right.
- 4 A. Yeah, like the south side of the road.
- 5 Q. Sure.
- 6 A. So, you know, as he entered the lane, those bikes got by
- 7 unscathed. However, there were also plenty of bikes toward the
- 8 inside of the lane, and I'm assuming those were the first ones he
- 9 caught. But kind of getting back to the point of what I was
- 10 saying earlier is, you know, the really surprising thing was the
- 11 | truck entered the lane and hit a bike and there was like no
- 12 corrective action whatsoever.
- 13 Q. By the trucker? By the truck driver?
- 14 A. Right, by the truck driver. It was just the truck continued
- 15 | like pretty much on a tangential path across the lane. And I
- 16 think that's -- you know, had the trucker corrected and gone back
- 17 | into, you know, gone back into his lane, many people -- you know,
- 18 there would still obviously have been some, you know, at least
- 19 injury, if not loss of life, but not to the extent that there was.
- 20 Q. Right. Yeah. Okay. And so then following the crash, was
- 21 | there -- did you see fire right away? Was there explosions?
- 22 Describe what you saw when they hit and leading up to the final
- 23 rest.
- 24 A. Yeah, sure. So directly after, you know, after the -- after
- everything came to a stop, there was a small fire in the truck.

- 1 And my wife and I have been talking about this, you know, it's
- 2 really unclear what the cause of the fire was. All we know is
- 3 that the fire was not fully involved, obviously, when the vehicles
- 4 came to a rest. So one thing we've been trying to figure out,
- 5 | like, is what -- you know, like what was the cause of the fire?
- 6 What was the cause of ignition? And the only thing I can think of
- 7 | is that one of the bikes -- so there were several bikes that got
- 8 pinned under the trailer.
- 9 O. Truck and trailer? Yes. Yeah.
- 10 A. So that -- you know, like a gas tank got ruptured or
- 11 | something like that.
- 12 Q. Well, I think you're right about that. That's a --
- 13 A. And then there were sparks or something, you know --
- 14 Q. Sure.
- 15 A. -- as the bikes got dragged, so --
- One of the first things that we said to people was, you know,
- 17 | we need a fire extinguisher, because it was small at that point.
- 18 But no one came with one so we weren't able to put the fire out
- 19 early on, unfortunately.
- 20 Q. So I take it, you pulled over to the side, your wife stayed
- 21 | in the car and you got you got out and then tried to help or do
- 22 | what you could?
- 23 A. Actually we both got out. We left Johnny, our son, in the
- 24 car with, you know, the doors open, the windows open. My wife is
- 25 a nurse -

- 1 Q. Okay.
- 2 A. -- so she immediately started doing -- like we both started
- 3 triaging victims and seeing, you know, who could be helped and
- 4 | what could, you know, what could be done to assist people. You
- 5 know, several of -- you know, there were of course several bikers
- 6 who were unscathed that were fine, and they started doing the
- 7 same. We were all kind of working together. My wife wound up
- 8 doing CPR for about 25 minutes on one patient. I kind of was
- 9 coordinating with the cars, the other westbound car or -- yeah,
- 10 the other westbound cars, trying to see if there was any water,
- 11 blankets, you know, towels, that sort of thing.
- 12 Q. Right.
- 13 A. You know, water for people who were either in shock or were
- 14 injured, and then blankets to sort of cover things up. And also,
- of course, see if there were any medical personnel who were
- 16 driving behind us.
- 17 Q. Right. Sure.
- 18 A. If they could help, yeah. So --
- 19 Q. Okay. So --
- 20 A. That was -- yeah.
- 21 Q. So you're thinking you got behind him, you think it was
- 22 | farther than about -- you said you've driven it again since and
- 23 you were following him maybe --
- 24 A. Well -- right. So --
- 25 Q. -- for 3 miles prior to it, where he was driving erratically?

- 1 A. So when I drove back into town from, I guess, from the
- 2 accident, because, right, the road closed. So from Randolph,
- 3 where the accident site was, back into Gorham, I realized that,
- 4 oh, this is further than I thought it was that I was behind him.
- 5 | So, yeah, I'm just not quite sure what that distance is.
- 6 Q. Okay. So it's more than 3 miles though?
- 7 A. Yeah, I'd say it's more than 3 miles.
- 8 Q. And, maybe 5 at most?
- 9 A. Yeah, I'd say about 5 miles.
- 10 Q. Okay. Yeah, and that's when you got behind him and that's
- 11 | when you noticed he was going back and forth, and that you don't
- 12 believe it was from the trailer, you think it was just from his
- 13 steering going from --
- 14 A. That's right.
- 15 Q. -- outside lane to the double white line and out, going back
- 16 and forth like that?
- 17 A. Yeah. I mean, right -- you know, usually if there was like
- 18 any wind or anything like that, you would at least be aware of it.
- 19 O. Sure.
- 20 A. And I know that that stretch of the road, because of the
- 21 | mountain range there, can be windy, but I didn't detect any
- 22 | noticeable wind on that day. I know it's different when you're
- 23 driving a trailer, but -- no, I think that this was -- you know,
- 24 what we did in the -- I work with railroad, and I would say that
- 25 this was a case of operator error. This was not, you know,

- 1 equipment malfunction or anything like that.
- 2 Q. Right.
- 3 A. So, yeah.
- 4 Q. Okay. Well, you've given me a great description. I
- 5 appreciate it. And, you know, I probably I could get a statement
- 6 | from you wife, but she's probably going to tell me pretty much
- 7 | what you have told me. Correct?
- 8 A. Yeah, in fact, I would say not nearly as much. Only from the
- 9 -- for the simple fact that she was in the back seat.
- 10 Q. Right.
- 11 A. And she was, you know, focused on our boy, so --
- 12 Q. Sure.
- 13 A. She was like, you know, looking at what was going on with him
- 14 and stuff, and not necessarily as aware of what was going on, on
- 15 the road as I was.
- 16 Q. Right.
- 17 A. Which I'm thankful for, that I was as aware of what was
- 18 happening, you know.
- 19 Q. Absolutely.
- 20 A. I think people that usually forget that. I've said to nearly
- 21 every person since the accident, you know, people have asked me
- 22 about it, they say, you know, do you think it was like a cell
- 23 phone or what do you -- you know, what do you think the cause was?
- 24 I'm like, look, I don't know, and I'm sure it will eventually come
- 25 to pass what the cause of the accident was, so it's all

- 1 speculation. But I will tell you, if I had been on my cell phone
- 2 | when the accident happened, I might not have been as --
- 3 Q. Attentive?
- 4 A. -- you know, because -- attentive, right. It kills your
- 5 reaction time. So, you know, regardless of somebody having a
- 6 Bluetooth or, you know, whatever in their car, if you're engaged
- 7 | in a conversation with somebody on the phone, you're not going to
- 8 be as aware as if you're just focused on your driving. So --
- 9 Q. Exactly, yeah. That's -- we're trying to get the word out,
- 10 you know. We've seen plenty of crashes involved with people using
- 11 their cell phones and things like that. So --
- 12 A. Yeah, I'm sure that, you know, like as far as rear end
- 13 accidents go, there are probably more rear end accidents now
- 14 because of it.
- 15 Q. Right. Yeah, yeah.
- 16 A. So --
- 17 Q. Okay. Well, sir, I thank you very much for taking the time
- 18 to give me a call back and give me your statement.
- 19 A. You're very welcome.
- 20 | Q. Like I said, a lot of good detail. And I thank you for
- 21 stopping and try to help as much as you could. I'm sure the
- 22 | motorcycle group was as well, you and your wife stopping to help.
- 23 A. Yeah. You know, it was really something to see, you know,
- 24 | for the most part, people just jumped out of their cars, you know,
- 25 and, not just us, literally people from both directions just

1 jumped out of their cars and got right to helping. 2 Right. Q. 3 Which I think, you know, for the few people who were able to 4 be saved, probably made a big difference for them. So --5 Sure. Absolutely. Okay, sir. Well I thank you again, and 6 safe travels. 7 Yeah, thank you. Thank you so much. And if you need 8 anything else, just give me a call. 9 Okay, sir. - MR. PARKER: Not many people refer to me as that, so you must
- 3 be the guy from the highway safety board?
- 4 MR. KAMINSKI: Yes, Ronald Kaminski with the National
- 5 Transportation Safety Board.
- 6 MR. PARKER: Okay.

- 7 MR. KAMINSKI: Do you have a couple minutes?
- 8 MR. PARKER: I do. I am off the clock and just chilling.
- 9 MR. KAMINSKI: Okay. Well, if you don't mind, I'm going to
- 10 record this so I don't have to interrupt you and you can just
- 11 | talk, and then I'll have some follow-up questions when we're done.
- 12 INTERVIEW OF JEFFREY PARKER
- 13 BY MR. KAMINSKI:
- 14 Q. Start with your first name is Jeff, Jeffrey?
- 15 A. Jeffrey, yeah.
- 16 Q. Okay. And Parker, P-A-R-K-E-R?
- 17 A. Correct. And my first name is spelled with a J not a G.
- 18 Q. Okay. Got it. And so I quess why don't you -- just talking
- 19 to Chief Horne, he said that he got a call directly from you.
- 20 A. Yep.
- 21 Q. And why don't you start from right before you called him,
- 22 | where were you and -- and your position, I mean, you're with the
- 23 fire department as well as a volunteer, correct?
- 24 A. I am not.
- 25 Q. Oh.

- 1 A. I am kind of operating in a huge gray area.
- 2 Q. Okay.
- 3 A. Did you want me to start with what I -- with my affiliation
- 4 | with fire? Is that what you want?
- 5 Q. Well, I guess I was just wondering, that's what I was --
- 6 that's what the chief told me. I guess I was -- so yeah, why
- 7 don't you tell me what your affiliation is?
- 8 A. Okay. My affiliation with fire is, I am one of the engine
- 9 bosses with the White Mountain National Forest. I'm a wildland
- 10 firefighter.
- 11 Q. Okay.
- 12 A. And I am, on top of that, I am third generation fire --
- 13 forest fire warden for the Town of Randolph.
- 14 Q. Okay.
- 15 A. I took that over from my mom, of all things, like 8 years
- 16 ago. And so that's my affiliation with the fire department, is
- 17 through the forest fire. So --
- 18 Q. Okay. I do recall him saying that, yes, you were with the
- 19 forestry service. Yes.
- 20 A. Yeah, so that's my affiliation with fire.
- 21 Q. Okay.
- 22 A. As far as that afternoon goes, do you want me to just start
- 23 off from when I got to the scene?
- 24 Q. Yeah. Did you witness anything?
- 25 A. I did not witness the actual crash. I was the second person

- 1 on scene. The first person was not an emergency responder at all.
- 2 It was just a guy.
- 3 Q. Right.
- 4 A. He was calling 911, and I pulled up behind his car. I saw
- 5 the smoke. I saw him on the phone. I knew immediately something
- 6 bad was happening because that's a very bad corner. So I left my
- 7 family in the car. I ran up to him, and all I said to him was, I
- 8 said, 911? And he nodded. And so I proceeded my way into the
- 9 scene to see what was going on and if I could do anything to help
- 10 anybody.
- Got into the scene, just saw the wreck, saw the truck
- 12 | burning, saw the pile of motorcycles just down everywhere. And
- 13 immediately then, I was like, knowing the bad cell service of the
- 14 area, I ran over to the corner of the garage that was right by the
- 15 accident scene, the old garage that's there, knowing that there's
- 16 | a little bit of cell service there, and called Dana directly
- 17 | because I was -- I figured that just hearing the conversation that
- 18 that guy was having with 911, I figured that they had not
- 19 dispatched anybody yet. So I called Dana directly just to tell
- 20 him what was going on and where it was, to give him an actual
- 21 address, because, you know, with emergency response, a lot of time
- 22 you get like it's between this and this kind of thing.
- 23 Q. Yeah, he mentioned you were a big help giving an exact
- 24 location. Yes.
- 25 A. Yeah. Because, you know, the guy that lived there was -- is

- 1 a loose family member of both of ours.
- 2 Q. Right. Yeah, he mentioned -- yeah, right. Yeah.
- 3 A. So I was like, we're -- I'm at Allman's (ph.) house and this
- 4 | is what's going on, you know, a truck fully engulfed in flames;
- 5 I've counted four, at least four dead bodies at that point. And
- 6 then got off the phone with him, and then called my town constable
- 7 and just told him where I was and what was going on, and then hung
- 8 up the phone with him, and then I ran back over to the scene to
- 9 try to find somebody that I could help.
- 10 Q. Okay.
- 11 A. And it was -- I mean, not that any part of this was a good
- 12 | situation --
- 13 O. No.
- 14 A. I was super bummed-out because I had just rolled through that
- 15 | area a hour and a half before that with my wildland fire engine,
- 16 with the trauma kit, with good radio communication, with all the
- 17 | stuff that I would normally need, dropped it at the ranger
- 18 station, and then picked up my family and went to go out to
- 19 supper, and I had absolutely nothing but a cell phone.
- 20 O. Sure.
- 21 A. So, yeah, at that point I just -- I found one person who was
- 22 down on the ground yelling all kinds of words that I couldn't
- 23 understand. And I tried to calm her down as best I could, you
- 24 know, so she wouldn't go completely off her rocker.
- 25 Q. Right.

A. And not that anybody couldn't do that in that situation, but at that point, that's when I realized what was going on. You know, I realized that this group of motorcyclists had been run over at that point. Like I didn't know what really had happened at that point. I just knew that there was dead bodies, I knew there was something going on, but then I realized -- I realized the gravity of the situation at that point, that there was

multiple -- more dead bodies than what I had initially counted.

- You know, the truck at that point was almost fully engulfed in flames. I mean, it was -- like the cab was burning and it was starting to burn the bed. And then I asked somebody, I asked somebody who was there, one of the motorcyclists, I was like, where's the driver of the truck? And he said, he's over by the garage. And I said, is he conscious? And he said, yes. So I ran over and saw him, and at that point he was going through all kinds of shit, you know, shaking, you know, obviously crying. I think all kinds of his own things going on.

- A. And so once I realized that, you know, he wasn't suffering
 any physical trauma, I then left and went back to try to help more
 with the people that were suffering physical trauma.
- 22 Q. Okay.
- A. And, you know, like I said, it was -- it's hard for me to recall all of it, because it was all happening so fast. It was so --

- 1 Q. Oh, I understand. I can understand that. Sure.
- 2 A. It was so incredibly fast paced that, being a wildland
- 3 firefighter, I am not used to that kind of a scene. Like I'm used
- 4 to more like, the woods are on fire.
- 5 Q. Sure.
- 6 A. Let's get at it.
- 7 Q. Yeah. You're not dealing with people, or bodies --
- 8 A. Yeah.
- 9 Q. -- I should say.
- 10 A. Yeah. I mean, in some cases I have, and I do, but not to
- 11 that degree. You know, like, not that many, not that much fire,
- 12 | not that much carnage, not -- you know. One of the things that
- 13 was really, I was having a hard time with, was there was a
- 14 motorcycle there that still had the stereo blaring on it, and that
- 15 was a super distraction to me because I just couldn't get that out
- 16 of my head, you know what I mean, like it was just like, wow. And
- 17 so somebody shut that off, thankfully, and -- you know, so then I
- 18 did what I do with wildland firefighting because you always divert
- 19 to your training, and I went -- well, like I said before, I
- 20 counted the number of dead bodies, I got a rough description of
- 21 what was going on, called the person that I thought was going to
- 22 be the incident commander, told him what was going on, and then
- 23 inserted myself in the situation and try to help as best I could,
- 24 you know, and -- so then I started looking at people that were
- down on the ground, like how can I help somebody, you know.

- 1 0. Sure.
- 2 A. And at one point I looked to my left and there was a guy that
- 3 | had his head broken in half and there was a brain sitting beside
- 4 me on the ground. And then I looked and there was a dismembered
- 5 leg over here, but the rest of the body looked like the guy might
- 6 still be alive. And then I went over and it didn't -- he wasn't
- 7 breathing. And, you know, so I just was just basically going down
- 8 | the line trying to find somebody that I could do something for.
- 9 Q. Right.
- 10 A. There was not many patients there. There was a lot of bodies
- 11 there. And, you know, the people that were moving, were moving,
- 12 | you know what I mean? They're up and about and they were moving,
- 13 but the ones that were down, generally speaking, weren't going to
- 14 make it.
- 15 Q. Were down, yeah. Okay.
- 16 A. Yeah.
- 17 Q. Yeah.
- 18 A. And so then, that to me, it calmed the situation down in my
- 19 head because I knew there wasn't anything I could do for those
- 20 people, you know. And so then I started to focus on trying to
- 21 make sure that people -- at that point I started to focus on
- 22 trying to make sure that people stayed out of the scene, which was
- 23 a huge challenge because there was no law enforcement there at
- 24 that point and people were just filtering in.
- 25 Q. Trying to help, thinking they can help or trying to help.

- 1 Sure.
- 2 A. Trying to help or taking pictures or --
- 3 Q. Oh, my gosh.
- 4 A. You know, one guy was walking around with a baby that was
- 5 probably a year and a half old, maybe not even that old. Then
- 6 later on in the accident, there was a family that just walked
- 7 through --
- 8 Q. Oh, my gosh.
- 9 A. -- because they wanted to. And it was a mom, dad and a kid.
- 10 It was a mom, dad and an 11-year old kid. And they just walked
- 11 through.
- 12 Q. Oh.
- 13 A. The kid was hiding his face in his father's back the whole
- 14 way. I mean, he did not want to see this.
- 15 Q. Sure.
- 16 A. But his parents, for whatever fucking foolish reason, decided
- 17 | they wanted to walk through this accident. I don't want to see
- 18 | what I saw.
- 19 Q. Right.
- 20 A. But I did see it. I can't imagine putting my child through
- 21 that.
- 22 Q. No, I can't either.
- 23 A. But, yeah, it's just a really bad section of road. You know,
- 24 that little piece right there is just really shitty. And when
- 25 Allman was still alive, the man that owned the homestead there, he

- 1 | called me years ago and was like, you ought to come over and learn
- 2 | stuff from me; I'm getting old. And I'm like, okay. And I went
- 3 over and I pulled into his driveway. He's like first thing you're
- 4 going to learn is never pull in my driveway ever again. He's like
- 5 always pull into my mother's old driveway over here. Do not use
- 6 this driveway. This driveway isn't safe. Somebody's going to get
- 7 killed here.
- 8 Q. Oh, because there's kind of a blind curve there or something?
- 9 A. Well, I mean, think about it, you know, from like the
- 10 | construction of the highway, to the east of there you've got a
- 11 straight flat road that people can go fast on it and to the west
- of there you've got a straight flat road that people can go fast
- 13 on it, but you have that one section right there in the middle
- 14 that is kind of an S-turn with a hill in the middle of it. And
- 15 people come into it going fast because that's what they're use to,
- 16 and they hit that S-turn, then they hit that hill, and given the
- 17 | time of day this whole thing went down, the sun is blinding when
- 18 you're headed west.
- 19 Q. Okay.
- 20 A. Because the setting sun follows the path of Route 2 this time
- 21 of year, and so when you come around that corner and you go over
- 22 | that little rise, you hit the sun, wham, right in your face.
- 23 Q. And that would have been for the truck driver or that would
- 24 have been for the motorcyclists?
- 25 A. The truck. For the truck.

Q. Okay.

1

- 2 A. The motorcyclists were headed east. Then they wouldn't have
- 3 experienced that. That would have been the truck. And the only
- 4 reason I bring that up is because the very first thing I thought
- 5 | when I saw that truck driver was like, that kid's 21-years old or
- 6 something, he was texting while driving. That was my first
- 7 prejudiced -- that was the first thing that came into my mind.
- 8 Q. Yeah. Yeah.
- 9 A. And then I said to myself, self, remember when you were
- 10 | commuting from Lancaster to Randolph? I mean Lancaster to Guam
- 11 | all the time to work at the ranger station? On the motorcycle,
- 12 commuting that road every day? Late spring/early summer and then
- 13 late summer/early fall, I would change my work schedule by 1 hour,
- 14 and I would go into work an hour earlier and take off an hour
- 15 | earlier so I wouldn't be in that rising sun in the morning --
- 16 Q. Oh, okay.
- 17 A. -- and then the setting sun in the evening, because that
- 18 | corner and that whole section of Route 2, it's right in the path
- 19 of the sun and it's really hard to see.
- 20 So I can see how this accident could happen, you know, just
- 21 looking at it from a completely objective point of view and not
- 22 thinking above all the death and the carnage and everything. But
- 23 just seeing that truck coming up over that rise, on an unfamiliar
- 24 road, you know, not taking the corner like he should have and
- 25 causing this huge catastrophe. So --

- 1 Q. Yeah, I know one of our guys are -- went out and took a look
- 2 | at that, and I'm not sure he went up to that hill, but I have to
- 3 mention it to him. I know he was at the scene checking out the
- 4 | sun's position just at that time, and I think he went there on
- 5 | Sunday or something, but --
- 6 A. Yeah.
- 7 Q. But I'll have to mention to him that maybe go up to that hill
- 8 and might be sun --
- 9 A. Yeah, it's just like pretty much right, when you're at the
- 10 | scene -- have you been to the scene?
- 11 Q. No, I have not, believe it or not. I came in from Portland
- 12 and I'm here at Littleton, and --
- 13 A. I'm assuming Portland, Maine, not Portland, Oregon?
- 14 Q. Yeah.
- 15 A. Okay.
- 16 Q. Yeah. Well, I drove in from Portland, Maine, yes.
- 17 A. Yeah. So that spot on Route 2 was the Farrar (ph.) Farm.
- 18 And when they initially moved Route 2 in the 1960s they tore down
- 19 the barn of the farm and they built the gray building that's still
- 20 there as the replacement for that barn, as -- you know, through
- 21 | the eminent domain process.
- 22 Q. Okay.
- 23 A. And so pretty much the driveway, like when you're coming from
- 24 | the east to the west and you're on Route 2, and you go -- when
- 25 | you're pretty much at the driveway of the big garage -- it's a big

- 1 gray building with, I think, four bays under it, four-bay
- 2 garage --
- 3 Q. Okay.
- 4 A. -- the driveway to that building is basically right at the
- 5 top of that rise. And it's not much of a rise, but it's enough to
- 6 | where, like, you're coming towards it, you're kind of shaded from
- 7 | the sun, it's no big deal. You get to the top of it, wham; it
- 8 hit's right there in your face.
- 9 Q. And what's the speed limit there?
- 10 A. Fifty-five.
- 11 Q. Okay.
- 12 A. Nobody -- I try to obey it as much as possible. Nobody obeys
- 13 it. It's like a raceway. People are driving way faster than that
- 14 all the time. It's a pretty busy road in general. It's the only
- 15 | east/west corridor in that part of the state.
- 16 Q. Okay. Yeah, I think from Portland, I think I took 302 for
- 17 | the majority of the ride here.
- 18 A. Yes, you would. Yeah, that is -- 302 or -- either 302 or 26
- 19 out of Portland is the two ways to get -- if you said you're in
- 20 Littleton?
- 21 O. Yes.
- 22 A. 302 is like -- there's one road. I mean, you take 302 the
- 23 whole way.
- 24 O. Yeah.
- 25 A. And yeah, so, yeah, but like in that part of Coos County,

- 1 | that's the only east/west, that's the only major east/west
- 2 | corridor that goes through. So it sees a lot of traffic. A lot
- 3 of commuters. A lot of Buddhas (ph.) going really fast.
- 4 Q. Yeah, I want to make a point of driving over to the scene
- 5 | tomorrow. I heard it's only about an hour away from me, so I
- 6 might go over there --
- 7 A. Yeah, it's not even that far. It's probably about 40 minutes
- 8 from where you're at.
- 9 Q. Okay.
- 10 A. Because my wife and I commute from Randolph to Littleton all
- 11 | the time because Randolph is a town full of nothing, and Littleton
- 12 has a grocery store, you know, so --
- 13 Q. Oh. What, the Walmart?
- 14 A. No. We go to the co-op grocery store.
- 15 Q. Oh, okay.
- 16 A. But yeah, so we're over there a lot. But yeah, it's about a
- 17 | 40-minute ride --
- 18 Q. Okay.
- 19 A. -- from wherever you are in Littleton. And, yeah, so, I
- 20 mean, as far as the rest of the scene goes, I was trying to push
- 21 people out of it, but they would not -- I had no semblance of
- 22 | authority. You know what I mean? Like I was dressed in my street
- 23 clothes. I wasn't wearing my U.S. Forest Service uniform. I
- 24 didn't have my truck. I didn't even have a radio. So like nobody
- 25 | would pay attention to me.

- 1 Q. Sure. And I can, I can see people just, you know, who are
- 2 you? Yeah.
- 3 A. Well, exactly, I can see why they wouldn't do it, but it
- 4 | frustrated me to no end. And even if I had a radio --
- 5 Q. Yeah, pictures and video, I mean, that's just disgusting. I
- 6 just --
- 7 A. Yeah. Well, and I can't understand why they'd ever want to
- 8 expose a child to that, you know?
- 9 Q. Right.
- 10 A. Like even that little baby, you know. It's like my
- 11 daughter's 5. She was in the car waiting for me. But she was
- 12 just down -- like where I parked, was just down the rise from the
- 13 top of the hill. She never saw any of it. The only thing that
- 14 | she saw was smoke and some ambulances going by. She never saw any
- 15 of the accident. Willingly exposing your child to that is
- 16 ridiculous, but that's what he did.
- 17 Q. Right.
- 18 A. And -- but yeah, and as far as --
- 19 Q. Do you have a quesstimate how many motorcycles would you -- I
- 20 | mean, there was, I think there was six of them that were really
- 21 | hit bad, and there was a couple of them, I quess, that laid down
- 22 | after or right -- you know, trying to avoid it.
- 23 A. Yeah. I'd have to say, as far -- like when I first got up to
- 24 | the scene, the bike that had the radio blaring on it was a blue
- one and it was off to the left, so south side of Route 2.

- 1 Q. Okay.
- 2 A. It was laid down on it's side. It wasn't run over like the
- 3 other ones were. I'm not sure who was operating that. I don't
- 4 know if that person was deceased or not. And then there was
- 5 probably two or three others that were just laid down in Route, in
- 6 the road. But when I got there, some of the bikers were trying to
- 7 move the bikes. I'm really not sure why they were doing that.
- 8 Maybe they were trying to clear a path for emergency response.
- 9 Q. Oh, sure. Okay. Yeah.
- 10 A. But yeah, there was a couple of bikers that were trying to
- 11 move motorcycles. Which to me was, like, don't do that because
- 12 this is the scene of an accident, but I can understand why you
- 13 are, because you're trying to get emergency response stuff in
- 14 here.
- 15 Q. Right. Right.
- 16 A. But, yeah, so there was -- God, that's taxing my memory a
- 17 | little bit, but I have -- let's see, there was that blue one,
- 18 there was a black one, there was the yellow one that were not
- 19 completely crushed. You know what I mean?
- 20 O. Yeah.
- 21 A. They still looked like a motorcycle. And then, God, this --
- 22 I know for certain there were three but I'm quessing there may
- 23 have been as high as five that were laid down.
- 24 Q. Okay. Yeah, we'll get that information from the police.
- 25 They'll have that information.

- 1 A. Yeah, sure. Oh, yeah, they'll definitely have that. I'm
- 2 | sure somebody took a detailed accident report.
- 3 Q. Yeah. Yeah, they're still working on it. They're still
- 4 trying to put together everything. I mean, I saw nine motorcycles
- 5 today.
- 6 A. Yeah.
- 7 \mathbb{Q} . They were out at the -- where they towed them away. So --
- 8 A. Yeah.
- 9 Q. But I'm sure there might have been a couple that were just
- 10 laid down, but they -- you know, there's no injuries, no nothing,
- 11 and the people pick them up and went, you know, or you know --
- 12 A. Yeah. Or just moved them off to the side.
- 13 Q. Right.
- 14 A. There was one woman I was talking to at the scene of the
- 15 | accident when I was trying to calm the first one down, when she
- 16 | walked up to me, she said, you know, right before, you know, when
- 17 | I -- she's like, said when I braced for impact, you know, when I
- 18 saw the truck coming. And I looked at her and I was like, you
- 19 were in this accident? You know, she was not scratched. She was
- 20 so lucky, you know.
- 21 Q. Oh, absolutely.
- 22 A. She had a cut on her ankle that was a half of an inch long.
- 23 That was it. And I was like, oh, my God, you know --
- 24 O. Yeah.
- 25 A. -- that is amazing that somebody would come out of that like

- 1 that. But, yeah, that was totally not -- that she was able to
- 2 make it through that with only that little scratch. That was
- 3 just, that blew my mind, you know.
- 4 Q. Yeah, somebody's looking over her shoulder, that's for sure.
- 5 A. All totally. I mean, there was definitely something going on
- 6 there. But --
- 7 Q. Yeah.
- 8 A. You know -- but yeah, I mean I don't know how much more I can
- 9 give you that's going to be really beneficial for you.
- 10 Q. Yeah. No, you've done a good job, you know, describing what
- 11 you did and what you saw. That's all I'm asking for.
- 12 A. Yeah.
- 13 Q. And but I appreciate you stopping to help, and I can't
- 14 imagine -- you have a tough job as well doing -- fighting those
- 15 | fires, I can imagine. That's not an easy job as well.
- 16 A. It's not an easy job, but, you know, in the last -- I've been
- doing it for 20 years, and in the last, I'd say 5 to 7 years,
- 18 they've stopped calling us wildland firefighting crews and started
- 19 calling us all incident response.
- 20 Q. Oh, okay.
- 21 A. And so, they still call us wildland firefighters, but we are,
- 22 | in a nutshell, we're all incident response. And so like, if I had
- 23 been going through with -- well, in the fire engine that I'm
- 24 sitting in right now, if I had been going through in that, I am
- 25 expected to stop and do something.

- 1 Q. Because you do have some medical, I guess, background, I
- 2 guess, or a little training?
- 3 A. I am what they call -- there's different levels of wilderness
- 4 | first aid. I am a wilderness first aid person. I'm not a
- 5 | wilderness first responder.
- 6 Q. Okay.
- 7 A. But where -- everything I do is in the backcountry for the
- 8 most part. I take all these trainings for trauma, you know. So
- 9 | if we're using chainsaws and somebody drops a tree on themselves,
- 10 what are you going to do, you know?
- 11 Q. Oh, okay. Sure.
- 12 A. You know, run drills all the time. I mean, and honestly, I
- 13 have a full-on trauma kit behind me in the seat of the truck that
- was put together by an EMT that worked for me a few years ago, and
- 15 she did a banger job on that thing, and she made a really nice
- 16 | trauma kit. And it's all labeled of what's where, like on the
- 17 | zipper fobs when you pull them.
- 18 Q. Yeah.
- 19 A. And so it's really handy, and I'm kind of heart broke that I
- 20 did not have that to offer to somebody, you know.
- 21 O. Yeah.
- 22 A. But, you know, on the other hand, the only thing that I --
- 23 Q. You were on family time, you know.
- 24 A. Yeah, totally. But like I used to carry a trauma kit in my
- 25 personal car all the time because I was like, what am I going to

- 1 | run across? But the last few years, you know, having a little kid
- 2 around the house and stuff, I've had a lot less time to be able to
- 3 do that kind of stuff.
- 4 Q. Sure, sure.
- 5 A. So I, you know, I don't -- I'm not always, you know, I'm not
- 6 always as keyed-up as I used to be as far as trying to be ready
- 7 for any situation that could possibly pop up.
- 8 Q. Sure. I do understand that when you have children, I think
- 9 you kind of, you know, you kind of set your priorities a little
- 10 bit different.
- 11 A. Yeah, you come at things from a different angle, and that's
- 12 | what I've been doing.
- 13 Q. Right.
- 14 A. But I ended up putting together another trauma kit and
- 15 | putting it in my personal car, and --
- 16 Q. Oh, you did. Okay.
- 17 A. -- up in there. And the other thing that was a nightmare at
- 18 that scene was communication. The radio communication was
- 19 horrible.
- 20 Q. Yeah. Well, Chief Horne said that he ended up going in one
- 21 of the engines and -- that was right there, and working out of
- 22 that just to make sure he had good communications.
- 23 A. Yeah. And for me, that -- I find that really interesting
- 24 | because, for me, I work for the U.S. Forest Service and we have a
- 25 repeater right on top of Mount Washington that's almost line of

- 1 | sight from where we were, and I never have an issue getting out
- 2 | with the radio there at all, you know, because I use that repeater
- 3 and I'm able to hit to go wherever I need.
- 4 Q. Could it be just to the cell service provider, like T-Mobile,
- 5 | you know, AT&T; is it that? Or is it just --
- 6 A. It's just a bad spot for cell service.
- 7 Q. Okay.
- 8 A. You know, like --
- 9 Q. Right.
- 10 A. -- you lose all your bars going through there. And for
- 11 radio, like I can never go from radio to radio there. I have to
- 12 go through the repeater on top of Mount Washington. But my
- 13 supervisor told me when I talked to him yesterday, that he has
- 14 them working on what's an agreement with the state, for the state
- 15 and municipalities to use that repeater on top of Mount Washington
- 16 so they can have it at their disposal in those situations.
- 17 Q. Sure.
- 18 A. I don't know if that agreement's ever going to go anywhere,
- 19 but that would be awful handy for them. You know, it would have
- 20 made things so much better there.
- 21 Q. Okay. Well, if I need any more information on that, I may
- 22 get back to you and you can maybe direct me with your supervisor
- 23 you said you talked to and --
- 24 A. Yeah.
- 25 Q. So --

- 1 A. He's on vacation right now but he's going to call on me to
- 2 | see how things are going because somehow he found out that I was
- 3 there.
- 4 Q. Right.
- 5 A. I don't know how he found out. because I didn't tell him.
- 6 Q. Well, you should be commended for stopping and doing what you
- 7 | could. I understand it had to be a grizzly scene and --
- 8 A. Yeah, it was probably the most horrific thing I've ever seen
- 9 in my life and I hope to never see anything like that ever again.
- 10 O. Yeah.
- 11 A. But it wouldn't stop me from trying to help again, you know,
- 12 | but it was still pretty fucking brutal.
- 13 Q. Yeah. I can imagine.
- 14 A. My heart goes out to all those people. But I don't know what
- 15 | the deal with the driver of the truck was. I've been -- I have
- 16 made a conscious effort to not look at Facebook, not look
- 17 | newspapers, you know. I kind of wonder what his deal was, you
- 18 know, like I --
- 19 Q. Well, if you want to know, in the newspapers, he was charged,
- 20 he was -- for negligent homicide and he --
- 21 A. Yeah.
- 22 Q. -- pleaded not quilty. And they did find some substances in
- 23 his blood.
- 24 A. In his blood?
- 25 Q. Yeah.

- 1 A. Okay. So was he under the influence or was it just residual
- 2 from some other times?
- 3 Q. No, it was some pretty hard-core stuff.
- 4 A. Yeah. So he was under the influence then? Or he
- 5 (indiscernible) --
- 6 Q. I don't know the cutoff is. I know that they found it in his
- 7 | system. I couldn't tell you what the cutoff is that showed that
- 8 he's under the influence or he has it in his system but he's not
- 9 under the influence, I don't -- I'm not sure how that works. But
- 10 some of the hard-core stuff, it only stays in your system for 24,
- 11 | 48-hours, so --
- 12 A. Yeah. Okay.
- 13 Q. So if it's still in his system, I don't know. I don't know
- 14 what effect that would have had on him, but --
- 15 A. Yeah.
- 16 Q. Mr. Parker, I'll let you go.
- 17 A. Thank you. Have a good evening.
- 18 Q. And I appreciate you taking the time and giving me a
- 19 statement of what all you saw and what you did out there, sir.
- 20 A. Okay. I hope it helps you. I can't guarantee that it will,
- 21 but have a good evening
- 22 Q. Okay. And you be safe out there, sir.
- 23 A. Yep. Bye-bye.
- MR. KAMINSKI: Bye-bye.
- 25 (Whereupon, the interview was concluded.)
